





ABOUT THE HONOREES Hon. Ernst H. Rosenberger '58 Of Counsel, Stroock & Stroock & Lavan LLP



Justice Rosenberger's long and distinguished career in the law is marked by an avowed concern for the rights of the disenfranchised. After graduation from law school in 1958, he gained extensive trial experience in state and federal courts litigating in criminal and civil cases. His strong commitment to justice led him to volunteer his services in the defense of the "Freedom Riders" arrested in 1961 in Jackson, Mississippi, and he worked on accommodation and voting rights cases throughout the South in the 1960s.


He began his long and distinguished career on the bench in 1972 as a judge of the Criminal Court in New York City, serving a concurrent term as Acting Justice of the State Supreme Court. In 1978, a year after being named a justice of the State Supreme Court, he was called to serve as Presiding Justice of the Extraordinary Special and Trial Term for the investigation of corruption in the criminal justice system. At the end of that term, in 1985, he was named Associate Justice of the Appellate Division, First Department.

Justice Rosenberger has been an adjunct professor of law at New York Law School since 1976, and has been a lecturer at Brooklyn Law School, St. John's Law School, and the New York City Police Department, among many other institutions. He is an active member of many legal committees and associations, including the New York State Bar Association's Committee to Improve the Effectiveness of the Criminal Justice System, which he chairs, and the American Bar Association's Criminal Justice Section. Justice Rosenberger is a Vice Chair on the New York Law School Board of Trustees.

Born in Hamburg, Germany in 1931, Justice Rosenberger has combined his two passions, the American legal system and his German roots, through his work as Director of the Blue Card, a self-help charitable organization for refugees from Germany. He is a graduate of City College and has a Master of Laws from the University of Virginia.

Justice Rosenberger is married to Dr. Judith B. Rosenberger, a psychoanalyst in private practice and professor at the Silbermann School of Social Work at Hunter College of the City University of New York. They are the parents of John and Anne.

It is our pleasure to honor Justice Rosenberger for his exceptional commitment to justice and his devotion to New York Law School.



ABOUT THE HONOREES Gerald C. Crotty '76 President, Weichert Enterprise, LLC



Gerald C. Crotty has extensive experience in corporate leadership, international business, private capital and public equity markets, government and public affairs, and the law.

Mr. Crotty is President of Weichert Enterprise, LLC, a private equity investment firm with interests in power, business services, distressed banks, and industrial companies, with its largest commitment in the power sector. Through its affiliates, Weichert has executed over 40 transactions in these sectors since 2003.

From 1991 to 1998, Mr. Crotty held various leadership positions with the ITT Corporation. He joined the company as a Vice President and Executive Representative of the Chairman in August of 1991 and in 1992 was appointed President and Chief Operating Officer of ITT Consumer Financial Corporation (CFC), one of the largest finance companies in the United States.

In the fall of 1993, Mr. Crotty was appointed Chairman, President, and CEO of ITT Communications and Information Services (later renamed ITT Information Services) with operations in Europe, Asia, Africa, the Caribbean, as well as the United States. Mr. Crotty led the successful efforts of ITT Information Services in a major precedent-setting contest before the European Union that created over \$2 billion in value for ITT shareholders.

Prior to joining ITT, Mr. Crotty had an extensive career in public service in New York State government. He was appointed Assistant Counsel to Governor Hugh L. Carey in 1979, First Assistant Counsel in 1981, Counsel to Governor Mario M. Cuomo in 1983, and Secretary to the Governor (or Chief of Staff) in 1985—a position he held through July of 1991. Mr. Crotty was awarded the Citizen's Budget Commission's highest medal for his public service in 1988 and was appointed a Visiting Fellow of the European Union in 1989 upon the nomination of the Republic of Ireland.

He was associated with Hawkins, Delafield & Wood upon graduation from New York Law School in 1976, where he served as Notes & Comments Editor of the *Law Review*. Mr. Crotty graduated from Fordham University in 1973.

He is on the Board of AXA Premier VIP Trust and The Jones Group, Inc., as well as several boards of Weichert Enterprise portfolio companies. Mr. Crotty currently serves as Vice Chairman of the Board of Trustees of New York Law School, is a member of the Board of Trustees of Fordham University, and is a member of the Board at the Delbarton School (New Jersey). He was a Founding Member of the U.S. Trade and Investment Center in Brussels, Belgium and served previously as the Chairman of the President's Council at Fordham University.

Mr. Crotty and his wife, Lucille, have six children and reside in New Vernon, New Jersey.

ABOUT THE HONOREES Cynthia G. Senko Rosicki '86 Co-founder, Sparkling Pointe Vineyards and Winery; Founding Partner, Rosicki, Rosicki & Associates, P.C.



Cynthia G. Senko Rosicki '86 and her husband transformed a vacant 12-acre parcel of land in Long Island's North Fork into an award-winning vineyard. They are owners of Sparkling Pointe, New York State's only winery dedicated to the production of sparkling wine. They have received numerous accolades from critics. At the prestigious 2009 San Francisco Chronicle wine competition, their 2000 Brut Seduction surpassed the reputable Californian Frenchrooted competition; their sparkling wine earned the Best of Class and Sweepstakes Award, unequivocally placing

Long Island on the world map of sparkling wines for the first time. Sparkling Pointe was the first in New York State to receive 90 points from Wine Spectator and Wine Enthusiast for their Méthode Champenoise wines.

Ms. Rosicki is also founding partner of Rosicki, Rosicki & Associates. She is the first woman in the United States to found a law firm specializing in creditor representation in default matters. Ms. Rosicki started the law firm in the back of her parents' funeral home with the assistance of her sister, Dawn Polewac. She seized an opportunity to represent a bank in real estate matters and did it all: real estate transactions, mortgage foreclosures, bankruptcy, evictions. The firm also manages a Nationwide Attorney Network in addition to title, legal publishing, court and process service and companies.


She traveled throughout the country to develop clients, and Rosicki, Rosicki & Associates, P.C. and related companies grew to its current size of 450 employees in seven locations throughout the state with the assistance of her husband and law partner, Tom.

Upon her graduation from New York Law School in 1986, Ms. Rosicki, with the help of Career Services, developed the as-yet unheard of position of Financial Compliance Officer at Olympia & York Properties on Park Avenue while they were building Battery Park City and taking the first billion-dollar loans in history. Prior to law school, Ms. Rosicki studied, sang, and danced with Frederick Loewe of "Lerner & Loewe" fame. After attending The Royal Academy of Dramatic Art in London, she entered Adelphi University on early admission and pursued a dual major of Theatre and Business while simultaneously working as General Manager of the professional stage Calderone Theatre.

Ms. Rosicki has been committed to mentoring female and minority professionals as well as persons with disabilities, and has received numerous awards from New York State and others for her dedication to these goals. ABOUT THE HONOREES Daniel J. Oates '86 Chief of Police Aurora, Colorado, Police Department



Daniel J. Oates '86, Police Chief in Aurora, Colorado, is responsible for the criminal investigation of the 2012 Century 16 movie theater shootings. He began his career with the New York Police Department in 1980. He started as a street cop in Manhattan's 19th Precinct and worked his way up the ladder while attending NYLS's Evening Division.

His early career included a broad range of assignments, from patrol in several Manhattan precincts, to teaching at the Academy, to narcotics investigations in Brooklyn and multiple assignments as an attorney.

Promoted to Captain in 1992, he served the latter half of his career as a senior executive and was a participant in the remarkable crime-reduction turnaround of the 1990s. He commanded the Legal Bureau, where he directed a law office of 80-plus attorneys. Under his leadership, the Legal Bureau initiated 1,500 actions annually in civil forfeiture and nuisance abatement as part of the NYPD's larger crime-reduction strategies. He led the successful campaign to win the Ford Foundation's 1995 Innovations in American Government Award for the NYPD's "Civil Enforcement Initiative."

By the end of his 21-year career, Chief Oates had become head of the Intelligence Division and was a member of the Police Commissioner's executive staff. He served as the NYPD's principal liaison on all security and intelligence matters to the federal government and the U.N. diplomatic community. He arranged security for the 2000 U.N. Millennium Summit, the largest gathering of world leaders in history. He finished his NYPD career as second-in-command of the city's largest patrol borough, Brooklyn South, with 3,000 officers.

Chief Oates became Police Chief in Ann Arbor in August, 2001 and was named the city's first Safety Services Administrator within a year, taking on additional supervision of the Fire Department, Emergency Management, and Code Enforcement. During his four years in Ann Arbor, he successfully led a reduction in violent crime of 24 percent and an overall crime reduction of 13 percent.

Chief Oates became Chief in Aurora in November, 2005. He has overseen a 30-percent reduction in crime in his six-plus years in office. He was recognized by his peers in 2009 with his election as President of the Colorado Association of Chiefs of Police. He is the recipient of numerous professional awards for excellence and innovation. He is also a charter member of the federal Criminal Intelligence Coordinating Council and is recognized as an expert in law enforcement intelligence matters.

Chief Oates considers the performance of the men and women of the Aurora Police Department during the Century 16 tragedy to be the proudest moment of his career. He says of that day, "My cops are the greatest. Their courage and professionalism in that crisis saved so many lives."

It is our pleasure to honor Chief Oates for his extraordinary leadership and service in law enforcement and for his dedication to New York Law School.
