# Note from the Editors

Welcome to the New York Law School Hedge Fund Activism Report for 2013 to 2014. Hedge funds that engage in activism purchase shares in a company and use the voting and other control rights that come along with the shares to influence or replace managers. Empirical studies generally find that activism by hedge funds increases the value of target companies. Hedge fund activism has grown significantly in recent years, with the total assets managed by activist funds jumping from \$12 billion in 2003 to over \$112 billion in 2014.

This Report covers Schedule 13D filings with the Securities and Exchange Commission (SEC). Schedule 13D filings must be filed when a person directly or indirectly acquires more than 5% of a class of a company's voting equity securities.<sup>3</sup>

This Report covers the 13D filings made by 30 activist hedge funds between January 1, 2013 and December 31, 2014.<sup>4</sup> It provides direct links to the 13D filings on the SEC's EDGAR website, as well as information on the target companies, industries invested in, activist goals, percentage of the target company acquired, and the short-term market impact of the hedge fund's action.

Table 1 and Figure 1 show each hedge fund's activity by number of investments. Bulldog Investors LLC was the most active of the hedge funds, with a total of 12 investments in 2013-2014. Table 2 and Figure 2 show the industries of the target companies by number of investments. The majority of target companies are in the financial services industry.




# Hedge Fund Activism Report Column Glossary

<u>Hedge Fund</u>: Name of the hedge fund engaging in activism.

<u>Schedule 13D(s)</u>: A Schedule 13D is commonly referred to as a "beneficial ownership report." A beneficial owner includes any person who directly or indirectly shares voting or investment power. When a beneficial owner acquires ownership of more than 5% of a company's equity securities voting class, they are required to file a Schedule 13D with the SEC.

<u>Target Company</u>: The company whose stock the hedge fund is purchasing.

<u>Target Company Industry</u>: The target company's industry.

<u>Activist Goals</u>: The goals that the hedge fund aims to achieve with its investment include: (1) board representation, (2) board control, (3) removal of directors/officers, (4) enhancing corporate governance, and (5) maximizing shareholder value.

Ownership Percentage: The amount of stock the hedge fund acquires, represented as the percentage of company ownership.

<u>Change in Stock Price</u>: The short-term market impact of the hedge fund's investment. This is the percentage change in stock price from the next business day and start date adjusted closing price.
