SUMMER RENOVATIONS TRANSFORM LAW SCHOOL BUILDINGS

Students and faculty returning to classes on August 20 will notice dramatic changes which took place during the summer in the various buildings of the Law School.

The most changes were made in 57 Worth Street where new classrooms and offices were added. The third floor Moot Court Room and adjoining classroom have been converted into one large classroom seating over 100 students.

On the fourth floor, classroom A-400 was renovated to resemble the layout of the LeFrak Moot Court Room and will seat 117 students and a seminar room, seating 20-25 students, was completed. The staff lounge was also renovated.

The fifth floor now includes classroom A-500, and a seminar room, which will double as a conference room for fifth floor offices. The Financial Aid Office has expanded to make the heavy student traffic areas - the Offices of Financial Aid and Admissions - more accessible for students.

The large classroom on the sixth floor has been converted into two smaller classrooms. Room A-600 is now a 45-seat lecture room and room A-602 is a seminar room for 25 students.

The new classrooms were equipped with their own cooling systems which will help maintain a comfortable temperature in both the classrooms and other areas on the same floors. Each floor has been re-painted, re-wallpapered and had new carpet installed to give the floors a more unified look. New restrooms accessible to the handicapped have been added on the fourth and sixth floors.

"The new classrooms and alterations were completed to meet the changing needs of the academic program. The idea was to make everything more comfortable for the students, faculty and staff. The larger classrooms were built on the lower floors to make the rooms easier for students to reach," George Hayes, Director of Facilities Management, said.

Before any construction began on the inside of 57 Worth Street, the exteriors of 47 and 53 Worth Street were repaired and re-painted to prepare the buildings for weathering that often takes a toll on older buildings. The sidewalk outside the Mendik Library on Church Street to Leonard Street was re-paved.

STILL UNDER CONSTRUCTION...

The notoriously-slow elevator in 47 Worth Street will be closed and completely reconstructed between August and late October. During that time, please use the elevator in 53 Worth Street and walk through the connecting doors (located on each floor) to enter 47 Worth Street.

Access to the 53 Worth Street elevator is now limited only to the lobby entrance inside the building. Entrance directly from Worth Street is now reserved for handicapped access and requires the assistance of a security guard.

The Froessel Room is a part of the Law School's "five-year construction plan" and will be closed until further notice. The room is to be extensively renovated to "capture the essence of a true reading room," according to Mr. Hayes.

SOLOMON PUBLIC SERVICE ENDOWMENT FUND ESTABLISHED

The Joseph Solomon Public Service Fellowship and Endowment Fund has been established to encourage students to enter public service careers by helping to alleviate the financial struggles often associated with such a career, Dean Simon has announced.

of public service will review applications. Finalists will then be interviewed by Dr. Solomon before final selection by the dean.

The students awarded the externships will receive \$400 per week for usually unpaid summer internships with legal aid offices, City and State regulatory departments, not-for-profit public advocacy groups and other agencies.

In addition, The Joseph Solomon Public Service Fellowship Program will be awarded to one graduate pursuing a career in public service each year. The Fellowship Program will provide an annual salary supplement of \$5,000 per year, for up to three years.

Joseph Solomon '27, is an honorary trustee of the Law School and is of counsel to the Manhattan law firm of Gallet, Dreyer & Berkey. In addition to the Fund, The Joseph Solomon Distinguished Professorship of Law and The Rita and Joseph Solomon Professorship in Wills, Trusts and Estates and The Joseph Solomon Lecture are all named in his honor.

2The Code lists what the faculty and administration view as sexual harassment and proper procedures to follow if one feels that he or she has been harassed in any form.

The role of the Board is to hear sexual harassment complaints, to assess whether or not the allegations have merit, and, if they do, to recommend a sanction.
