2	told the Police, they told you about it when you got
3	in that neighborhood, isn't that it?
4	A Yes, sir.
5	Q So then in your statement you gave the Police
6	on October 14th to that extent was not true. It was not
7	a situation where he told you about it, but you actually
8	had planned it, is that correct?
9	A For a few hours.
10	Q Now, you also testified on that stand under oath
11	that Kenny said he was going to the bar, is that right?
12	A Yes, sir.
13	Q Left the car and got out on your side and he
14	turned the corner, is that correct?
15	A Yes, sir.
16	Q And that corner would be Franklin and East 16th,
17	is that correct?
18	A Where Kenny went?
19	Q Yes.
20	A No. Kenny went towards Franklin and East 18th.
21	Q Franklin and East 18th Street. Would you come
22	down and show us that please, so I will understand.
23	THE COURT: The Jury can see where Franklin

2	THE COURT: I ask the jury, can they
3	see where 18th and 16th Street is?
4	MR. BROWN: Just point it out and re-
5	turn to your seat.
6	(The witness steps to the diagram.)
7	MR. BROWN: Thank you.
8	(The witness resumes to the witness
9	stand.)
10	BY MR. BROWN:
11	Q When did you see Kenny Kellogg, if you
12	ever did?
13	A A few days later or it could have been the next day,
14	or a few days later.
15	Q Now, then on October 14th, you didn't tell the
16	Police that Kenny went to the bar on October 14th, 1966?
17	You told them Kenny stayed in the car, is that right?
18	A Well
19	Q I am only asking you one thing. Is it a fact
20	that you told the Police in this signed statement on
21	October 14, 1966 that Kenny stayed in the car?
22	A Where does it say this?
23	Q "Kenny stayed in the car."
24	A I told the Police that then.
25	O Now when you say "Stood in the car" T sasum

- 1 that means stay in the car?
- 2 A Yes.
- 3 Q So, is it a fact that this is what you told
- 4 the police on October 16, when you were supposedly
- 5 telling them the full story, is that right?
- 6 A Yes.
- 7 Q Now, it is also a fact, is it not, that when
- 8 you talked to the Police on October, and specifically
- 9 I refer you to Detective Callaham, that you did not tell
- 10 him about your taking money from the cash register, did you?
- 11 A Well, I wasn't --
- 12 THE COURT: In October?
- 13 THE WITNESS: I wasn't going to commit
- 14 myself.
- 15 BY MR. BROWN:
- 16 Q In the earlier part of October, specifically
- 17 ground October 3rd, 4th or 5th, you spoke to certain de-
- 18 tectives, didn't you?
- 19 A Yes.
- 20 Q And you told them certain additional things
- 21 about June 17, is that right?
- 22 A Yes.
- 23 Q But you did not tell them that you had taken
- 24 the money out of the cash register then, isn't that correct?
- 25 A I don't recall.

1	Q You don't recall. Well, if I show you a copy
2	of Detective Le Conte's report
3	THE COURT: How can that make him recall.
L	It is not his report.
5	MR. BROWN: It may refresh his recollection,
6	THE COURT: He can't refresh his rec-
7	ollection by what someone else wrote.
8	BY MR. BROWN:
9	Q You can't recall then whether in October,
10	around the 3rd, you did tell them the full story including
11	your going behind the bar and taking the money, is that
12	right? You can't recall that?
13	A I can recall that. I can recall what I told. They
14	told me to tell the truth. At the end I told them it and
15	I had a reason. So that Is what I did.
16	Q But October 3rd, you didn't tell them the truth?
17	A I don't recall.
18	Q Well, do you also recall talking to the two officers
19	on June 17, in the morning before the cars occupied by the
20	Defendents were brought back and I should, specifically
21	refer to Detectives Unger and Greenough. Do you remember
22	talking to them before the cars bearing the Defendents
23	were brought back? Do you recall talking to those officers?

You don't.

- A I probably did, but right off hand I am not sure.
- 2 Q You probably did. Do you recall telling them
- that there was a car -- there was a new white car with
- blue license plates? You told them that?
- 5 A Yes, I told them that,
- 6 Q And that was before the Defendents were brought
- 7 back to the scene. You told them that beforehand?
- 8 A I told them it was a New York plate.
- 9 Q And you told them that before the Defendents
- 10 were returned to the scene at Lafayette and 18th, correct?
- 11 A Yes.
- 12 Q And you also told them there was a
- 13 description of these people before the Defendents were
- 14 brought back, isn't that correct?
- 15 A Yes.
- 16 Q And the description you gave to the Police
- 17 before Carter and Artis returned to the scene at Lafayette
- 18 and 18th Street, was as follows: "That there were two
- 19 colored men, thin built, 5'11", each," is that right?
- 20 A I don't recall.
- 21 Q Well, do you recall telling them that, "One
- 22 of the fellows wore a fedors and sport jacket", before
- 23 they returned?
- 24 A Yes, I think I told them that.
- 25 Q Now, as before they were returned you said one
- 26 was thin built, 5'11"?

1	A I said that one was taller than the other one. I
2	don't know what they wrote.
3	Q "The second one was also thin built, 5'11".
4	A I don't recall.
5	Q That is in the report, would you deny it?
6	THE COURT: Don't answer the question.
7	We are not interested in what is in the
8	report. That is wholly improper in ques-
9	tioning the witness.
10	MR. BROWN: Your Honor, it is laying
11	a foundation.
12	THE COURT: You can lay a foundation by

6	THE COURT: Do what?
7	BY MR. BROWN:
8	Q Slay the bartender?
9	THE COURT: What?
1.0	MR. BROWN: When did he slay the bartender?
11	That is addressed to him?
12	THE PROSECUTOR: Objection.
13	THE COURT: Answer that.
14	THE WITNESS: It is not to my knowledge.
15	MR. BROWN: No further questions, your

19	question, "When did you slay the bartender?"
20	There is nothing to support it thusfar in my

- 13 A Yes.
- 14 Q And you saw a shotgum in one man's hand, is that
- 15 right? A Yes, sir.
- 16 Q But you can't tell what kind of a shotgum, is
- 17 that right?
- 18 A Definitely not.
- 19 Q You don't know if it was a one barrel or two
- 20 barrels?
- 21 A I definitely know one man had a shotgum and I definitely
- 22 know one man had a pistol.
- 23 THE COURT: Just answer the question.
- 24 Do you know whether it was one barrel or two
- 25 barrels?

- THE WITNESS: No. sir.
- BY MR. STEIN:
- 3 Q And you don't know what size the pistol was
- 4 do you, sir?
- 5 A Not exactly.
- 6 Q Well?
- 7 A No, sir.
- 8 Q Cam you describe this weapon at all, sir?
- 9 A Not in detail.
- 10 Q Can you describe it at all?
- 11 A Not in detail.
- 12 Q I am not asking you for a detail description.
- 13 I want you to tell me whatever you can recollect at all
- 14 about this weapon?
- 15 A It was a pistol. That is all I could recollect. It
- 16 was a pistol.
- 17 Q And could you tell us what kind of a pistol it was,
- 18 as to the shape or the type of the pistol that it was?
- 19 A No, sir.
- 20 Q It could have been an automatic, could it not,
- 21 Mr. Bello?
- 22 A All I could tell you, sir, is that it was a pistol
- 23 and I don't know it. I can't go into detail.
- 24 Q You don't know if it was an automatic?
- 25 Now, do you know what an automatic pistol is?

1	A I believe so.
2	Q But you don't know if this was an automatic,
3	do you? A No, sir.
4	Q And you don't know if it was a revolver either,
5	do you? A No, sir.
6	Q And you certainly know, if I were to place an
7	automatic and revolver side by side, let us say on that
8	easel over there, you would be able to walk over and say
9	that is an automatic and that is a revolver, isn't that
10	right, sir? A Definitely.
11	Q But you didn't know in this case which?
12	THE COURT: He said he did not.
13	BY MR. STEIN:
14	Q Now, you described one man as rather, specifi-
15	cally as to the clothes that he wore, with reference to
16	a vest, jacket and so forth, is that right? A Yes
17	Q That man was holding which weapon, according
18	to your recollection? A Shotgum.
19	Q And the other man was dressed how, sir, the
20	man whom you say was holding some kind of pistol?
21	A Darker clothes, brown or blue. I don't actually
22	notice clothes too well.
23	Q Well? A The color I mean.
24	Q Well, on Friday, October 14, when you gave the

statements, did you give some description as to what the

2	clothes were that this man was wearing?
2	THE COURT: Will you show him what you
3	are referring to?
4	BY MR. STEIN:
5	Q Let me show you on Page 2. This, of course,
6	you are familiar with, are you not, of this statement?
7	This is your statement, isn't it?
8	A I just told my story.
9	THE COURT: Just answer the question.
10	THE WITNESS: Yes.
11	BY MR. STEIN:
12	Q That is your signature? A Yes, sir.
13	Q Do we have to go and see if you can identify
14	each issue?
15	THE COURT: Don't argue with him. He
16	said yes.
17	BY MR. STEIN:
18	Q Page 2, sir. "The other one was a little taller
19	and he was wearing dark clothes, brown or black or some-
20	thing like that." A Yes.
21	Q Is that what you said on October 14, 1966?
22	A Yes, sir.
23	THE COURT: And now he said brown or blue.
24	THE WITNESS: Brown, black or blue.
25	BY MR. STEIN:

Bocause what you remembered on October 14. 1966,

1,23

1	was that it was brown or black, or something like slat,
2	is that right? A That is correct.
3	Q Were you able to make any other observations
4	as to the type of clothes that this man with this pistol
5	was wearing? A Sir?
6	Q Were you able to make any observations as to
7	the type of clothes that this man with the pistol was
8	wearing? Could you describe the type of garments that
9	he wore?
10	A I can't go into detail.
11	Q Let me ask this. Can you describe anything
12	about the characteristics of these clothes that you
13	recall other than the color?
14	A Just the color.
15	Q You can't recall whether for instance the man
16	was wearing a jacket or a shirt, can you? A No, sir
17	Q And you can't recall that the man had a tie
18	on, could you? A No, sir,
19	Q And you can't recall for instance if this second
20	man who you say was carrying some kind of a pistol was
21	wearing a hat of any kind, can you? A I be-
22	lieve he had a hat. I'm not sure. I'm not positive, so
23	I'm not going to say.
24	Q But you can with particularity describe the clothes

of the man whom you say was carrying a shotgum, in much

1	man who you say was carrying a pistol, is that right?
2	THE PROSECUTOR: I object. The witness
3	has testified as to what he saw.
4	THE CCURT: No, it is a proper question.
5	The objection is overruled.
6	Do you recall the question?
7	THE WITNESS: Will you repeat it?
8	BY MR. STEIN:
9	Q Yes, you can give much more specific details
10	about the clothes of the man who was carrying the shotgun
11	as you said, then you can about the man whom you say was
12	carrying some kind of a pistol, can't you?
13	A Well, sir, you are right. But I am not a movie camera,
14	you know.
15	MR. BROWN: Pardon?
16	THE COURT: Ha said, "You are right."
17	MR. BROWN: May I ask that the last portion
18	of the answer be read?
19	THE COURT: Will you please read it.
20	MR. STEIN: I ask that it be stricken.
21	THE COURT: Did you hear it?
22	MR. STEIN: I heard it.
23	MR. BROWN: I didn't hear it.
24	THE COURT: I don't think you heard it.
25	(The requested answer is read by the Court

1	MR. BROWN: I want that to remain,
2	THE COURT: It will remain.
3	Alright, now you are consistent, Gentlemen.
4	The two of you will have to get together,
5	MR. BROWN: We are always consistent, your
6	Honor. Maybe wrong, but always consistent,
7	THE COURT: Proceed, Mr. Stein.
8	BY MR. STEIN:
9	Q Now, you came back to police Headquarters, did
10	you not, sir, in a car?
11	A In a car that morning.
12	Q And when you came back there had you am op-
13	portunity at that time to see Mr. Carter and Mr. Artis?
14	A Yes, sir.
15	MR. STEIN: I have no further questions.
16	THE COURT: Anything further?
17	THE PROSECUTOR: Yes, your Honor.
18	REDIRECT EXAMINATION
19	BY THE PROSECUTOR:
20	Q Mr. Bello, I show you S-40 for identification.
21	Is that your signature? A Yes, sir.
22	Q This, is a statement I believe you gave to the
23	police on June 17, 1966? A Yes, sir.
24	Q Now, on that particular date on June 17, 1966
25	ross you saled this mantion?

1	MR. BROWN: I object. There has to be
2	a certain preliminary procedure before he can
3	do this.
4	THE COURT: You asked questions based on
5	the statements. If it is on the same subject
6	matter he is certainly entitled to go into it.
7	We don't know until we hear the question.
8	MR. BROWN: That is the problem. That is
9	the problem and I would like to be heard out
10	of the presence of the jury.
11	THE COURT: You want to be heard?
12	MR. BROWN: In an offer of proof.
13	MR. STEIN: May I request that Mr. Bello
14	be excused too?
15	THE COURT: Well, there is no big problem.
16	Do you have any objection to that?
17	THE PROSECUTOR: I have no objection.
18	THE COURT: The jury will be excused for a few
19	minutes.
20	(The jury is excused from the Courtroom.)
21	(Alfred Bello is excused from the Courtroom.)
22	(A motion is made by the Prosecutor to read
23	certain portions of the June, 1966 statement and
24	is granted by the Court.)
25	(The jury is returned to the Courtroom.)

1	(Alfred Bello, being previously sworn
2	resumes the witness stand.)
3	THE COURT: Alright.
4	THE PROSECUTOR: Thank you, your Honor.
5	CONTINUATION OF REDIRECT EXAMINATION
6	BY THE PROSECUTOR:
7	Q Now, Mr. Bello, with respect to S-40 for iden-
8	tification, on June 17, 1966 were you asked this question:
9	"Tonight in the city of Paterson you were a wit-
10	ness to a shooting. Will you tell me in your own words
11	all that you can recall about the events that lead to this?"
12	Were you asked that? A Yes, sir.
13	Q And did you give this answer, "Yes, a friend
14	of mine named Kenny let me get out of his car, a block
15	away from this tavern. I was going to the tavern to
16	get cigarettes. I told him to go around the block. As
17	I was walking up the street towards the bar, I heard two
18	gun shots, so then I stopped, I didn't think that this
19	tavern had a band, I heard two more gun shots. I had one
20	cigarette left, and I lit the cigarette, and waited a
21	minute. Nobody came out of the bar, so, I started walking
22	down towards the bar. Then two colored guys, came out of
23	the front door, one was about as tall as me, the other was

THE COURT: Alright. The jury will understand that this statement that has been read seems to be cut off. The Court has not permitted anything further to be utilized in this statement. That is why it sounds that way. In addition, I wish to instruct the jury that the use of this statement, both by the defense and by the State, involves the problem of credi-

3	bility of the witness. The statement itself
2	is not to be used by you as substitive evidence
3	of what it contains.
4	In other words, you are not to consider
5	that as the evidence in the case. It is only
6	used for the purpose of the credibility of
7	the witness, whether it be to attack or to
8	support him.
9	BY THE PROSECUTOR:
10	Q Mr. Bello, as far as I read down at the end of
11	the page one, was that the answer given on June 17, 1966?
12	A Yes, sir.
13	Q Now, I show you S-41 for identification. Is that
14	your signature on the bottom of page five? A Yes, sir.
15	Q With respect to page one of that statement, on
16	October 14, 1966 were you asked this question?
17	THE COURT: Are you going into it? I'd
18	like to advise the jury.
19	THE PROSECUTOR: Yes, Sir.
20	THE COURT: Now, Ladies and Gentlemen, the
21	State now intends, now as I understand it, to
22	make reference to another statement given by this
23	witness on October of 1966. Again, the purpose
24	of this statement is not to, establish the facts
25	contained in this statement. That is not evidence.

Such a statement cannot be used for that purpose. 1 In this case this witness was attacked on cross-3 examination by virtue of the statement which you heard referred to of June 17, 1966. Now, the State is permitted to utilize another statement, not for the purpose of proving the truth of what 6 7 is contained in it, but for the purpose of showing 8 that the witness made another statement which may 9 be or may not be as you find it, consistent with 10 what he testified to in Court. 11 If in other words, this statement also is only 12 to be considered by you in the matter of 13 considering and judging the credibility of the 14 witness, and not as subsitive evidence of its 15 contents. 16 THE PROSECUTOR: Thank you, your Honor. 17 BY THE PROSECUTOR: 18 Mr. Bello, were you asked this question? 19 I am going to ask you some questions in 20 regard to your activities during the early morning hours of 21 June 17, 1966. Do you agree to tell me truthfully of your activities at that time?" Were you asked that question? 22 23 Yes, sir. 24 MR. BROWN: Now, your Honor, that is not 25 proper. That was not ever been gotten into in

1	this case. I understood you limiting him to
2	read that portion which related to whatever
3	examination there was. There was no such
4	question asked.
5	THE COURT: Alright. The objection is overruled.
6	BY THE PROSECUTOR:
7	Q Did you give this answer, "Yes," A Yes, slr.
8	Q WEre you then asked, Will you tell me in your
9	own words where you were and with whom during the early
10	morning hours of June 17, 1966?" Were you asked that
11	question? A Yes.
12	Q And did you give this answer, "On June 17, I
13	was driving around with Dexter Bradley and Kenny Kellogg.
14	Kenny Kellogg was driving the car and we rode around the
15	area of Lafayette Street and E. 18th Street. Then we
16	parked the car about the middle of the block on Franklin
17	Street between E. 18th and E. 16th Street. Kenny stood
18	in the car and me and Dexter got out of the car. We
19	walked up to the corner of E. 16th and Lafayette Street.
20	Dexter told me about pulling a Breaking and Entering. So
21	we walked over to the building and checked it out. Bradley
22	said he would go into the building, and if I would stand
23	on the corner of E. 16th Street and Lafayette and watch
24	for any cars. While I was standing on the corner, I

2	toward Franklin Street, and as I turned around I saw a
3	white car. It was either coming down E.16th Street or

As I was coming closer to the bar 14 15 I noticed there was a white car parked about 3 feet from 16 the curb, facinf 16th Street. I noticed it was the same 17 car that I had seen earlier. I got to the end of the 18 building, and two men came walking around the corner. 11	looked out the front door for a street post sign, but I
12	didn't see one. So I went back and I said"
13	"The girl from upstairs came down and about 4 or 5
14	minutes later the police car got there. The patrolman in
15	the car asked me"There was a question and then he told
16	the policeman scmething. "Then about 10 or 15 minutes
17	later the police brought the car back, and the two men
18	that were at the car with the police were the same two
19	men I seen coming out of the bar."
20	Did you give that answer? A Yes, sir,
21	MR. BROWN: Now, if your Honor, please,
22	is that the end of it, Mr. Hull?
23	THE PROSECUTOR: I am going now to page
24	5, Mr. Brown.
25	MR. BROWN: Page 5.

1	Well, the rest is colloquy, your Honor,
2	which was never touched in this case.
3	THE COURT: What are you referring to
4	on Page 5?
5	THE PROSECUTOR: I am starting with the
6	first question, your Honor.
7	MR. BROWN: I did not refer to any state-
8	ment of this. This is all colloquy.
9	THE COURT: Yes, that will have to be
10	asked by direct questioning rather than through
11	the statements.
12	THE PROSECUTOR: Very well, your Honor.

14	Q Mr. Bello, you gave a statement to the police
15	on June 17, 1966, is that correct? A Yes, sir.

19	Street, is that right? A Yes, sir.
20	Q Why did you not identify Mr. Carter and Mr. Artis
21	at the time?
22	MR. BROWN: I object to it, your Honor.
23	THE COURT: Yes, your objection is noted.
24	We, of course, covered that problem.

1	THE WITNESS: Because I recognized the
2	fact that I was down in the area and I was
3	on a conspiracy to break and enter, in helping
4	to break and enter. And later on as I walked
5	up the street I got involved in a murder. And
6	I also realize that I had recognized the two men

8	if I had recognized them they had recognized

13	THE COURT: The objection is overruled. You

18	I was approached on three different occasions.
19	MR. STEIN: I object to that, your Honor.
20	THE COURT: That will be stricken.
21	Alright, the jury will disregard the last
22	remarks.
23	The jury will disregard the remark of being
24	approached on several occasions.

7	you? A Sir?
8	Q I asked you, did you see anybody coming out
9	of the bar? A Yes, I did.
10	Q You did? From what door did you see them
11	come out of? A I seen them come around
12	the corner.
1.3	Q Then seeing them come out of the bar is a lie,
14	isn't it?
15	THE COURT: Don't ask him to characterize
16	whether it is truthful or not. Just ask him
17	what the facts are.
18	BY MR. BROWN:
19	Q The fact is that you did not see them coming
20	out of the bar, isn't that correct? A Yes, sir.
21	Q So therefore in this truthful statement that
22	fact is incorrectly set down, is that right? A Yes, sir.
23	Q Did you give a statement to the police on the
24	18th day of June?
25	THE COURT: You mean a written statement?

1	MR. BROWN: Yes, sir. That is the burden
2	of my question, your Honor.
3	THE COURT: Alright. Can you answer that?
4	THE WITNESS: On the 18th?
5	BY MR. BROWN:
6	Q That is right, as opposed to the 17th?
7	A In that general area. I don't recall.
8	THE COURT: Did you give another written
9	statement besides June 17th?
10	THE WITNESS: It might have been on the

13	Q And how long did you stay down at the end?
14	A I just turned right around and came back out.
15	Q You turned right around and came back out, is
16	that right? A To the best of my

18	Q Now, you have stated that one man was a little

20	that Mr. Stein covered this morning, is that right?
21	A Yes, sir.

22	THE COURT: Well, there are two general
23	statements , Mr. Brown. You have covered the
24	specifics and the jury has heard it.

1	you gave the police, including the other statements, and
2	interrogated you on this morning, the oral statements that
3	allegedly were given to other police officers, all of them,
4	each is different from the other, is that not true, the
5	statement of October 17, the statement you gave to the
6	police? All of these differ, do they not?
7	THE PROSECUTOR: Objection.
8	THE COURT: Objection sustained. It is
9	too broad a question.
10	BY MR. BROWN:
11	Q On October 3rd, you concede that you told the
12	Officers who spoke to you a part of your new story but
13	left out the business of rifling the safe, is that right?
14	A I don't recall. I don't recollect.
15	Q You don't recollect. Well, do you recollect that
16	in the statement of October you told something about the
17	safe that you had not told in the June 17th statement, isn't
18	that correct?
19	THE PROSECUTOR: Objection.
20	THE COURT: Why?
21	THE PROSECUTOR: Something about a safe.
22	THE COURT: You mean the register?
23	BY MR. BROWN:
24	Q The register. Did you say something about the
25	register in October that you hadn't said in June? A Yes.

1	Q And you said something about the identity of

1	MR. BROWN: Not the next question,

3	I finish. Your present question is improper.
4	You have covered it completely on your cross-
5	examination. This should be limited to the
6	statements and on the subsequent testimony.
7	BY MR. BROWN:

18	given a sentencs in the Passaic County jail of 61 days?
19	A Yes.
20	Q On or about December 7th of 1962 were you
21	convicted of larceny of a motor vehicle in the Passaic
22	County Court and given a sentence of two years probation?
23	A Yes.
24	Q On or about September the 13th of 1964, were

25 you convicted of breaking and entry with intent to

1	steal and larceny in the Passaic County Court, and
2	sentenced to Bordentown for an indefinite term?
3	A Yes.
4	Q On or about March the 12th of 1965, were you
5	convicted of breaking and entering with intent to steal
6	and larceny in the Bergen County Court and sentenced to
7	an indeterminate term in Bordentown to run concurrent
8	with your conviction in the Passaic County Court?
9	A Yes.
10	Q And also on March the 12th of 1965, were you
11	convicted in the Bergen County Court of breaking and
12	entering with intent to steal and larceny and sentenced
13	to Bordentown for am indeterminate term which sentence
14	was to run concurrently with your conviction in the
15	Passaic County Court? A Yes.
16	Q Mr. Bradley, where are you at the present time?
17	A Morris County jail.
18	Q Morris County jail. Please keep your voice up.
19	Mr. Bradley, where were you on June the 17th of 1966,
20	approximately between 2 and 2:30 in the morning?
21	A In the vicinity of the Lafayette Grill in Paterson.
22	Q You will have to keep your voice up.
23	THE COURT: Will you try to speak out?
24	Maybe you ought to bring the chair up a little
25	too.

1	BY THE PROSECUTOR:
2	Q How did you get to the vicinity of the Lafayette
3	Grill? A In the car.
4	Q In whose car? A Kenny Kellogg's
5	Q And where did you go in the car?
6	A When we arrived in that vicinity?
7	Q Yes. A We parked on Franklin
8	Street.
9	Q In Paterson? A Yes.
10	Q Now, Mr. Bradley, would you please step down
11	to this diagram which is S-3 in evidence.
12	(The witness steps down to the diagram.)
13	BY THE PROSECUTOR:
14	Q This is East 18th Street; Lafayette Street; East
15	16th Street and Franklin Street. Can you point out for us
16	on this diagram approximately where you stopped in the car
17	on Franklin Street? A We parked
18	right here.
19	THE COURT: Number one, Mr. Bradley, would
20	you turn to your right so the jury can see the
21	diagram, and yell out so everybody can hear you,
22	please.
23	THE WITNESS: We parked the car on Franklin
24	Street facing East 16th Street.
25	DA HATE DEOCECHAOD.

1	Q Who was in the car at that time? You may resum
2	the witness stand.
3	(The witness resumes the witness stand.)
4	BY THE PROSECUTOR:
5	Q Who was in the car at that time?
6	A Kenneth Kellogg, Alfred Bello and myself.
7	Q And what did you do after the car was parked on
8	Franklin Street? A I removed a tire iron
9	from under the front seat.
10	Q You will have to speak up.
11	A I removed the tire iron from under the front seat.
12	Q Of the car? A Yes.
13	Q And what did you do? A Alfred
14	Bello and I walked up Franklin Street to East 16th and
15	toward Lafayette Street for the purpose of breaking into
16	a building.
17	Q What building was that?
18	A Ace Sheet Metal.
19	Q Now, would you step down again please and show
20	for us on this diagram the route that you took?
21	(The witness steps down to the diagram.)
22	THE WITNESS: We left the car, here. We
23	walked down Franklin Street to East 16th and
24	the building is right here.
25	THE PROSECUTOR: Alright. You may get

1	back on the witness stand.
2	(The witness resumes the witness stand,)
3	BY THE PROSECUTOR:
4	Q And what did you do then when you turned into
5	East 16th Street?
6	A I told Bello when we got to it.
7	Q You had a conversation with Bello?
8	A Yes.
9	Q What did you do after you had the conversation
10	with Bello? A Just before we got to the
11	front of the place I told Bello to
12	MR. BROWN: I object.
13	THE COURT: Don't tell us the conversation.
14	As a result of the conversation what did you do
15	next?
16	THE WITNESS: I went to the front door of
17	the building.
18	BY THE PROSECUTOR:
19	Q Now, I show you S-36 in evidence, a photograph.
20	Is the front door of that building contained in this
21	photograph? A Yes, right there.
22	THE COURT: You see you can't speak to
23	yourself. We all have to hear you. What did
24	you say?
25	THE WITNESS: Yes, it is in the photograph.

1	BY THE PROSECUTOR:
2	Q Would you point out to the Judge, counsel
3	and the jury where this door was?
4	A Right here. Behind the trees.
5	THE COURT: Behind the trees to the right
6	of the truck that is parked there, is that
7	correct?
8	THE WITNESS: Yes.
9	THE COURT: Alright. Turn it around for
10	the jury.
11	THE WITNESS: Right here.
12	THE COURT: Do you want to hold it up a
13	little. I don't think they can see it.
14	Did everyone see it?
15	BY THE PROSECUTOR:
16	Q What did you do when you got to the front door
17	of the building?
18	A I tried to force the door with the tire iron.
19	Q And what happened?
20	A Bello had gone up to the corner to
21	Q Please you will have to keep your voice up.
22	A Bello had gone up to the corner to watch for any cars
23	coming or for the police. I tried to force the door.
24	Q Toward which corner did Bello go?
25	A East 16th and Lafaverte.

1 Q Is this the corner? Yos. 2 What happened then? A car 3 went by and I threw the tire iron into the weeds right 4 around there. I threw the iron into the grass right 5 around there. 6 Q What were you doing when the car went by? 7 I went to the corner. 8 Did you see the car that went by? 9 No. I had all black clothes on and I hid my face 10 so a car going by wouldn't see me. It would be harder 11 for them to see me. 12 Now, could you tell where the car was going by? 13 It came from Lafayette Street and went toward 14 Franklin on East 16th. 15 You mean in this direction? Yes. Where were you when Bello walked up there? 15 16 Still trying to force the door. 17 And what happened then? I realized that a car could come up Lafayette Street. 18 19 The police, if someone had noticed us. 20 MR. BROWN: I object and ask that all tha 21 be stricken. 22 THE COURT: That will be stricken. 14	THE WITNESS: Yes.
1.5	THE COURT: Now, what street is that, 16th
16	Street, or Lafayette?
17	THE WITNESS: This is on East 16th.
18	THE COURT: East 16th. Alright.
19	BY THE PROSECUTOR:
20	Q Will you show that to the jury?
21	A It is right here.
22	Q Now, where did you go after you
23	THE COURT: Well, before that so we can
24	clarify it, you say you came out of an alleyway.
25	Was that alleyway facing Lafavette or 16th

1	Street?
2	THE WITNESS: Facing Lafayette.
3	BY THE PROSECUTOR:
4	Q But it is in back of the corner house, is that
5	right, the side of the corner house?
6	A The alleyway goes through East 16th and you can come
7	out on Lafayette.
8	THE COURT: It turns around to Lafayette?
9	THE WITNESS: Yes.
10	THE COURT: So you came out of it facing
11	the Lafayette Street side?
12	THE WITNESS: Yes.
13	BY THE PROSECUTOR:
14	Q I show you S-33 in evidence and does that picture
15	show the area where you came out of the alleyway?
16	A Yes.
17	Q Where was that? A Right here.
18	This is the alleyway. This is really an opening that
19	faces Lafayette Street.
20	Q Will you show that to the jury.
21	A Right here. Here is the alleyway I came out of over
22	here.
23	THE PROSECUTOR: May I show these to the
24	jury, your Honor?

2	BY THE PROSECUTOR:
3	Q How long a period of time did you see that car?
4	The distance where you were at the first time you saw it?
5	A I was right at the end of the house here and this car

8	was going, with the pointer? A Toward
9	East 18th Street on Lafayette. It was going this way.
10	Q Alright. You can put the pointer down and go
11	back to your chair.
12	(The witness resumes the witness stand.)
13	BY THE PROSECUTOR:
14	Q Can you describe the car that you saw?
15	A I thought it was a white car. It was new. I thought
16	ic was
17	MR. BROWN: I object and ask that be
18	stricken.
19	THE COURT: What stricken?
20	MR. BROWN: What he thought.
21	THE COURT: So far he said it was a white
22	car, new.
23	MR. BROWN: He said he thought it was a
24	white car.

THE COURT: That is what testimony is

1	(The exhibits are shown to the jury.)
2	BY THE PROSECUTOR;
3	Q Now, Mr. Bradley, what if anything happened
4	when you came out behind that rear house as you were
5	coming out from the alleyway?
6	A I didn't come right out to the sidewalk. I came out very
7	slowly and looked down the street and I didn't see any cars
8	coming up, and just as I went to go back I saw a car coming
9	from it could have been coming from up Lafayette or East
10	16th Street. It was on Lafayette Street traveling toward
11	East 18th.
12	Q Now, will you step down again please to S-3 in
13	evidence. Please keep your voice up.
14	(The witness steps down to the diagram.)
15	BY THE PROSECUTOR:
16	Q Can you on this diagram, S-3 in evidence, show
17	the Court the alleyway in which you were in?
18	THE COURT: Cam you ladies and gentlemen
19	see that diagram?
20	THE WITNESS: I came through this alleyway
21	right here and came through right about here,
22	just before the houses end. I looked down
23	Lafayette Street and I didn't see any cars.
24	Just then I noticed a car. It could have been
25	coming from Lafayette Street or East 16th Street

9	THE WITNESS: Yes.
10	THE COURT: As you observed it?
11	THE WITNESS: Yes.
12	THE COURT: Alright, proceed.
13	BY THE PROSECUTOR:
14	Q Now, the driver's side was closest to you, to
1.5	where you were standing, is that correct?
16	A Yes.
17	Q I show you S-30 for identification and ask if
18	you have ever seen what is contained in that photograph
19	before?
20	MR. BROWN: I object to that. It is not a
21	question of what he has ever seen. This man has
22	talked about a particular kind of car.
23	THE COURT: The objection is overruled.
24	He is permitted to ask him whether he has seen
25	that or not.

1	THE WITNESS: Yes, it is similar to the
2	car I saw on that night.
3	BY THE PROSECUTOR:
4	Q Please keep your voice up.
5	A It is similar to the car I saw on that night.
6	THE PROSECUTOR: I offer S-30 for identi-

in here.
BY THE PROSECUTOR:
Q Now, where were you when you first heard the
noises? A Right in around here.
THE COURT: Pointing to the front of the
Ace Metal Building.
BY THE PROSECUTOR:
Q And point out again where you were when you
heard these noises for the second time?
A Somewheres in here.
THE COURT: Indicating somewhere between
tell me the numbers there.
MR. STEIN: Between 247 and the end of 251,
is that right, Mr. Bradley?
THE WITNESS: 241 and 257.
MR. STEIN: Somewhere between 241 and 257.
THE COURT: Do you know more specifically
where you were when you heard the noises?
THE WITNESS: No.
THE COURT: Alright.
THE PROSECUTOR: You may resume the stand.
(The witness resumes the stand.)
BY THE PROSECUTOR:
Q And what did you do, then?

1	A I continued down Lafayette Street toward East 18th
2	Street. That person was in front of me all the time.
3	Q And who was the person that was in front of
4	you? A I am not sure. I thought it was my
5	friend Bello.
6	Q And what happened then?
7	A Two people came out fromI saw two people pass my
8	friend, pass Bello.
9	Q You saw them pass Bello? A Yes.
10	Q What do you mean?
11	MR. BROWN: I object.
12	THE WITNESS: Not pass him. Past.
13	MR. BROWN: Pass him?
14	THE COURT: They passed him?
15	THE WITNESS: Yes.
16	BY THE PROSECUTOR:
17	Q Show us on the diagram what you saw?
18	MR. BROWN: I object, your Honor. This is
19	obviously a key area. Let the man tell the
20	story.
21	THE COURT: I am sorry. The Prosecutor
22	can direct his questions as he sees fit. If
23	he wants him to show something on the diagram
24	he is permitted to do so.
25	Step down.

(The witness steps down to the diagram.) 2 BY THE PROSECUTOR: 3 First show us where you were when you saw it? I was just coming into the trees, here. 5 Q Where was Bello? 6 Right in about here. 7 THE COURT: Indicating the end of the corner 8 building around there. 9 THE WITNESS: Yes. 10 THE COURT: And you were where the trees are 11 located. 12 THE WITNESS: Yes. 13 BY THE PROSECUTOR: Alright. Now, who and what else did you see? 14 15 I saw two Negroes right in around here. 16 Where? Here. 17 And what happened then? 18 A As soon as I saw them I turned and ram. And Bello was 19 still walking in this direction toward East 18th Street. I 20 turned and ran. 21 And where were the two Negroes when you turned Q 22 and ran? A Right in here some place. 23 And where was Bello? Still 24 walking toward East 18th Street about right in here. THE PROSECUTOR: Alright, you may resume 25

1	the witness stand,
2	(The witness resumes the witness stand.)
3	BY THE PROSECUTOR:
4	Q Now, cam you describe the two Negroes that you
5	saw? A Yes.
6	Q What did you see?
7	A What they had on or what?
8	Q Describe them in any way you can?
9	A One hadboth of them had something intheir hands.
10	One had either a rifle or a shotgum in his hand. I am not
11	sure what the other had in his hand.
12	MR STEIN: I couldn't hear the answer.
13	THE WITNESS: I am not sure what the other
14	person had in his hand.
15	THE COURT: Did he have something?
16	THE WITNESS: Yes.
17	THE COURT: You are not sure of what it
18	was?
19	Alright.
20	What else did you observe about them,
21	description wise? Was there anything about their
22	clothes, the size, or what they looked like?
23	THE WITNESS: One was short and the other
24	one was tall. The shorter one had a light sports
25	jacket on, light colored sports jacket. That is

1	the one had the rifle or shotgum in his
2	hand.
3	And the other one I think had a sweater
4	on. I am not sure.
5	MR. BROWN: He had a sweater on?
6	THE COURT: "He had a sweater on. I am not sure."
7	BY THE PROSECUTOR.
8	Q Is the man who was wearing the shotgum or rifle
9	in this Courtroom?
10	A Yes.
11	Q Where is he? Point him out, please,
12	A He is right there.
13	THE COURT: Pointing where? Tell us again.
14	THE WITNESS: That Negro right there.
15	MR. BROWN: He said, "That Negro right there"?
16	Is that what he said?
17	THE COURT: Yes, that is what he said,
18	pointing to Rubin Carter. The record will in-
19	dicate that he has pointed to the defendant
20	Carter.
21	BY THE PROSECUTOR:
22	Q At the time when you were on the scene there,
23	were you able to determine who the other individual was?
24	A No.
25	Q Now, what did you do after you got to the

1 trees? I saw these two people and 2 Bello was still walking toward him, and then I turned 3 and ran back up Lafayette Street toward East 16th Street, And where did you go? Q Into the 5 opening that I had come out of on Lafayette Street. Please keep your voice up. Now, I show you 6 7 S-33 in evidence. Does that show the area where you ram 8 to? Yes. 9 And where did you go? Q 10 Right in here. 11 And what did you do when you got there? Show 12 the Court and the jury the area you ran to? 13 I ran right into here. 14 THE COURT: In other words, the same area, 15 the alleyway we were talking about earlier in 16 the testimony? 17 THE WITNESS: Yes. 18 THE COURT: Show it to the jury. 19 THE WITNESS: Right here. 20 BY THE PROSECUTOR: 21 And what did you do there? I stopped there. 22 23 Whereabouts? Right in the alleyway Q 24 in the opening there. Just out of the side of the street. 25 In the alleyway? Q Yes.

1	Q I show you S-35 in evidence. Can you show us
2	in that picture where you were?
3	A Yes, right at the end of this alleyway, just out
4	of the side.
5	THE COURT: You better show this to the
6	jury. That is more important than showing it
7	to me.
8	THE WITNESS: Right at the end of this
9	alleyway.
10	THE PROSECUTOR: Would you mark that with
11	am X.
12	THE COURT: It is on which exhibit?
13	THE PROSECUTOR: S-35 in evidence, your Honor.
14	(The witness complies.)
15	BY THE PROSECUTOR:
16	Q How long did you remain in the alleyway?
17	A I am not sure. About one or two minutes.
18	Q What happened next?
19	A Bello ram up Lafayette Street toward the opening and
20	I saw him when he came up to the opening. He ram up to
21	ma.
22	Q Then what happened then?
23	A He gave me some money.
24	Q And what did you do after he gave you the money?
25	A I went through the alleyway and came out on East 16th

1	Street.
	DELEGE

- 2 Q Before that did you have a conversation with
- 3 Bello? A Yes.
- 4 Q And after the conversation what did you do?
- 5 A I went through the alleyway and came out on East
- 6 16th Street and walked toward Franklin Street and down
- 7 Franklin Street to where we had the car parked.
- 8 Q Now, will you step down again and show us the
- 9 route that you took.
- 10 (The witness steps down to the diagram.)
- 11 BY THE PROSECUTOR:
- 12 Q Show us the route you took.
- 13 A Through this alleyway out onto East 16th Street and down
- 14 toward Franklin and across the street and came over to here
- 15 where the car was.
- 16 Q Where were you going?
- 17 A To the car.
- 18 Q Was the car there? A No.
- 19 Q When you say car, which car do you mean?
- 20 A Kenneth Kellogg's.
- 21 Q What did you do after you reached that area there
- 22 where the car was? A I continued down
- 23 Franklin Street toward East 18th Street. There is an
- 24 alleyway there by the corner house. I went through that
- 25 alleyway and came out to East 18th Street and looked down

1 toward the corner, here. And what, if anything, did you see at that time? 2 3 There was no people there. And what did you do after you looked out onto 5 East 18th Street? I came back to 6 the alleyway and came out onto Franklin Street and stopped 7 somewhere in here. I was thinking and I happened to turn 8 around and I saw Ken Kellogg's car traveling on East 18th 9 Street toward Lafayette. 10 Will you show the jury in which direction it was 11 going. In this direction. 12 And where were you when you saw that? 13 Right about here. 14 Q What did you do after you saw that? 15 I came back up Franklin Street and crossed East 16th 16 Street and came back down to the block after 10th Avenue on 16th Street. 17 18 And what did you do after that? 19 I stopped there for about 15 minutes on the street 20 and I eventually came up East 18th Street to just about 21 across the street fromthe bar. 22 THE PROSECUTOR: You may resume the stand. 23 (The witness resumes the witness stand.) 24 BY THE PROSECUTOR:

Approximately how long did all this take from

1	the time you left the alleyway here on Franklin Street
2	and around the time you got to the bar?
3	A Between ten and twenty minutes I would say. I am
4	not sure.
5	Q And what did you see when you got to the area
6	of the bar? A There were quite a few
7	police cars there and I was standing with some people
8	across the street from the bar on East 18th Street.
9	Q And what did you see or what did you do?
10	A I asked the lady there
11	THE COURT: Don't tell us again about the
12	conversations.
13	THE WITTESS: I had a conversation with an
14	old lady.
15	BY THE PROSECUTOR:
16	Q Was this on the street?
17	A Right on the sidewalk across the street.
18	Q And what happened them? A I walked
19	across East 18th Street to where some people were just off
20	the sidewalk there in front of the Lafayette Grill,
21	Q And what did you do there? A I saw
22	Bello come out of the bar and he came over to ma,
23	Q And did you speak with him? A Yes.
24	Q What did you do after you spoke with Bello?
25	A The police officer drove me and him downtown.

1	Q Now, did you see anything else before you went
2	downtown? A Yes.
3	Q What was that? A I saw Rubin
4	Carter and another man standing on Lafayette Street near
5	the side of the bar.
6	Q Was there anything else there?
7	A I saw a car that looked similar to the one I had
8	seen previously.
9	Q Now, you said that you were standing there and
10	you spoke to Bello, is that correct?
11	A Yes.
12	Q Don't tell us what you said to Bello. Now, how
13	long after that did you go downtown with the police?
14	A A few minutes.
15	Q Alright. Now, do you recall who it was that
16	you went downtown with? A Yes, it was a
17	detective. Detective Lawless.
18	Q And was there anyone else with you when you
19	went downtown? A Yes. There was
20	another person I knew named Ruggiero.
21	Q And was there anyone else? A No.
22	Q Was Bello there? A Yes.
23	THE COURT: Well, he already said that.
24	He said Bello, you and Lawless and Ruggiero.
25	THE WITNESS: Yes.

1	BY THE PROSECUTOR:
2	Q And where did you go in that car?
3	A To the corner of Van Houten Street and Washington Street.
4	Q And what happened there?
5	A They let me out there and I walked over to the taxi stand
6	on Clark Street and got a taxi to an apartment on North
7	7th.
8	THE COURT: Where did you go in the taxi
9	from there?
10	THE WITNESS: From the taxi stand to North
11	7th Street and Temple Street.
12	THE PROSECUTOR: Your Honor, I am still
1.3	going to be quite some time with this witness.
14	THE COURT: Alright, it is a good time to
15	recess.
16	We will recess until 2 o'clock or thereabouts
17	until you finish your lunch.
18	(A luncheon recess is taken.)
19	ARTHUR DEXTER BRADLEY, being previously
20	sworn resumes the witness stand.
21	CONTINUATION OF DIRECT EXAMINATION
22	BY THE PROSECUTOR:
23.	Q Mr. Bradley, where did you get out of the cab?
24	A At the corner of North 7th and Temple Street.
25	Q Please keep your voice up. Where did you go

- 1 when you got out of the cab?
- 2 A To the apartment of Sylvia Smith.
- 3 Q Where was that? What street was that on?
- 4 A North 7th.
 - 5 Q What floor was that on, do you remember?
 - 6 A Third floor.
 - 7 Q And what did you do when you got there?
 - 8 A I had a conversation with Sylvia. I am not sure if
 - 9 Kenneth Kellogg was there after or before me.
 - 10 Q And you had a conversation with whom?
 - 11 A With Sylvia Smith. And I am not sure if Kenny,
 - 12 Kenneth Kellogg was there when I got there or if he arrived
 - 13 a few minutes later.
 - 14 Q And what did you do after that?
 - 15 A We went to the -- Sylvia Smith, Kenneth Kellogg and I
 - 16 went to the City Service Gas Station downtown Paterson.
 - 17 Q Now, how did you get there?
 - 18 A In kellogg's car.
 - 19 Q And who drove? A Sylvia Smith.
 - 20 A Alright. And what did you do at the City Service
 - 21 Garage? A I put some gas in the car and I
 - 22 bought some gas and had a tire changed.
 - 23 Q And who paid for that? A Me.
 - 24 Q And whose car was this? A Kellogg's
 - 25 Q Now, strike that. Where was that garage that

1	we are talking about? A On the corner
2	of Market and I am not sure of the other corner. I think
3	it is Railroad Avenue or East Railroad Avenue.
4	Q In Paterson? A Yes.
5	Q And what did you do after that?
6	A We drove I drove the car then and we drove to
7	Franklin Street and East 16th Street and parked on Franklin
8	Street.
9	Q Now, will you step down and show us where you
10	were?
11	(The witness steps down to the diagram.)
12	THE WITNESS: I parked the car right here.
13	BY THE PROSECUTOR:
14	Q When you say the car, whose car do you mean?
15	A Kellogg's.
16	THE COURT: Indicating the westerly portion
17	of the intersection of Franklin?
18	THE WITNESS: Yes. The car was facing this
19	way and parked over here.
20	MR. STEIN: Can we have that marked?
21	THE COURT: You can't. It is off the chart.
22	It is left of 16th Street facing this way.
23	THE PROSECUTOR: You may resume the stand:
24	(The witness resumes the witness stand.)
25	BY THE PROSECUTOR:

1	Q What happened when you parked the car there?
2	A I left the car and went to the front of the building
3	I had been trying to break in previously.
4	MR. BROWN: I can't hear a thing he is
5	saying, your Honor.
6	THE COURT: Would you please read the answer.
7	(The last enswer is read by the Court
8	Reporter.)
9	BY THE PROSECUTOR:
10	Q And what did you do then?
11	A I forced the padlock on the side door.
12	Q I show you S-36 in evidence. Is that area
13	depicted in that photograph? A Yes.
14	Q And whereabouts in that photograph was that?
15	A Right here. That door.
16	THE COURT: You better show it to the jury.
17	BY THE PROSECUTOR:
18	Q Show it to the jury.
19	A That door right there.
20	THE COURT: Hold it up.
21	THE WITNESS: Right there.
22	THE COURT: Keep your voice up.
23	THE PROSECUTOR: Did everyone see it?
24	MR. BROWN: I guess everyone but ourselves,
25	your Honor.

1	Thank you.
2	BY THE PROSECUTOR:
3	Q What did you do after that?
4	A After I broke the padlock I went in.
5	Q Where did you go?
6	A Into the building.
7	Q And what did you do while you were in the
8	building? A I went through another
9	room to where there was a partition.
10	Q What kind of a partition?
11	A Fiberboard. It was easy to break through and I entered
12	the other part of the building where the offices were.
13	Q What did you do, there?
14	A I searched for money.
15	Q Did you find any?
16	A No. I noticed the safe and I realized they probably
17	kept the money in the safe.
18	Q Keep your noices up.
19	A I saw a safe in one of the offices. So, I realized they
20	probably kept the money in the safe and that there was no point
21	in continuing looking for the money. So, I left by the rear
22	door and came out onto Franklin Street.
23	THE PROSECUTOR: Will you step down again to S-3
24	in evidence.
25	(The witness steps down to the diagram.)

1	BY THE PROSECUTOR:
2	Q Whereabouts was that door which you came out?
3	A One of these two doors.
4	Q And where did you go from there?
5	A I walked out the driveway here and up here and got
6	back to the car.
7	THE PROSECUTOR: You may resume the stand
8	(The witness resumes the witness stand.)
9	BY THE PROSECUTOR:
10	Q What did you do after that?
11	A I drove to the Tiangle Grill Diner in Hawthorne.
12	Q Who was with you then?
13	A Sylvia Smith, Kellogg and myself had breakfast.
14	Q And where did you go from there?
15	A They dropped me off. I drove the car to my house
16	on Bell Avenue and I left the car there and I went home.
17	THE PROSECUTOR: I have no further
18	questions.
19	
20	
21	
22	
23	-i

1	MR. BROWN: Your Honor, of course at this
2	time we ask for any statements and his testimony.
3	THE PROSECUTOR: I have a statement here,
4	a four-page statement given by Mr. Bradley on
5	October the 14th of 1966. I have a statement
6	given on November the 18th of 1966 consisting
7	of one.page. I have Grand Jury testimony of
8	Mr. Bradley taken on October 31, 1966 consisting
9	of pages from the bottom of page 61 through page
10	83, and a copy of the police report of an oral
11	conversation with Mr. Bradley on October 6, 1966.
12	MR. BROWN: I have never seen these before,
13	your Honor.
14	THE COURT: There's no question about it.
15	You are entitled to have some time. Do you want
16	it now?
17	MR. BROWN: I would like to start and then
18	very shortly break off.
19	CROSS EXAMINATION
20	BY MR. BROWN:
21	Q Mr. Bello, I beg your pardon. Your partner is
22	Mr. Bello you are Mr. Bradley. You came into the area on
23	Franklin Street, didn't you?
24	A Yes.
25	Q And then as you have explained to Mr. Hull, you

came back later to roughly the same location, this factor;
that I am indicating, and broke in? A Yes.
Q And after that night was over, you didn't dis-
continue your career of breaking and entry, did you? You
continued, did you not? A Yes, sir.
THE PROSECUTOR: Objection.
THE COURT: Objection sustained. That
night I will permit it, anything beyond that
night I will not permit.
MR. Brown: If your Honor please, under
the very new rules they have allowed this to
go in.
THE COURT: Very well, the objection is
sustained.
MR. BROWN: Perhaps your Honor will allow
me to argue that point out of the presence of
the jury later before this interrogation ceases
THE COURT: Yes.
BY MR. BROWN:
Q Now, you have testified how you came down
Lafayette Street to approximately the area of the trees,
is that right? A Yes.
Q Ahead of you was a man who you couldn't
recognize, but whom you thought at that time was Bello?
A No.

Past him you saw two men, is that right? Q Yes. 3 Q And you immediately turned and ran? Yes. Now, how long after you immediately turned and ran did Bello, your partner, join you with the money? 7 I am not sure. About two or three minutes. 8 Q Less than two or three minutes? 9 Yes. 10 In the meantime you had gone back into the Q 11 same alley that you had use to come out into the street? 12 Yes. 13 Q And Mr. Bello came back into this alley and 14 found you there, is that correct? Yes. 15 Q How much money did he give you, Mr. Bradley? 16 Between \$40 and \$60 I am not sure. 17 It was \$62 to be precise, wasn't it? Q 18 A Yes. 19 It was \$62 to be exact, wasn't it? 20 I didn't count it then. 21 When you counted it, you found it to be \$62.00 22 A No, because I had spent some of it. exactly? 23 Well, how much had you spent before you counted 24 it? Maybe we can add it up? A few dollars.

And how much did you have after you counted it?

1	A I had some money of my own and it was with that.
2	Q Well, how much money had you had? Let us sub-
3	tract that? A I am not sure, about \$20.
4	Q About how much? A About \$20,
5	Q So, what you had left after you had spent money
6	was less than \$80, that is how you arrived at it, I suppose,
7	\$20 plus approximately \$60. That would be a fair statement?
8	A Yes.
9	Q Now, from the position that you occupied near
10	the tree you say you immediately saw these two Negroes, that
11	is the way you described them. You saw these two Negroes
12	and immediately ran away? A Yes.
13	Q Now, did you spin immediately and run as you
14	had described it? A As soon as I saw them I turned,
15	Q As soon as you saw them you turned. So, your
16	observation from this point down to near the corner was
17	limited as you described it, is that right? Because you
18	turned immediately and ran?
19	A Yes I did. I had looked at them long enough to know
20	who they were and then I turned.
21	Q I am asking you about this time when they turned
22	around the corner. Your testimony was that you saw these
23	two Negroes, you turned and ran? A Yes.
24	Q Alright. Now, and one Negro you said you
25	recognized? A Yes.

You had seen him on television I assume? I saw him in magazines and I had saw him once on 3 12th Avenue in Paterson. On what, sir? 12th Avenue in Paterson. 5 12th Avenue? Yes. 6 You call it 12th Av? 7 Yes. I was in a car with a friend of mine and he 8 pointed him out to me. 9 And you rode by him then? Yes. 10 Now, how long prior to this night on the 17th of 11 June had you seen Mr. Carter? 12 About in February. I saw him in a magazine. 13 You saw him in a magazine in February? 14 A Yes. 15 As far as in person when did you see him? 16 I saw him that same night. 17 My question is, prior means before, how long 18 before June 17th had you seen Mr. Carter in the flesh? 19 A In '64. 20 Q 1964? 1964. 21 Q That would be two years prior to this event? 22 Yes. 23 Q And that was the occasion when you passed him in a car with a friend who said, "That's Rubin Carter", and 24

the other time was in February when you read about him in a

1	magazine? A Yes. I had seen his picture
2	quite often during that time.
3	Q So, in that flash you recognized him from his
4	pictures, by the flash, I mean you were immediately turning
5	and running away?
6	A No. I recognized him first when he went by in the
7	car on Lafayette Street.
8	Q That is when the car turned right with the four
9	Negroes in it? A Yes.
10	Q And went down Lafayette Street? A Yes.
11	Q And how long just before you saw him here had
12	you seen this car? Was it a matter of two or three minutes,
13	or how would you designate it? A I am not sure.
14	Q Well, would it be a question of minutes or a
15	half hour or what? A No, minutes.
16	Q It would be a question of minutes since you had
17	seen him go down here and you at the time were standing
18	across the street, is that right? A Yes.
19	Q And he was the driver of the car?
20	A Yes.
21	Q And from where you stood you said you were not
22	right up to the curb, were you? A No.
23	Q You were back in here somewhere? A Yes.
24	Q From where you wereyou were all the way back
25	where the X 1s? A No.

Halfway up? 1 0 2 About the corner of the building? 3 This corner? Yes. So from this corner of the building you could 5 see him and see the passenger? A Yes. I saw him. 6 Well, you described also that you saw something 7 in the car? 8 I saw three other people and something else. An object. 9 You said you saw an object between the knees of 10 the right front passenger, am I correct? Yes. 11 So from where you were here you could see between 12 the knees of the right front passenger? 13 An object? Yes. 14 You don't know what it was but it was -- how did 15 you describe it? A Long and thin. 16 Long and thin. And then in the back there were 17 two other males, were they Negroes as well? 18 I didn't say they were males. 19 Were they women? One I believe 20 was a woman. One you believe was a woman. I understood you 21 22 to say four men. No. I didn't say that. 23 THE COURT: He said four people. 24 BY MR. BROWN: 25 I epologize to you. In the rear was a woman

toward East 18th.

25

1 and a man? Yes. 2 Was the woman sitting nearest you or was the man 3 sitting nearest your side? 4 She was sitting on the passenger side, the far side 5 from me. 6 Q Now, you said, to the best of your estimation, 7 that it was a '54 Ford? No. 64. Q '64 Ford. And as they passed by you you could 8 9 tell us what speed they were traveling? Was it a normal 10 speed, 25 or 30, or slower? 11 Slower. Between 15 and 20 miles an hour. 12 Between 15 and 20 miles an hour you would 13 estimate they went by here. Now, that was the only occasion 14 that you saw the car turning the corner, is that right? 15 I didn't say I saw it turning the corner. I said it 16 might have come straight down Lafayette or from East 16th. 17 It could have come straight down or could have 18 come up from 16th Street in this direction? Yes. 19 Now, when you left this position and raced back 20 you say it was a matter of two or three minutes before Bello 21 came with the money? Yes. 22 What did Bello do immediatrly after he gave you 23 the money? 24 He left and started walking down Lafayette Street

1 He walked down toward East 18th Street? Q 2 Yes. 3 And that is when you left the grea? 4 Yes. 5 Q And you went around and ultimately contacted 6 Kellogg over here, is that right? I didn't see Kellogg. I didn't contact him. I saw his 7 A 8 car. 9 Q You didn't stop him? No. 10 He just kept going? Yes. 11 Q Where were you when you saw his car? 12 Right here where we had parked the car previously. 13 Yes. You were up there earlier? 14 So when he passed here, you couldn't hail him? 15 Is that correct? A 16 Q Now, this chart indicates, Mr. Bradley, that 17 the entire length of this street is about 457 feet. 18 Yes. 19 Q You say you were approximately where these trees 20 are, that is the circular area in from 257, is that right? 21 Yes. 22 Q And these men came around the corner and then you 23 broke and ran. Did you see anything else in this area in 24 Lafayette Street at the time you broke and ran after seeing 25 these two Negroes? A Where, on the sidewalk or

- 1 in the street?
- 2 Q Anywhere. Anywhere at all.
- 3 A No, I couldn't remember.
- 4 Q For example, you were looking here and in that
 - 5 flash before you turned in this area you don't remember
 - 6 seeing smything? A No.

 - 8 person you were following was Bello?
 - 9 A I wasn't sure and I didn't want to call out and
 - 10 arouse any suspicion. So, I thought I could catch up to
 - 11 him before he got to the bar if it was him.
 - 12 Q He wasn't doing anything wrong inwalking down
 - 13 the street? A No. But I was.
 - 14 Q What were you doing wrong in walking down the
 - 15 street?
 - 16 A I wasn't doing anything wrong in walking down the
 - 17 street. I was there for the purpose of breaking into a
 - 18 place.
 - 19 Q And you wanted to preserve a lack of notice,
 - 20 is that right? A Yes.
 - 21 Q That is why you wore the black suit?
 - 22 A Black sweater and dungarees.
 - 23 Q The black sweater and dungarees. And you
 - 24 described everything you had on as black, right?
 - 25 A Yes.

1	Q And when the car you first observed came by
2	you had hidden your head up in here so you couldn't be seen?
3	THE COURT: That was when?
4	THE WITNESS: I was in front of the building.
5	BY MR. BROWN:
6	Q When you were in front of the building you said
7	you hid your face and everything so you couldn't possibly
8	be seen. Was this dark clothing your normal attire for
9	breaking and entering?
10	THE PROSECUTOR: Objection.
11	THE COURT: Objection sustained.
12	MR. EROWN: May I have his record?
1.3	Well, you do have a long series of breaking
14	and entries, don't you?
15	THE PROSECUTOR: Objection.
16	THE COURT: Onjection is sustained.
17	MR. BROWN: I will read each one.
18	THE COURT: But only read on specific items
19	of conviction.
20	Hand Mr. Brown the indictment.
21	BY MR. BROWN:
22	Q Do you recall having pleaded guilty on October
23	26th, 1962 to an indictment which charged with having on the
24	18th of August, 1962, in the City Of Clifton, in the County
25	of Passaic aforesaid, and within the jurisdiction of this

Yes, I remember it.

Do you remember having been charged and pleading guilty to--I'm sorry, your Honor. That was a confederate, and not his. Do you recall having been sentenced on the 30th day of October, 1964, to Bordentown Reformatory for the following crime in that you did wilfully and maliciously and feloniously break and enter into the building of Dover Club Inc., 62 Dover Street, Paterson, New Jersey a corporation there situate, with intent then and there feloniously 14 to steal, take and carry away the money, goods and chattels of the said corporation in the said building, and the Grand Jurors aforesaid, upon their oath aforesaid, do present that the said Arthur D. Bradley, at the time and place aforesaid and within the jurisdiction of this Court, feloniously did steal, take and carry away money to the amount and value of \$500.00. 3 bottles of whiskey of the value of \$12.00 and 1 carton of cigarettes of the value of \$3.00. Do you remember 22 pleading to that and being sentenced? Yes.

Do you recall having been sentenced on October 30th, 1964 to Bordentown Reformatory on a sentence of breaking and entry and larceny? Yes.

1	Q And do you recall with respect to at Bergen
2	County having been sentenced on April 12th, 1965 on two counts
3	of breaking and entry and larceny? A Yes.
4	Q And those totaled up to approximately six, is
5	that right? That you can recall it, Mr. Bradley?
6	A Yes.
7	Q And for those offenses you were sentenced to
8	Bordentown Reformatory, is that right? A Yes.
9	Q Now, when did you obtain your release from
10	Bordentown Reformatory after the sentence of 1964?
11	A March 11, 1966.
12	Q That was three months prior to this event of
13	June 17th? A Yes.
14	Q And did you return home, then? A Yes.
15	Q And subsequently in December of 1966 were you
16	returned to Bordentown for a violation of your parole?
17	A Yes.
18	Q And was this violation of your parole because
19	of several armed robberies that you had committed?
20	THE PROSECUTOR: Objection.
21	THE COURT: Objection sustained.
22	THE WITNESS: No.
23	MR. BROWN: If your Honor please, the rule
24	provides that where it goes to the question of
25	his honosty. I submit this conlemation in

1	evidence as proper.
2	THE COURT: The rules do not provide that.
3	I sustain the objection.
4	MR. BROWN: May I at this time your Honor
5	have a break which would be necessary to prepare
6	for continued cross-examination.
7	THE COURT: Alright, ladies and gentlemme,
8	counsel is entitled to review these documents
9	before continuing his cross-examination.
10	We will therefore have to take a recess
11	for that purpose.
12	We will call you ladies and gentlemen when
13	we are ready.
14	(A recess is taken.)
15	MR. BROWN: Thank you for the time, your
16	Honor.
17	(The jury is returned to the Courtroom.)
18	(Arthur Bradley being previously sworn
19	resumes the witness stand.)
20	CONTINUATION OF CROSS-EXAMINATION
21	BY MR. BROWN:
22	Q Mr. Bradley, the first time you told the police
23	anything about this was inOctober 1966, is that right?
24	A Yes.
25	O And they came down to Bordentown and talked to

1	you about it? A Yes.
2	Q You didn't tell them amything even them, did
3	you? A No.
4	Q And finally after three statements they got a
5	complete story as you wished to tell it, is that right?
6	A I gave them two statements.
7	Q Well, you signed a statement on October 14th,
8	1966, a statement on November 18th, 1966, and on October 6,
9	1966 was the first time that you talked to the officers at
10	Bordentown?
11	THE COURT: That wasn't a written statement?
12	THE WITNESS: That wesn't signed.
13	BY MR. BROWN:
14	Q Did you give them an oral statement?
15	A Yes.
16	Q This was the first occasion on which you spoke
17	to them, is that right? A Yes.
18	Q So, it was on three separate occasions, whether
19	written or spoken that they talked to you before the full
20	story came out, is that right? A Yes.
21	Q And the fact is that it wasn't until November
22	18th that you admitted coming back and eventually breaking
23	into the place and actually going to the place and actually
24	going to the safe, is that right?

When I gave them my statement in front of the Grand

- 1 Jury, I thought I was giving them the whole truth.
- THE COURT: We are talking about November
- 3 18th written statement.
- 4 BY MR. BROWN:
- 5 Q You see your signature at the bottom?
- 6 A Yes.
- 7 Q It was not until November 18th, a written
- 8 statement that you finally told the police about your part
- 9 in actually coming back and breaking in that factory?
- 10 A Right.
- 11 Q And the reason you gave was that nobody asked
- 12 you, right? A Yes, that is true. There was no
- 13 mention of a break there. I felt that wasn't part of my
- 14 first statement.
- 15 Q So, you didn't tell them what happened because
- 16 as you said, no one asked you, is that right?
- 17 A No. It wasn't because of that.
- 18 Q Well, let me read what you said, "Why didn't
- 19 you mention this in your earlier statement or in your
- 20 testimony before the Grand Jury?" Referring to your breaking
- 21 into the Ace Metal Building. Your answer was, "No one had
- 22 asked me about what happened after I left the area in the
- 23 taxi, and Detective Sargeant Mohl had told me there was no
- 24 break reported." A Yes.
- 25 Q "So, I saw no point in mentioning it." That

- Bradley-Cross is the real reason that you didn't tell him, isn't it? 1 2 Yes. 3 Q Then you didn't tell him because you didn't 4 think it was a part of the evenings' adventure, you didn't 5 tell him because you say here specifically you didn't think 6 they knew it? Right. 7 Now, you have also described for the Grand 8 Jury, to some extent, what Mr. Bello was wearing that night, 9 can you tell us what he was wearing that night? 10 I didn't describe that. 11 Well, didn't you say he was wearing a three-12 quarter length coat or something of that kind? No, I am not sure. 13 14 You are not sure about that? No. 15 But in any event you had been with him since 16 early evening, had you not? Yes. And you had been with Kenny Kellogg long since 17 18 early afternoon? Yes. 19 And Kellogg and the girlfriend knew what you 20 were planning to do? THE COURT: If you know? Did they know 21 22 what you planned? 23 THE WITNESS: I amnot sure.
- 24 BY MR. BROWN:
- 25 Q You're not sure. You're not sure of what you

1 of what you told the Grand Jury? A Yes, I am sure. 2 Q What did you tell the Grand Jury? 3 We went back that second time. 4 Sir. The afternoon of the 16th before you went 5 to the area of 16th and Lafayette to break in a factory. 6 THE COURT: Was the question what he told 7 the Grand Jury or what? 8 MR. BROWN: I will withdraw it, your Honor. 9 BY MR. BROWN: 10 Is it a fact or not that you and Kenny Kellogg 11 and the girl, have discussed this on that afternoon, this 12 meaning a breaking and entry of that factory? 13 No. The girl wasn't involved until later that night. 14 Q She was not present in the afternoon, is that I don't remember. 15 correct? 16 You are sure of that? You don't remember? Q 17 Right. A 13 Now, but it was later in the evening that Bello 19 came by and you told him that you had intended to do that. 20 is that right? 21 I mentioned to the Grand Jury that I --22 I asked you, sir. Well--23 MR. BROWN: I ask that it be stricken, 24 your Honor.

THE COURT: That will at the moment. Yes.

1	Just tell us whether you told Bello about
2	it or not.
3	THE WITNESS: He knew I wanted to break
4	into a place. He didn't exactly know the
5	location.
6	MR. BROWN: Now I ask that be stricken,
7	your Honor.
8	THE COURT: No, it will stand. That is
9	an answer to your question.
10	BY MR. BROWN:
11	Q Let me ask you about this place. When did you
12	first tell Bello you were going to break into it?
13	A I am not sure if it was in the afternoon or on the
14	way to it.
15	MR. STEIN: I couldn't hear any of that,
16	sir.
17	THE WITNESS: I am not sure if it was in
18	the apartment or on the way to it.
19	BY 'IR. BROWN:
20	Q But you had been planning this for some time
21	because you had inside information, is that correct?
22	A Yes.
23	Q And you either told him at the apartment or
24	on the way there? A Yes.
25	O Who was driving the new that you say helonged

1	to Kellogg?
2	THE COURT: At what time.
3	MR. BROWN: I withdraw that.
4	BY MR. BROWN:
5	Q When you left the apartment going to this area
6	where you planned to break into the factory, who was driving
7	the automobile in which you rode?
8	A The first time?
9	Q The time when you left the apartment and came
10	to the area which is described as Lafayette and Franklin
11	Street. Who drove the car belonging to Kellogg?
12	A I am not sure. I believe it was Kellogg because I
13	drove his car for him all summer.
14	Q You believe it was Kellogg, is that right?
15	A Yes.
16	Q You are not sure about that, but you believe it
17	was Kellogg who drove, is that so?
18	THE COURT: Is this the first time or the
19	second time?
20	MR. BROWN: The first time, your Honor.
21	Prior to the tentative breaking and entering.
22	THE COURT: Alright. Before you started
23	to work on the door of the Ace Metal Factory do
24	you know who was driving the car when you arrived
25	at Franklin Street?

- 1 THE WITNESS: I think I was driving at
- 2 that time.
- 3 BY MR. BROWN:
- 4 Q Well, which is it? Was it Kellogg or you?
 - 5 A As I said before, I can't remember that but, I think
 - 6 it was me, because I have been driving for him for about a
 - 7 month.
 - 8 Q You had been driving the car all the time, hadn't you?
 - 9 A Yes.
 - 10 Q And Kellogg did not drive on that night when you
 - 11 were in the car, did he?
 - 12 A I gave a definite answer to that.
 - 13 Q You know, however, that Kellogg went to the
 - 14 Lafayette Bar & Grill that night?
 - 15 THE COURT: As of when?
 - 16 BY MR. BROWN:
 - 17 Q Well, what time did you park the car on Franklin
 - 18 Street after you arrived in that neighborhood when you and
 - 19 Bello went to break in the factory? About what time was that?
 - 20 A I would say it was around two o'clock.
 - 21 Q Between two and two thirty, is it not a fact that
 - 22 you know that Kellogg went to the Lafayette Bar & Grill?
 - 23 A I had told him he could wait for us in that bar.
 - 24 Q Excuse me?
 - 25 A Kellogg didn't want to be involved in the breaking and

1	entry. So, I had told him he could wait in the bar.
2	Q The Lafayette Bar and Grill? A Yes.
3	Q And he told you he did so?
4	THE COURT: You mean in advance or after-
5	wards?
6	THE WITNESS: Well, when he left
7	MR. BROWN: If your Honor please, at any
8	time.
9	THE COURT: Well, let us get the questions
10	which have some meaning and significance.
11	MR. BROWN: This question has meaning and
12	significance, your Honor.
13	THE COURT: I want to know whether you are
14	askingjust a minute please, I don't like to be
1.5	interrupted, Mr. Brown. I am trying to find out
16	whether you are asking whether Kellogg said that
17	he intended to go to the Lafayette Bar & Grill
18	or whether he told him afterwards that he had
19	been at the Lafayette Bar & Grill.
20	BY MR. BROWN:
21	Q Did you learn that Kellogg went to the Lafayette
22	Bar & Grill at two o'clock? A Yes.
23	Q And you know that he was in the bar & grill between
24	two and two thirty? You learned that, did you not?
00	A

Q

1	Q Had you also learned that Bello had been in that
2	bar & grill from time to time, not necessarily on this night?
3	A Would you repeat that, please?
4	Q Yes, sir. Except for this night, on other nights,
5	prior to, you knew that Bello had been in there from time to
6	time, is that correct? A Yes.
7	Q Now, on this night when you went down the street
8	and you saw the man who you have described coming around the
9	corner, it was actually within a minute that Mr. Bello came
10	back with the money for you, isn't that a fact?
11	A Within a minute? Yes, sir.
12	Q After you turned and ran Bello came to you within
13	a minute with money. Do you understand the time I am talking
14	about? A Yes.
15	Q This is the time when you say you walked down
16	the street. Suddenly you saw two colored fellows. You spun
17	and ran, is that correct? Was it not within a minute that
18	Bello came back to you with the money?
19	A It was more than a minute.
20	Q Let me show you your statement, sir, on the 14th
21	of October, is that your signature? A Yes.
22	Q On page two are the statements. "As soon as I
23	saw that I ran back a couple of houses in the shadow and in
24	one of the alleyways there you follow me? A Yes

"I am not actually sure what happened in the

- 1 next few seconds but I remember within a minute after I saw
- 2 the colored guys, Bello ram up to me and handed me money."
- 3 Is that correct?
- 4 A Yes, that is correct. I wasn't actually sure of the
- 5 time, then.
- 6 Q This was in October. But you now state it, is that
- 7 correct?
- 8 A I used that as a figure of speech. It was a very
- 9 short time.
- 10 Q You used a minute as a figure of speech?
- 11 A Yes.
- 12 Q Did you also use as a figure of speech, "I'm
- 13 not actually sure what happened in the next few seconds, but
- 14 I remember within a minute." Was that a figure of speech or
- 15 were you using seconds and minutes in an intelligent appraisel?
- 16 A Yes.
- 17 THE COURT: Which is it?
- 18 THE WITNESS: No, I was just -- I was
- 19 generalizing there.
- 20 BY MR. BROWN:
- 21 Q You were generalizing? A Yes.
- 22 Q Tell the jury how long it was before?
- 23 A It was two minutes.
- 24 Q Two minutes. We now have two minutes.
- 25 A I can't exactly give an exact time.

1	Q I thought you said two minutes?
2	THE COURT: He did, but he can't give it
3	exactly.
4	BY MR. BROWN:
5	Q And the fact is that as you told us you are not
6	even sure that man you were following down the street was
7	Bello, is that correct? A Right.
8	Q Because you couldn't identify him and you can't
9	say that. At this time you can't identify that person you
10	were following as Bello, correct? A No.
11	Q Now, as I understand it, sir, the point we are
12	talking about is when you reached this clump of trees, there
13	was a man about 20 feet in front of you, is that correct?
14	A Yes.
15	Q And you couldn't identify that man as Bello,
16	right? A No, I wasn't really sure.
17	Q Although you had been with him since early
18	evening, you had known him for how long? A A few hours.
19	Q You only knew Bello for a few hours?
20	A No, I have known him a long time.
21	Q You have known him a long time, but although you
22	couldn't recognize the man 20 feet in front of you, a man
23	coming around the corner who you had seen in a magazine and
24	once in 1964 you recognized in a flash, is that right?
25	THE PROSECUTOR: Objection.

- 1 MR. BROWN: Is that correct?
- THE COURT: Objection overruled,
- 3 BY MR. BROWN:
- 4 Q Is that correct?
 - 5 A I was pretty sure that was Bello. I just didn't want
 - 6 to call him.
 - 7 Q As you just said you couldn't identify him?
 - 8 A I know.
 - 9 Q But you could identify this chap coming around
 - 10 the corner?
 - 11 A Yes. I had been looking at different houses as I was
 - 12 walking toward, running toward him.
 - 13 Q You had been running toward different houses?
 - 14 A I was running down the street to catch him before he
 - 15 got to the bar.
 - 16 Q Yes. I understand that. And, therefore, you
 - 17 were concentrating on him or looking at him because that
 - 18 is the man you are trying to catch?
 - 19 A I realized--
 - 20 Q My only question to you is this. Isn't that a
 - 21 fact that you were specially noticing this figure that you
 - 22 couldn't identify because that is the figure you are trying
 - 23 to catch, correct?
 - 24 A He was walking close to the building.
 - 25 MR. BROWN: I ask that be stricken.

1	THE WITNESS: He was in the shadows.
2	MR. BROWN: I ask that be stricken, that is
3	not my question.
4	BY MR. BROWN:
5	Q My question is that this was the person you were
6	trying to catch and therefore concentrating on in your chase?
7	A Yes.
8	Q Alright. And you weren't looking for the
9	other two people coming around the corner? A No.
10	Q That was just unexpected, right? A Yes
11	Q But you recognized the man you had seen once in
12	1964 and once in a magazine, but you couldn't recognize Bello
13	THE COURT: That is only a statement. Don't
14	answer it.
15	MR. BROWN: It is a fact.
16	THE COURT: You have asked that question.
17	It has been answered.
18	BY MR. BROWN:
19	Q It is a fact that you then spun around and came
20	back? A Yes.
21	Q And it is a fact that you went all the way back
22	up into here near the corner of this house, that is the way
23	you described it? A Yes.
24	Q And is it a fact within now what you call two
25	minutes, although in your statement you said one minute,

- Bello came back with the money?
- 2 A I shouldn't have used an exact amount of time because
- 3 it was a very short time. It could have been in as much as
- 4 three or four minutes.
 - 5 Q You also identified a car for Mr. Hull, didn't
 - 6 you? A Yes.
- 7 Q I show you a car that you said was similar to
- B the 1964 white Ford you talked about, is that right?
- 9 A Yes.
- 10 Q No, that photograph was shown to you on October
- 11 14th by one of the officers, wasn't it? A Yes.
- 12 Q And you were told that that was the car used by
- 13 Rubin Carter, weren't you? Weren't you told that?
- 14 A No.
- 15 Q You were not told that Rubin Carter had rented
- 16 this car?
- 17 THE COURT: He said no.
- 18 MR. BROWN: I have changed the question,
- 19 your Honor.
- 20 BY MR. BROWN:
- 21 Q You were not told that that was the car rented
- 22 by Rubin Carter?
- 23 A I was shown -- I imagine it was the same picture I was
- 24 shown that this was the car.
- 25 MR. BROWN: I ask that it be stricken. That

1	is not responsive to my question.
2	THE COURT: Yes. It will be stricken.
3	The question is whether you were told that
4	this was the car that Rubin Carter had rented.
5	I am talking about by the police.
6	THE WITNESS: Yes.
7	BY MR. BROWN:
8	Q As a matter of fact they advised you that
9	specifically while showing you that photo, didn't they?
10	Is that correct?
11	A They said it was a car similar to that or it could
12	have been the same one.
13	Q Let me ask you this. If this is not a fact that
14	they advised you of that as they showed it to you. This is
15	on page of the statement that you signed. Is that right?
16	This question. You stated in answer to a previous question
17	that the car you saw appeared to be a white 64 Ford, is
18	that correct as you read it? I now show you a photograph
19	which I have marked S-4 and I assume that was Lt. DeSimone's
20	photographs, is that correct? A Yes.
21	Q He said, "I now show you a photograph which I
22	have marked S-7 and advise you that this was a '66 Dodge
23	which was rented by Rubin Carter on or about June17, 1966."
24	Is that correct? A Yes.
00	

1	Q And then he continued. "I ask you to look at
2	this photograph and tell me if there's any similarity between
3	this photo and the car you saw on that night?" Is that
4	correct? A Yes.
5	Q And then your full answer, "They looked like
6	the same car and if you were to ask me now without telling
7	me it would look like a '64 Ford to me." Now, is that your
8	answer? A Yes.
9	Q Is that the way it happened? A Yes.
10	Q So that when that car was shown to you, you
11	were in fact told this is the car that Rubin Carter rented?
12	That was taken on October 14th? A Yes.
13	Q That is correct? Alright.
14	Q Do you have a question about that?
15	THE COURT: Let us not get involved in his
16	questioning you.
17	BY MR. BROWN:
18	Q October 14th?
19	A No. I just said I wasn't sure.
20	Q You weren't sure. You didn't tell the complete
21	truth on October 14th. It was later on that you came through
22	with other factors?
23	THE PROSECUTOR: Objection.
24	THE COURT: Objection sustained.
25	We are not concerned with specifics, Mr. Brown.

	1	BY MR. BROWN:
	2	Q You also had a gun on that date, did you not?
	3	THE COURT: What date?
)	4	MR. BROWN: June 17th, your Honor, 1966.
	5	THE WITNESS: No.
	6	BY MR. BROWN:
	7	Q You did not? A No.
	8	Q When did you possess a .32 caliber pistol?
	9	THE PROSECUTOR: Objection.
	10	MR. BROWN: Within the summer of 1966.
	11	THE COURT: Objection overruled.
	12	BY MR. BROWN:
	13	Q Well, did you tell the Grand Jury that you had
	14	a .32 caliber pistol?
	15	THE PROSECUTOR: Objection.
	16	THE COURT: Objection sustained.
	17	BY MR. BROWN:
	18	Q Did you tell the Grand Jury that you had
	19	acquaintance with a shotgun, your father's shotgun?
	20	THE PROSECUTOR: Objection .
	21	THE COURT: Objection sustained. The jury
	22	will be instructed that theyr's statements of
,	23	counsel and a question do not constitute evidence
	24	and it is not to be considered as a fact, The
	25	facts come from relineague arrows to testify to

1	the truth.
2	BY MR. BROWN:
3	Q Do you remember this question asked to you by
4	the Grand Jury when you testified in October of 1966? Did
5	you so testify? A Yes.
6	Q "Do you have any acquaintance with guns?" Your
7	answer was, "Yes."
8	THE PROSECUTOR: Objection.
9	THE COURT: Mr. Brown, you know that is
10	wholly improper.
11	MR. BROWN: Why, your Honor?
12	THE COURT: Because the Court has just
13	ruled that it is improper and you are trying to
14	do it again in another manner and therefore the
15	objection is sustained.
16	Now, I have cautioned you. You are not to

- 6 Q Now, you also don't know what was in your hand
- 7 when you decided to go down toward the corner on East 18th
- 8 and Lafayette at the time when you saw the Negroes and
- 9 turned and ran. You had that thing in your hand previous
- 10 to that? A Yes.
- 11 Q And you dropped it somewhere, is that correct?
- 12 A Ah-hum.
- 13 Q And did you subsequently recover it?
- 14 A Yes.
- 15 Q That is when you went back after getting the
- 16 money from Bello, is that right?
- 17 A No. I don't remember if I had it then.
- 18 Q You don't remember if you had it then?
- 19 A If I did have it, once I saw that his car was gone I
- 20 threw it away.
- 21 Q Now, you told us that you came down toward
- 22 Lafayette Bar & Grill because you were breaking into a
- 23 building over on 16th Street and you decided to go through
- 24 this alley that you traced to the corner of the building,
- 25 is that right? A Yes.

Q Now, you left -- I am pointing to the factory. Is 1 2 this the correct location? And you went down the alley and out here for 3 4 what purpose? The first time? 5 Yes, the first time just before you went down 6 the street? I wanted to see if possibly a police car was coming 7 8 up that way. 9 This way? Q Yes. 10 Well, you hadn't seen any police car, had you? O 11 No. 12 You were actually breaking and entering around Q 13 here? 14 Yes, but I realized that someone might have called the 15 cops and they could come from up Lafayette Street. 16 Q You realized that someone might have called the 17 cops and they would have been coming up Lafayette Street? 18 Yes. Q Why anymore likely than they would be coming 19 20 up East 16th Street. 21 It is no -- they could have come either way, but Bello 22 was on the corner of East 16th and Franklin Street. 23 He was on the corner? Of East 16th and Franklin. 24

- 13 come out of the bar, did you or did you not?
- 14 A I don't remember that.
- 15 Q You don't remember. Page 29 of your Grand Jury
- 16 testimony on October 26th. "So, I was maybe 20 feet behind
- 17 him." That was Bello, wasn't it? A Yes.
- 18 Q "I was just ready to call his name. You know.
- 19 I was enraged to call him and these two colored guys came
- 20 out from the bar." Did you say that to the Grand Jury? It
- 21 is printed there. A Yes.
- 22 Q Then you said, "I don't know what door they came
- 23 out of. They could have come out of either door from where
- 24 I was." Was that right? A Ah-hmm.
- 25 Q So, is it a fact, that you didn't see anybody

1	come out of the bar and you just told the Grand Jury this
2	because it was the most likely place, is that right?
3	A Yes.
4	Q Is that right? A Ah-hmm.
5	Q And then by the same token you told the Grand
6	Jury to finish your answer, "One was Rubin Carter." You told

10	THE COURT: What is that, just a minute?
11	The reporter will read back the question.
12	(The question is read by the Court Reporter.)
1.3	THE PROSECUTOR: Objection.
14	THE COURT: I know and that is exactly why
15	I had it read. He said he saw Rubin Carter in
16	this Courtroom, and he said he saw Rubin Carter
17	before the Grand Jury. The jury will disregard
18	the subsequent comment by counsel made after the
19	answer.
20	BY MR. BROWN:
21	Q And you finished your answer by saying, "The
22	other looked very similar to John Artis", is that right?
23	A Is that what is printed there?

1	THE PROSECUTOR: Your Honor, four words
2	were left out of that answer in that paragraph.
3	MR. BROWN: Which ones.
4	THE COURT: Read the entire answer, please.
5	MR. BROWN: "One was Rubin Carter." That
6	was not left out. That was what your Honor
7	complained of, I added to it.
8	THE COURT: Alright, now we have the
9	whole answer.
10	MR. BROWN: That is what I said. "One was
11	Rubin Carter." That certainly can't be contested.
12	BY MR. BROWN:
13	Q Now, after you had given that kind of answer,
14	you then continued and you testified later on, did you no,
15	that with respect to the car in question, to wit, a Dodge,
16	with respect to the question, 'Were there any cars there,
17	then." That is a question before you, isn't it? And your
18	answer there was, "A lot of cars. I saw a car that looked
19	like the one I had seen go by before." Is that correct?
20	A Ah-hmm.
21	Q "A white car?"
22	Your answer was, "Yes. It looked to me like a
23	'64 Ford, but I was told it was a '66 Dodge and they resemble
24	each other to me." Is that correct? A Ah-hmm.
25	Q That is what you further told the Grand Jury

1	is that right? A Yes.
2	Q Now, when you returned to Bordentown on September
3	12th, 1966, you had been sent there for crimes not connecte
4	with this case, is that right?
5	THE PROSECUTOR: Objection.
6	THE COURT: Objection sustained.
7	BY MR. BROWN:
8	Q Why had you been returned to Bordentown in
9	September 12th, 1966?
10	THE PROSECUTOR: Objection.
11	THE COURT: We already went through the
12	sentence. That has no revelency. The objection
13	is sustained.
14	MR. BROWN: This is something that follows
15	the sentencing, your Honor.
16	THE COURT: Whether it follows it or not
17	doesn't dictate it's revelency. I don't see
18	it's revelency at the present time. I will
19	sustain the objection.
20	MR. BROWN: I will call to your Honor's
21	attention that the State brought it out and
22	referred to it on the direct testimony. Your
23	Honor might change the ruling.
24	THE COURT: Alright, I will still stick
25	with my ruling.

1	Continue.
2	BY MR. BROWN:
3	Q Now, when you were questioned on October 6th
4	in Bordentown Reformatory concerning the Lafayette Bar & Grilla
5	you were questioned by Sgt. Kliker and Det. Sgt. Mohl, is
6	that correct? A Yes.
7	Q When they questioned you in the first instance,
8	is it not a fact that they told you what Bello had said and
9	that you confirmed it? A No.
10	Q I show you a statement which is not signed by
11	you, but represents the conversation.
12	THE COURT: Therefore, do not show it to
13	him. Ask him a direct question as to what he
14	said.
15	BY MR. BROWN:
16	Q Did you, sir, confirm the story told to these
17	officers by Alfred Bello as to their actions that morning and
18	also said that Bello did give him some money that he took
19	from the cash register of the Lafayette Bar & Grill, this
20	being about \$45?
21	THE PROSECUTOR: Objection.
22	THE COURT: Objection sustained. It is too
23	general a nature. You will have to ask specific
24	questions.
25	BY MR. BROWN:

1	Q Well, it is a fact, is it not, that until these
2	officers came down to you on October 6, 1966 you hadn't
3	said anything to any officials about this matter, is that
4	right? A Yes.
5	Q You had not admitted that you had received this
6	money which you learned was stolen from the cash register
7	of the bar? You learned that, didn't you? A Yes.
8	Q And you hadn't told them about that? A Yes
9	Q Is that correct? And you had not told about
10	the fact of your breaking and entering, either by an attempt
11	or success in that factory, that is so isn't it?
12	A Yes.
13	Q Do you recall being held in the County Jail in
14	this County in August of 1966?
15	THE PROSECUTOR: Objection.
16	THE COURT: Yes.
17	Well, it is leading.
18	Objection overruled.
19	BY MR. BROWN;
20	Q Do you recall telling an inmate named Martinez
21	that you are going to play the Carter case off against
22	charges against you so that you would get the benefit of it?
23	A No.
24	Q You do not. You did not make that statement?
25	A No.

1	MR. BROWN: I have no further questions,
2	your Honor.
3	THE COURT: Alright, Mr. Stein.
4	CROSS-EXAMINATION
5	BY MR. STEIN
6	Q Mr. Bradley, after you saw these two men and
7	ran up the street, you went into the alley, is that correct?
8	A Yes.
9	Q And you waited in that alley until such a time
10	until Bello came there with money, is that right?
11	Λ Yes.
12	Q During that time did you see any car go by?
13	A No.
14	Q You did not. Now, when you were in the alleycould
15	you come down here and indicate to us just where you were
16	located?
17	(The witness steps down to the diagram.)
18	THE COURT: Do you want to orient us Mr.
19	Stein as to which time you recall he was in
20	the alleyway?
21	MR. STEIN: Yes.
22	BY MR. STEIN:
23	Q Mr. Bradley, do you understand what I'm talking
24	about?
25	THE COURT: I want to understand also.

1	tell me.
2	MR. STEIN: I will run through it. The
3	reference I am making to you, sir, is after Mr
4	Bradley ran up Lafayette Street and waited til
5	Mr. Bello got there.
6	THE COURT: When he came with the money?
7	MR. STEIN: Yes.
8	BY MR. STEIN:
9	Q Do you understand that? A Yes.
10	Q Tell us where you were located/
11	A Right in the opening, here. Right in the corner.
12	Q Now, could you indicate where you were located
13	sir? Mark it with that red pencil.
14	(The witness complies.)
15	THE COURT: That is indicating a cross at
16	the rear, I would say, of the building located
17	on the corner of East 16th and Lafayette.
18	Is that correct?
19	A What is that, sir?
20	THE COURT: The cross indicated the area
21	in the rear of the building which is on the
22	corner of 16th and Lafayette?
23	THE WITNESS: Yes.
24	BY MR. STEIN:
25	O Now, you were. I believeyou did not hear any

- 1 car coming up that street, did you, sir?
- 2 A I can't give you a definite answer about that because
- 3 I am not sure.
- MR. STEIN: You may take your seat if you
 - 5 want to.
 - 6 (The witness regumes the witness stand.)
 - 7 BY MR. STEIN:
 - 8 Q When you say you are not sure, do you mean you
 - 9 can't recollect whether you heard any, is that what you
 - 10 mean? A Yes.
 - 11 Q From the point that you turned around and
 - 12 started to run up Lafayette Street until you got into the
 - 13 alley, how long did that take you? Can you recall?
 - 14 A I am not too sure. As long as it would take to run
 - 15 that distance.
 - 16 Q And you were running as fast as you could?
 - 17 A Yes.
 - 13 Q And as you ran up the street, no car passed, did
 - 19 it? A I can't give a definite answer on that,
 - 20 I am not sure.
 - THE COURT: Will you keep your voice up.
 - 21 BY MR. STEIN:
 - 22 Q I did not hear the last answer.
 - 23 A I am not sure. I can't give a definite answer to that.
 - Q Now, when there was a man ahead of you-when you

1 were walking behind somebody -- I am going to take you back 2 to the time you were walking down Lafayette Street toward 3 East 18th Street. Could you describe anything about the 4 physical characteristics of the man directly in front of 5 you or anything of the clothing he was wearing at that time? 6 He was short and stocky. He was walking down the 7 sidewalk on the inside of the sidewalk more in the shadows. 8 Q He was about 20 feet in front of you? 9 THE COURT: Let us get the end of the answer. 10 You asked also about how he was dressed. 11 THE WITNESS: Yes. He had a dark shirt on 12 and dungarees. 13 BY MR. STEIN: 14 Which was what Mr. Bello was wearing, is that 15 right? Ah-hma. 16 And this man in front of you, did he have on 17 a high heel which was a little higher than ordinary street 18 heel which could perhaps be like a cuban heel? 19 I am not sure. 20 THE COURT: What was that? 21 THE WITNESS: I am not sure of that. 22 BY MR. STEIN: 23 Do you know if Bello, that night was wearing 24 that type of a heel? I don't remember. 25 Do you remember that on that night mr. Bello

- 1 had what you would describe as rather long hair?
- 2 A No. He may have needed a haircut. His hair wasn't
- 3 that long.
- 4 MR. STEIN: I have nothing further.
- 5 MR. BROWN: I have just one or two, your
- 6 Honor. I will be very brief.
- 7 CONTINUATION OF CROSS EXAMINATION
- 8 BY MR. BROWN:
- 9 Q You do know a man named Martinez, Hector?
- 10 A Yes.
- 11 Q He was in jail with you on August 3, 1966?
- 12 A Yes.
- 13 Q In the Passaic County Jail? A Yes.
- 14 Q Now, when you took the money from Bello, did
- 15 you ever ask him where he got it?
- 16 A Not right away.
- 17 Q The question is, did you sir, did you ever ask
- 18 him where he got the money?
- 19 THE COURT: Ever?
- 20 THE WITNESS: Yes.
- 21 BY MR. BROWN:
- 22 Q And what did he tell you? I withdraw the
- 23 question. Isn't it a fact that he told you that he saw some
- 24 money, picked it up and ran and gave it to you?
- 25 A Yes.

1	Q And he also came to you the next day for part
2	of it? A Yes.
3	Q And how much did you tell him it was?
4	A \$40.
5	Q That is what you told him is was. And as a
6	result of this you gave him some of it, is that right?
7	A Yes.
8	Q You only gave him \$15, is that correct?
9	THE COURT: What difference does it make?
10	MR. BROWN: It makes a difference as to the
11	total, even among
12	THE COURT: It is not revelent, and I will
13	not permit it.
14	MR. BROWN: Would it be revelent to the
15	question of honesty?
16	THE COURT: Fine, but that is not the
17	question before the Court or the Jury. That is
18	why I am excluding it, sir.
19	BY MR. BROWN:
20	Q Did you ever find out, whether your friend, your
21	partner, Bello, whatever the terms of partnership ever got a
22	cigarette? A No, I never did.
23	Q Well, he was standing there smoking them when
24	you were watching him from the corner? A 's.
25	Q And he was standing outside of the tavern, wasn't

1 he? No. I noticed him with a cigarette. 2 noticed him with a cigarette when I had come back to the 3 scene. When you came back to the scene you noticed him 4 5 standing outside the bar with a cigarette? 6 THE COURT: This was after the police were 7 there? 8 THE WITNESS: Yes. 9 BY MR. BROWN: And talking to the people outside of the bar? 10 11 Yes. A 12 Q Is there some doubt in your mind as to whether 13 or not you gave him the money to get cigarettes? 14 THE PROSECUTOR: Objection. 15 THE COURT: Objection sustained. 16 BY MR. BROWN: 17 Q Well, with respect to the money for the cigarettes 18 when this man went down to the bar, did you give him the money for cigarettes? 19 A I don't remember. 20 Well, do you remember telling the Grand Jury 21 that you don't know, but you think you may have given him 22 a dollar for cigarettes? He may have asked you for a dollar 23 for the cigarettes? 24 And you don't recall whether you gave him change or a dollar. You told Mr. Thevos you couldn't remember that? 25

1	A If I did give it to him I don't remember.
2	Q Let me ask you this specific question. Did the
3	Prosecutor ask you, Mr. Thevos ask you this question? "Let
4	me ask you this. If Bello went to the place, the Lafayette
5	Grill for the purpose of buying cigarettes, how do you
6	account for the fact that he took certain cents from the
7	cash register to call the police?" You said, according
8	to the
9	THE PROSECUTOR: Objection.
10	MR. BROWN: "I don't remember."
11	THE COURT: There is an objection,
12	Mr. Brown.
13	MR. BROWN: I can't be stopped in mid-
14	throat, I will choke to death.
15	THE COURT: I don't want you to choke
16	yourself.
17	MR. BROWN: I wasn't sure.
18	THE COURT: What is your objection?
19	THE PROSECUTOR: The question is phrased
20	what did Bello
21	THE COURT: Will you please stand up.
22	THE PROSECUTOR: The question is how can he
23	account for what Bello did.
24	THE COURT: Yes. That question contained
25	what you say and I will sustain the objection.

1	MR. BROWN: If you Honor please, this
2	entire account now, we come into a section where
3	he says what he did because it
4	THE COURT: Ask your next question.
5	BY MR. BROWN:
6	Q Then we will go on without that, your Honor.
7	"Something just occured to me. I am not sure, but when
8	he went for cigarettes he might have asked me for a dollar
9	for cigarettes. I am not sure about that." Did he or did
10	he not?
11	A I am not sure. That's one of the things I am not
12	sure of.
13	Q "Did you give him a dollar? Did you give him
14	a dollar bill or did you give him change?" "Answer, I don't
15	remember that. I can't remember that."
16	"Question, did you have change in your pocket?"
17	"Answer. Yes. I had change and I had paper."
18	Do you remember?
19	A Yes.
20	MR. BROWN: No further questions.
21	THE COURT: Anything further?
22	MR. STEIN: Yes, I still
23	THE COURT: Not still, but again. That is
24	the problem. You see, you should try, push, I
25	won't hold you to /strictly, but try to

1	complete your questioning in one session.
2	MR. STEIN: I appreciate that. I appreciate
3	the opportunity.
4	THE COURT: Alright.
5	CONTINUATION OF CROSS EXAMINATION
6	BY MR. STEIN:
7	Q Mr. Bradley, when you were following this
8	gentlemen down the street, you never did get a chance to
9	call out to him, did you? A No.
10	Q And you came back and you ran back into that
11	alley and then Bello came running into the alley and gave
12	you the money, is that correct? A Yes.
13	Q He didn't know you were there, did he?
14	A No. I wasn'the wasn't 20 feet in front of me all
15	the way down. I had been slowly closing in on him. You
1.6	know, closing the distance. And when last I saw him, he
17	still had his back to me.
18	Q So he never knew you were behind him?
19	THE COURT: He wouldn't know what somebody
20	else knew, how could he know?
21	BY MR. STEIN:
22	Q There was no physical response by Mr. Bello at
23	any time or in the sense that he turned around or just spok
24	to you to indicate that he recognized the fact that you were
25	hehind him is that wight? A Veg

BY MR. STEIN:

1	Q That is right, isn't it? A Yes.
2 .	THE COURT: Yes, he said that.
3	BY MR. STEIN:
4	Q So, in fact, he didn't turn around at any time
5	before you ran up the street that you know of, is that right?
6	A Yes.
7	Q And you ran into the alley and into that little
8	side there where you have the red spot? A Yes.
9	Q And when he came back with the money he ran
10	right into that little side spot and gave you the money, is -
11	that right?
12	Q But you at no time ever communicated to him
13	the fact that you were in that spot or that you were going
14	into that spot, did you?
15	A What spot is that? Where he gave me the money?
16	Q The red dot
17	A No, when he came up the sidewalk he came into view.
18	I jumped and then I saw that it was him and he ram over to
19	me.
20	THE COURT: What do you mean you jumped?
21	I don't understand?
22	THE WITNESS: At first I just saw a person
23	and then I saw it was him and he came right up
24	to me and he gave me the money.

1	Q So that when he came up the sidewalk he was
2	in your view, is that right? A Yes.
3	Q So that if he was in your view, where that
4	little dot was on this diagram, anything else coming up
5	the street would have been in your view also, is that right?
6	THE PROSECUTOR: Objection.
7	THE COURT: Objection sustained.
8	BY MR. STEIN:
9	Q Well, let me ask you this. Was any portion of
10	the width of Lafayette Street in your view from that little
11	red dot over there?
12	A I had gone into the alleyway a little bit and turned
13	around. He was just coming out there and he came up to me,
14	so a car could have gone by while I was back a few feet.
15	THE COURT: Let's not guess. You didn't
16	see a car coming anyway.
17	THE WITNESS: No.
18	THE COURT: You already enswered that before.
19	MR. STEIN: I have nothing further.
20	THE PROSECUTOR: I have no questions.
21	MR. BROWN: That is all.
22	THE COURT: Alright, Mr. Bradley, you may
23	step down.
24	we'll recess until tomorrow morning at 9:30.
25	(Whereupon the hearing is adjourned.)
