Lewis: The following is another episode in the melodrama-

11/30/76: Maynard called from LaGuardia stating that he had been paged, upon deplaning from Flight 417-Montreal, and requested to report information center. Was approached by plainclothsman, Gerald Whitmor (No.-0105). Said he was from the U. S. Dept. of Justice; has him under investigation. Told him that he has an auto up in Plattsburgh, N.Y.; the car has been missing. Maynard replied that he had not reported it stolen. Whitmor wrote down his bank account number, address and registration.

When he asked what the investigation was all about, was told if he wanted to know to write to the Department.

All of this occurred in the Customs Room. They wanted to skin search - Maynard refused - said they could arrest him but he was not taking off his clothing - they went through his luggage.

He then told me he was on his way to Phila., and would call ne when he arrived there. He did; gave me his telephone number.

I advised him that I could not call the department- that you were totally tied up in Carter/Artis; that Danny might be able to help. I called Danny (also advised him to call and leave message on Danny's answering service if couldn't be reached).

12/2/76 - Sometime between 11/30 and 12/1 - Maynard and Danny spoke with each other. See attached note. I also called in answer to telephone message from Cipriano; he was not in, but returned my call. I told him who Dan was; asked to speak with Mr. Whitmor; was told that Whitmor would not speak to me and that he got the gist of my call and would relay my message and Danny's to Whitmor.

That's all.... for now.
