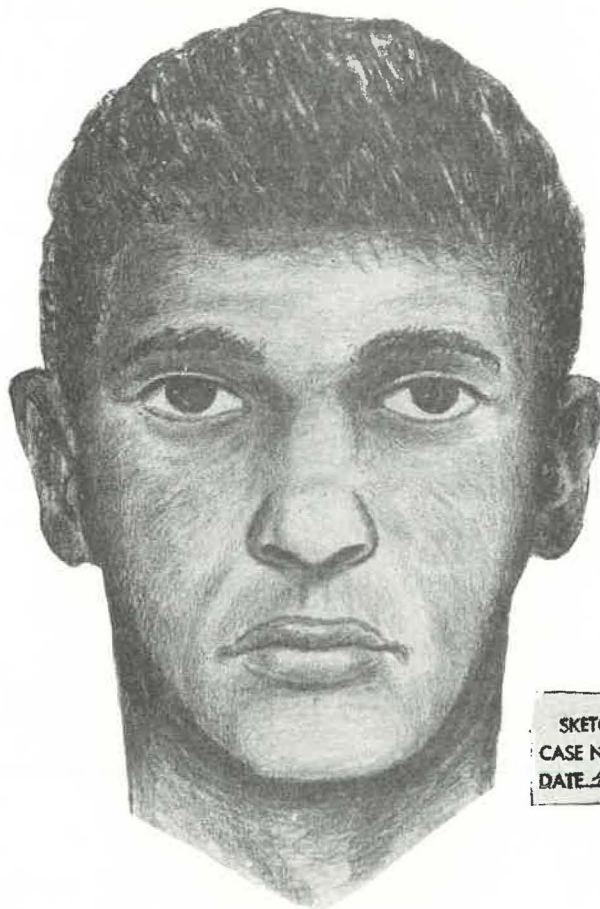

DESCRIPTION: MALE-NEGRO-18/25 YEARS, 5'8" 6' SLENDER BUILD, BROWN COMPLEXION, BLUE WINDBREAKER JACKET.

MODUS OPERANDI: SUBJECT AND A MALE-WHITE, 18/25 YEARS-5'10"-SLENDER BUILD-SANDY BROWN HAIR-DID INJECT THEMSELVES INTO AN ARGUMENT THAT SEAMAN APPRENTICE ROBERT CRIST AND MARINE SERGEANT MICHAEL KROLL WERE HAVING WITH ANOTHER PERSON.
