- 2102 MICHAEL QUINN for def direct
- Q: Can you recall being at your mother's home with Mr. Maynard the Sunday following Easter Sunday?
 - A: Yes.
 - Q: What was the date of the week of the Sunday following Easter Sunday?
 - A: April the 1st and 2d?
 - Q: Of what year?

A: of 1967.

- 2140 MICHAEL QUINN for def direct
- Q: Where did you sleep that night?
 - A: I slept in my old bed in my brohters; s rhom. We both have beds there.
 - Q: Where did Mr. M sleep that night?
 - A: In the living room.

- 2141 MICHAEL QUINN for def direct
 Q: About what time, if you can recall, did you leave your
- mother's home Monday morning, April 3, 1967?
- A: Approximately quarter to 9.
- Q: And do you have any recollection of what time you arrived at your place of employment?
- A: I arrived after nine. I was late, ten er 15 minutes late for work.

- 2116 MICHAEL QUINN for def direct
- Q: Now, as you sit on the stand today, how are you able to recall that particular week-end?
- A: He dropped me off to work that morning in a car we had rented, and he had stayed ov r that evening, and I recall being dropped off on a trip to the city. I recall the wek-end also because Mary had called A then at the house, and -- well, that is my direct recall.
- A: ... He dropped me off at 991 Sixth Avenue between 36th and 37th Street.

2151 - MICHAEL QUINN - for defense - cross

- A: There are many recollections of that day. Now I offer ed 2, at that time, and I have --
- Q: New you are offering 2 more.

A: Yes.

Q: Thank you.

A: I could offer some more.

Q: Do so.

A: I recall on the morning when he dropped me off, that he gave me a letter to be posted.

Q: Yes.

A: And, I recall psting that letter.

Q: I see.

A: I recall lying on the floor, or sitting on the sofa with Mr. M and watching a late movie. I recal a -- overhearing a conversation between my mother and Mr. M regarding a flower pot that he had brought over earlier.

A: He brought a flower pot over that Easter, the Sunday Before.

Q: Yes.

A: And it had bloomed this Sunday following, and it was made mention, the conversation was made regarding the flower blooming, a week later.

Q: Mr. Quinn, I just have a few brief questions. As

COURT: Never mind what you did. That isnt what he asked you. He asked you in effect why you happen to remember this particular weekend, not what you did. So don't volunteer anything. Your answer, as I understand it, is that you recall this particular weeken because it was
