Ibconsistent testimony llll prior hearing -- Now the follow ing day on the 17 of May, 1967, pursuant to this conversation that you had with Det McDonald, because of that conversation.

Van Means doesn't remember the questions and answers.

Confused and unsure of dates 2914

Court goes over things with Van Means ending with did you know the pigs were coming in that day to arrest him.

NO.

It seems they met on street corner 6th Ave & 8th St and

arranged to meet at boutique to pay Tony \$600. But he denies calling McDonald and telling him. Admits when pigs came, he never paid Tony.

Doesn't remember when he moved into to possession of boutiq Then he moved into a larger store.

A: Well, I didnt feel that I owed him anything.
