IT IS HEREBY STIPULATED AND AGREED by and between the attorneys for the plaintiff classes ("plaintiffs' counsel") and the attorneys for the defendant as follows:

- 1. Defendant has discovered various documents contained in the personnel files of non-rotating staff other than those listed in paragraphs 4 and 5 of the Stipulation and Order dated October 24, 1985 ("Stipulation").
- 2. Pursuant to paragraph 8 of said Stipulation, counsel for the defendant has informed plaintiffs' counsel that miscellaneous documents contained in personnel files pertaining to defendant's non-rotating staff have been discovered.

- 3. The following documents in defendant's personnel files for the period December 1, 1974 to date relating to non-rotating staff personnel including both "exempt" and "non-exempt" employees will be produced to plaintiffs' counsel subject to the confidentiality order issued by Magistrate Harold J. Raby, dated November 7, 1984:
 - 1. Attendance records, tardiness reports
 - 2. Handwritten notes which generally appear to pertain to interviews, employee discipline, termination, work performance, etc. except for attorney-client privileged or attorney work product notes if any which shall be listed in an appropriate schedule consistent with the requirements of local civil court rule 46, effective June 1, 1985
 - 3. Unemployment forms, determinations, requests for wage data and various correspondence related thereto
 - 4. Interview/thank-you notes
 - 5. SCOA I.D. Cards
 - 6. Statement of benefits forms
 - 7. Maternity Leave Policy form
 - 8. Letters regarding employee performance
 - Applications for Approval relating to personnel matters
 - 10. Overtime Records

- 11. Pension Plan Information
- 12. SCOA Annual Statement of Benefits forms
- 13. IRS documents (1040 forms)
- 14. Office salary charts
- 15. Payment vouchers
- 16. Payroll sheets
- 17. Check ledger
- 18. Immigration and Naturalization Service forms
- 19. Request for Verification of SCOA employment by potential employer/bank (redacted to exclude name of employer/bank)
- 20. Request for reference by SCOA from prior employer.
- 4. Plaintiffs' counsel agree to defer their request for the following documents which have been identified in defendant's personnel files for the period December 1, 1974 to date relating to non-rotating staff personnel, including both "exempt" and "non-exempt" employees, until after they have reviewed the documents to be produced pursuant to paragraph 3 of this Stipulation and Order or in accordance with the Order of the court if such is required.
 - 1. Jury notices, requests to postpone
 - 2. Disability Forms
 - 3. Bank verification of signature forms
 - 4. Housing Authority Applications

- 5. U.S. Treasurer check xerox copies
- 6. Blue Cross/Blue Shield Forms
- 7. Leave/Absence Notes
- 8. Information submitted to government agencies re eligibility for welfare benefits.
- 5. Counsel for Defendant has discovered diverse documents written in the Japanese language. Defendant's counsel has also discovered documents pertaining to actual or threatened agency or court claims or litigation against or with SCOA other than those enunciated above. Such documents shall be discussed on a case by case basis at mutually convenient times and produced according to a separate agreement between the parties or in accordance with an order of the court if such is required.
