JESSUP MOOT COURT TEAM IS UNITED STATES NATIONAL CHAMPION

New York Law School's team brought home the Brunston McChesney award as United States National Champion from the World Cup Rounds of the Philip C. Jessup International Law Moot Court Competition, held April $1-8\,\mathrm{in}$ Chicago. The team's performance placed it among the top four teams in the world behind the overall champion, the University of British Columbia. NYLS also received the Alona E. Evans award for second place in the best brief competition.

The NYLS team of third-year students Sandra Corbitt, Hassan Fancy, Dennis Prahl, second-year students Donna Farmer, Pashko Vuksanaj and coach third-year student Kannon Menon qualified to compete in the competition's international round by placing first in it's regional round in February. NYLS was one of twelve American regional champions among 35 teams from 25 countries competing at Chicago.

NYLS advanced through the preliminary rounds of the Chicago competition, defeating the National University of Taiwan, the National Autonomous University of Mexico, the University of Oregon and the University Malaysia - Kuala Lumpur. The team then defeated the University of Texas at Austin, winning the United States National Championship and advancing to the semi-finals where they met the University of British Columbia, the eventual world champion.

Arguments in this year's Jessup Competition concerned the Vienna Convention on Diplomatic Relations and the State seizure of assets administered by an international monetary organization.

FIRST ANNUAL STUDENT AWARDS CEREMONY SET FOR MAY 2

The Law School's first annual Student Awards Ceremony is scheduled for Tuesday, May 2 at 4:30 p.m. in the Faculty Dining Room. At the ceremony Dean Simon will present Certificates of Merit to all graduating students who have served on student organization Executive Boards, on the Student Bar Association, on the Moot Court Association, or as Journal Editors. A reception will follow the ceremony.

JAPANESE LAWYERS VISITING NYLS

New York Law School will host a group of Jpanese lawyers, from the Japan Federation of Bar Associations, called Nichibenren, during their visit to New York this week. The group is here to study the administration of the juvenile justice system and visit representative court, schools and other institutions.

Nichibenren is a quasi-public body that administers admission to practice under the Lawyers Law and makes influential recommendations concerning new and amended legislation to the Diet, the National Assembly of Japan.

The visiting group, consisting of twenty-five lawyers and professors of law, will be at the Law School for lunch on Monday, May 1, where they will be greeted by Dean Simon and hear a talk by Professor Marjorie Silver on education law. On Tuesday morning, they will return to the Law School from 9:30 to 11:00 a.m. for a lecture given by Professor Stephen Newman on juvenile law.

NEW YORK LAW SCHOOL FACULTY NEWS

Professor Robert Blecker's play, "Vote No!" will be performed May 1 at the Supreme Court of Rhode Island in celebration of Law Day. Professor Blecker will introduce the play and conduct a discussion of "Anti-Ratification Efforts," following the performance. He will present a lecture entitled: "From the Streets to the Joint," touching on the extreme violence in the streets of the Nation's capital, about his experiences working at the Lorton Central Prison in Washington D.C., on May 18, at noon in the Aronol Theatre at City College.

Professor Seymour I. Feig, will conduct a seminar for station managers of television stations affiliated with the American Christian Television Service, on problems relating to the production of programs, at a meeting of the Radio and Television Commission of the Southern Baptist Convention, in Ft. Worth, Texas, on May 18.

Professor B.J. George, Jr.'s article, New Developments in Victim and Witness Protection in the United States, 32 UNAFEI Resource Materials Series 11-27 (Dec. 1987) has been published.

Professor David Schoenbrod will speak at the Symposium, entitled "Environmental Law Turns Twenty," on the topic of: "A Reassessment of Risk Assessment, " and will also moderate a discussion on the topic of: "Tactics: Choosing among Litigation, Regulation, Legislation, and Negotiation," at Yale Law School on April 14-15. He will also receive an award from the Yale Environmental Law Association for his contributions to environmental protection.

Michael Sinclair's review of Anna Clark, <u>Woman's Silence</u>, <u>Men's Violence</u>: <u>Sexual Assault in England</u>, <u>1770-1845</u>, has been published by The American Historical Review.

Professor Vernon F. Snow has received a \$ 25,000 grant from the National Endowment of the Humanities to complete the third volume of The Private Journals of the Long Parliament (1640-1642). The third volume covers the breakdown of negotiations between the King and Parliament and the outbreak of the English Civil War. It sheds new light on the early career of Oliver Cromwell and Anglo-Irish relations on the eve of the first Civil War. Professor Snow will spend several months in England verifying the text of the private journals and composing an introduction.

Professor Nadine Strossen traveled to Egypt, Israel and the West Bank to work on a human rights project for Middle East Watch. In April, she gave a public lecture in San Diego, sponsored by the Anti-Defamation League, on newspapers' rights and responsibilities concerning the publication of anti-semitic editorials and letters to the editor.
