Plaintiffs request that the defendant Sumitomo Corp. of America, by a member or agent thereof, respond, under oath, in accordance with Rule 33 of the Federal Rules of Civil Procedure, to the following interrogatories, and produce copies of documents hereinafter requested, in accordance with Rules 33 and 34 of the F.R.C.P. These interrogagories shall be deemed to be continuing so as to require defendant seasonably to supplement or amend its answers thereto in accordance with Rule 26(e) of the Federal Rules of Civil Procedure.

PLEASE TAKE NOTICE that copies of defendant's answers must be served upon the undersigned within 30 days after the service of these interrogatories. It is requested that defendant's answers restate each of these interrogatories in full before responding to it, that copies of all documents identified be attached to the answers and that said copies of the abovedescribed documents and answers be delivered to plaintiffs' counsel for inspection and copying at plaintiffs counsels' offices at 351 Broadway, New York, New York 10013.

DEFINITIONS

Unless a contrary meaning appears in the context of a particular interrogatory, the following definitions shall apply:

(a) "Corporation" refers to defendant (as corrected in Answer 1 below)its officers, agents, and employees, and any company to which it is the corporate successor.

(b) "Job" refers to positions of employment, whether now or previously in existence at the Corporation, and held either on a temporary or permanent basis.

(c) "Employee" refers to a person employed by the Corporation.

(d) "Applicant" refers to a person who seeks, or has sought employment with the Corporation.

(e) "Supervisory position" refers to any position within the Corporation in which an employee has the authority to direct the work of other employees.

(f) "Test" refers to any written or oral performance, or other examination administered at any time by the Corporation for the purpose of selecting applicants for employment or for the purpose of promotion or transfer to any job.

(g) "Document" refers to any written, printed, typed or other graphic matter of any kind or nature, including drafts and copies bearing notations or marks not found on the original; including but not limited to all memoranda, reports, financial reports, notes, letters, envelopes, telegrams, messages (including reports, notes and memoranda of telephone conversations and conferences), studies, analyses, books, articles, magazines, newspapers, booklets, circulars, bulletins, notices, instructions, minutes of all other communications of any type, including interand intra-office communications, purchase orders, questionnaires and surveys, charts, graphs, tape or other recordings, punch cards, magnetic tapes, discs, data cells, drums, print-outs and other data compilations from which information can be obtained (translated, if necessary, by the defendant into usable form).

(h) "Career paths and/or progression ladders" refer to a system of job progression, from which an employee may expect to advance from one job title or description to a more advanced job title or description in the normal course of employment, assuming satisfactory performance.

(i) "Salary" refers to all money, property and services received from the firm, including compensation, benefits of any nature, and bonuses.

(j) "School years completed" refers to the number of years of formal education an employee has completed. For example, an employee who has graduated from high school in the United States has completed 12 years.

INTERROGATORIES

1. What is the correct corporate name of the defendant, and when and in what state was it incorporated?

2. State fully what relationship, if any, the defendant has or had at any time to Sumitomo Shoji America, Inc. (for example, is it a successor corporation, was Sumitomo Shoji America's name changed to defendant's), and give all dates relevant to said relationship.

3. If the defendant has or had any relationship to Sumitomo Shoji America, please state whether any employees of the defendant were employees of Sumitomo Shoji America, and if so, state whether employees of Sumitomo Shoji America became employees of defendant without undergoing a rehiring process and whether employees of defendant who formerly were employees of Sumitomo Shoji America retain or retained any seniority, benefits, rights, job assignments, titles or status which they accumulated as employees of Sumitomo Shoji America.

4. State whether the defendant has any affiliates or subsidiaries.

5. If the answer to interrogatory 4 is in the affirmative, please list each affiliate or subsidiary, and as to each supply

the following information:

(a) Its state of incorporation;

- (b) The address of its principal place of business;
- (c) Whether the defendant, or any of its employees, participate in the day to day management and/or control of the subsidiary or affiliate, and if so the names, titles and business addresses of the employees of the defendant who engage in this function.

6. State whether the corporation is a subsidiary of any other corporation. If so, state the name of the parent and state the location of the parent's principal office.

7. If defendant is a subsidiary of another corporation, please state whether any employees of the parent corporation engage in the day to day management and/or control of defendant, and if so, please give the following:

- (a) The names and business addresses of all such employees;
- (b) Their position of employment;
- (c) Their function(s);
- (d) If any of said persons are not physically located at an office of defendant, with whom and how they maintain contact with defendant.

8. State where the defendant maintains offices, indicate which office is the principal place of business, and give the full address of each office.

9. State the total number of employees employed by the corporation.

10. State the total number of employees employed by the corporation at each of its offices.

11. Does the corporation use job titles? If the answer is yes, list all job titles which have been utilized by the corporation since April 1, 1969, and state as to each job title when it came into being, and until what date the job title was utilized.

12. Does the corporation use job descriptions? If the

answer is yes, identify all job descriptions which have been in use since April 1, 1969, and annex copies of all documents containing job descriptions which have been utilized at any time by the Corporation since April 1, 1969 to date, specifying the periods when said descriptions have been utilized.

13. If the Corporation has utilized job descriptions which have not been reduced to writing, please list each job by title, stating next to each job what the description of the job is, and state when the Corporation has employed persons to fill such job from April 1, 1969 until the present.

14. Does the Corporation classify employees into categories such as executive, managerial, professional, technical, clerical etc? If the answer is in the affirmative, identify all documents which describe how the classification is accomplished, and attach copies to these answers. Also list all job titles which fall within each category.

33. State whether the Corporation has any standard procedure by which an employee may seek a promotion or by which the Corporation grants promotions on its own initiative. If the answer to this interrogatory is in the affirmative, please answer the following questions:

(a) Is the procedure in writing? If the answer to this question is in the affirmative, please answer the following:

 (i) identify the document or documents and attach copies to the answers to these interrogatories; when and

- (ii) /by whom were the procedures promulgated?
- (iii) how were they communicated to the employees?
 - (iv) to employees in which job titles were the procedures communicated, and when were they communicated?

34. Does the Corporation have oral, rather than written standard procedures for promotion? If the answer is yes, answer the following additional questions: When and

- (a) /By whom were the oral procedures promulgated?
- (b) How are they communicated?
- (c) To which employees, and when?
- (d) State in detail what the procedures are.

35. Does the Corporation have oral, rather than written

procedures by which employees may become salespersons? If the answer is yes, answer the following questions: When and

(a) /By whom were the oral procedures promulgated?

- (b) How are they communicated?
- (c) To what employees and when?
- (d) State in detail what the procedures are.

36. Has the Corporation utilized any tests from April 1, 1969 to date for the purpose of selecting applicants for employment in, or promotion or transfer to, any job? If the answer to this question is yes, answer the following questions:

(a) Identify all such tests and attach copies to the answers to these interrogatories, and state when each test was used.

(b) As to each test, unless the test is attached to the answers, describe in detail the nature of the test and the questions asked.

(c) As to each test, describe the criteria which the Corporation applied, including the passing grade, etc.

(d) As to each test, state who judged or judges the test results and/or made or makes determinations as a result thereof.

37. State whether the Corporation has had, or presently has, a training or educational program which employees may utilize to seek promotions or transfers. If so, describe in detail, including the dates of initiation and termination, what employees are eligible for inclusion, how the existence of the program was communicated to employees, and the numbers of employees who enrolled, year by year, from April 1, 1969 to date, indicating sex and country of national origin during each program. (If the Corporation claims it does not know the national origin of its past or present employees, it should indicate this in the answer, and substitute "citizenship", and provide this information).

Also state as to each such pro-

38. State whether the Corporation utilizes any system of written evaluations or efficiency reports regarding the quality and quantity of work performed by employees. If so, answer the following:

(a) Identify all such documents, stating during what period of time from April 1, 1969 to date each report was utilized, and attach blank copies of each form utilized.

(b) For each evaluation utilized, state which categories of employees by job title were, or are, evaluated.

(c) For each category of employee by job title evaluated, state how often they are evaluated, listing the date of the last evaluation.

39. Does the Corporation maintain personnel files for individual employees? If the answer is in the affirmative, answer the following:

If the answer is in the affirmative, list each case name individually, setting forth the forum, the case identification number, and the status of each case. 41. With regard to each question above which requires the . Corporation to set forth information which is not based on documents, please give the source of the information, stating the name and address of the informant(s).

42. Identify separately and with particularity sufficient for use as a description in a subpoena each document (not already identified in the answers to the foregoing interrogatories or produced in response to the requests contained herein) which contains any of the information given in answer to each of the foregoing interrogatories.

43. State whether the Corporation asserts that either sex and/or country of national origin is a <u>bona fide</u> occupational qualification (hereinafter "b.f.o.q.") for holding of any job with the Corporation. If the answer is in the affirmative, list all job titles and/or categories in which the Corporation asserts a b.f.o.q. defense, listing for each job title or job category what defense is asserted, and stating in detail the basis for the assertion of the defense.
