ROBERT CRIST - CROSS X ASK FOR MATERIALS INCLUDING COMPOSITE AND DISCRIPTION ON FLYER.

- a. You were on a weekend leave the night of April 2-3, 1967?
- b. When did leave begin. time place. How did you get to Cornwall. Did you get paid before going on leave? How much?
- c. What did you did when you go home to Cornwall. Who did you see. Did you have a girlfriend. How long had you been in the service. When had you had your last leave?
- d. Did you go out on the town while you were home in Cornwall. Go to any of the local bars or taverns. What did you do Saturday nite, who did you see, did you party, drink much, get home late.
- f. What time did you get up on Sunday? What did you do that day, etc. Who did you see. Where did you have dw Your supper. With whom. When did you expect to get your next leave. Have a bk beer or a highball with your dinner. How did you get to the bus station. Did you have a beer waiting for your bus. (doesn't recall363).
- g. What time did you arrive in New York. Where dod you go. Were you looking for anyone in particular. How long did you stay in the bar waiting.
- h. How much did you have to drink. (drank beer can'T recall how much did not eat. T364).
- i. Where did you go after you decided to leave. What time. (T338 went to east side stopped off in a couple of bars.
- ii: did you try to pick up any girls?
 k. When did you arrive back at Port Authority(T338- 2:30am)
- 1. Then you went back to the Marginas Bar to see if any one was there? x Do you remember whether you had anything els to drink?
- m. And you wen decided to go to Greenwich Village around 2:30a.m. What did you want to do down there? Did you know the area? Where were you headed?
- n. How did you get down. T339. First he says hezwakk took subway, then he says he walked. Then he says he took subway to 14th and walked. Very unclear. Read transcript.
- o. discribe what happened next. Check against T343; t371-372. What happened to the sanwich and beer. How far did you run. Were you out of breath and a little messed up looking.
- p. What hahppened when you caught up to the black man? did you hit him? did he fall? Were you excited. Do you normally get anry at people and hit them for insulting you. Were you a little bit high would that explain your conduct?

- o. Then want happened. Where did you first see the black man and the white MAN? Point it out on exhibit (344 in front of Purple Onion 372 just after he passed Purple Onion).
- p. Where did they come from (t344 they came up nothing

But see p378. " He came up from behind me and off to the side." Push him here and see what happens.

- q. Not sure of stret lights. T374. You do remember that the bars were closed and their lights out, don't you?
- r. discribe where discussion took place. do you remember where you were standing. Where they were standing? Did you stay in the same location. For how long. Now, I take your/86APPentation withzthezsecondzbiackzman took place in that one area, is that right. And when he moved off with kkexwkikexman his white companion, you did not follow. You remained next to the Purple Onion.

s. Now , do you remember what the Negro looked like? Would you discribe him, to the best of your recollection? (Discriptions are on pages T344 and T372-379)

T344 -About my height (ask how tall Crist is) 6 (1375) "good build, light skin, not very light skinned, average skin, I would say."

T372-3 - Negro wearing dark - quite blue or deep gray windbreaker or jacket, spring jacket T373- din't see him carrying anything. No hat, no glasses, clean shaven, didn't notice shirt, jacket drawn up

T374 jacket waist high. didn"t notice zipper or buttons.

saw no bulges

T376- good build, wasn't fat or skinny, solid. color - "not a really dark color, not light, medium tone." "average shaped face" Wasn't pointed chin or wasn"t real narrow eyes, "nothing outstanding like that registered in my mind."

doesn't remember high or low cheek bones. nothing significant about nose. Nothing significant about ears. didn't notice whether he had any marks or scars.

T377: didn't have really long hair - neat and trimmed. kinky.

din't notice whether he had long side lashes.

T378: head held high 7380: Estimated 19- 20

- t. Now it was during this period that you got your best look at this Negro whom you were arguing with, isn"t that correct. In other you remember what he looked like from seeing him on W3rd st. You didn't get to see the person under as favorable conditionsthereafter.
- u. When you testify that you saw this same person again on 4th st before and during the shooting, you are aware that the lighting wasnxxxxx worse where the shooting took place are you not. And you were further, and inside a car, and looking through a window, isn't that right?

v. Now at some time after the shooting you gave a discription to the police, did you not. Who did you give it to?

How many times did you give discriptions? Where?
On what dates or during what periods of time?
Did you see any of the police officers take any notes as you gave out discriptions. Who.

x. At a certain point you met a police artist did you not, and you gave him a discription of the Negro you saw? Did you not.
And you actually watched while he did a sketch, did you not.

And you saw the finished product, did you not - in the form of a police flyer. And you read the discriptive material which was attached to the composite. And I take it you thought the discription and composite were accurate to the best of your recollection?

y. Introduce the composite flyer and have the witness read. Then question in light of the discription which he has given in court.

z. Now the white whom you saw you saw with the Negro in front of the Purple Onion, would you discribe him?

T344 - "the white I don't remember much about."

T372 - looked at the white but didn't take much notice of him. "Hw was shorter than I was , that is the only thing I noticed." didn't notice what he was wearing. How old was he? aa. Did you give the police any discription of the white?

to wz whom? T381 - 5' 9" - medium build

bb. Now you say that in front of the P.O. you has some words the the Negro whom you believed to 19-20 years old? What did he say to you and what did you say to him. What can you remember of that conversion. And how long do you estimate that it lasted.

T345 - shouldn't have been picking on smaller man 5-10 min.

cc. Christ,s voice raised (t345) arguing (T346) foul language (346) no blows 346

Yet later Crist says \$346 - good english - no slurs.

dd. Now as I understand your testimony, the white asked the black to leave, and at at certain point they did so - they walked west toward 6th and left you standing there - the incident was clsoed. And then the Marine drove up, is that correct.

If not what is correct . See T348 - Marine asked Crist what happened, then asked Negro what happened, then offered to drive Crist to Port Authority.

ee. What happend next. Traffic conditions - How fast did Marine drive? traffic lights.

ff. Did Kroll tell you what he was going to do? Did you ask him? Well you must have realized that he was going to start a fight? and did you try to stop or tell him you weren't interested in getting into another fight
