

HUMAN RIGHTS POLICY



The Online Mental Disability Law Program at New York Law School Certificate in Advanced Mental Disability Law Studies

Few, if any, growth areas of the law have matched the astonishing growth of mental disability law as both a specialty of practice and a subject of new and important significance to members of the bar, practicing mental health professionals, and criminologists. New York Law School's Certificate in Advanced Mental Disability Law Studies program is the first advanced certificate program created specifically to give lawyers, mental health professionals, and criminologists advanced training in one of the most important, complex, and challenging areas of law and public policy.

The Certificate is designed to:

- · Offer practicing attorneys specialized knowledge in an area of law that, each year, grows in importance.
- Enhance the knowledge-base and credibility of forensic psychologists and psychiatrists in report writing, evaluation, and testimony, and help in preparation for board certification examinations.
- Provide administrative and clinical psychologists and psychiatrists with valuable information about the legal system necessary to daily practice.
- Offer mental health professionals who do not have terminal degrees in their fields the opportunity to receive raises
 and promotions.
- Provide people working for advocacy agencies with valuable information about the legal system that they need to
 effectively represent and work with their clientele, and afford them additional credibility in their work.
- · Offer public employees an additional credential that, in many instances, makes them eligible for raises and/or promotions.
- Provide criminologists and criminal justice students and scholars an opportunity to pursue advanced academic work in
 a subject matter that has become increasingly integral to their field.

CERTIFICATE REQUIREMENTS

- 1. Candidates for the Certificate in Advanced Mental Disability Law Studies at New York Law School must earn at least 15 course credits of approved course work.
- Candidates must successfully complete the Survey of Mental Disability Law course. International candidates and candidates without J.D. degrees must, in addition, successfully complete Introduction to the American Legal System, unless they have demonstrated proficiency in the study of American law or successfully completed equivalent course work.
- 3. In addition, candidates must successfully complete four elective courses.
- 4. Candidates who have successfully completed previous course work prior to spring 2009, either in the Online Mental Disability Law Program or in identical or analogous predecessor courses offered by New York Law School prior to the creation of the Online Mental Disability Law Program, may apply some or all of these credits towards the Certificate. If candidates have earned nine or more credits in previous course work, then they must also successfully complete two elective courses in order to receive the Certificate.
- 5. To receive the Certificate, a candidate must have a minimum cumulative grade point average of 2.5.
- 6. The requirements for the Certificate in Advanced Mental Disability Law Studies and all New York Law School and program policies are subject to change without notice. Candidates for the Certificate in Advanced Mental Disability Law Studies must satisfy any other requirements for the Certificate that are in force when it is awarded.

APPLICATION DEADLINES AND DECISION TIMELINE

Priority consideration is given to applications received and completed by these dates:

For admission in Spring 2009: December 19, 2008 For admission in Fall 2009: May 15, 2009

Applications received or completed after these priority deadlines will be considered only if space is available. Decision notifications generally are made within one month of the receipt of the application.

The above deadlines and decision time frames also apply to transfer applications.

CERTIFICATE IN ADVANCED MENTAL DISABILITY LAW STUDIES APPLICATION REQUIREMENTS

All candidates for the Certificate in Advanced Mental Disability Law Studies must have earned, at a minimum, an undergraduate degree from a qualifying institution prior to enrollment in the Online Mental Disability Law Program. Applicants generally must have the equivalent of a "B" average in their undergraduate career or in subsequent graduate work; however, applicants whose GPA average is less than a 3.0 will be considered on a case-bycase basis if their résumés or curricula vitae indicate a significant amount of professional experience in the field. Candidates who have completed any part of their education outside the United States may satisfy this degree requirement on the basis of an equivalent degree earned in a foreign jurisdiction. (International students should read carefully the section on p. 3 "Additional Information for International Students" for certification and evaluation requirements and other information.)

The following must be submitted to complete an application:

- Completed and signed Certificate in Advanced Mental Disability Law Studies application form
- 2. All previous post-secondary education degree transcripts
- 3. Personal statement
- 4. Résumé or curriculum vitae
- 5. Two letters of recommendation
- 6. Non-refundable application fee of \$65 (U.S.)

While interviews are not a regular part of the admissions process, the Admissions Committee reserves the right to call any applicant for an interview during the evaluation process.

POST-SECONDARY EDUCATION AND DEGREE TRANSCRIPTS

Official final transcripts confirming the conferral of all undergraduate, graduate, and other professional degrees must be received from the issuing schools prior to matriculation. (For work completed at New York Law School, it is not necessary to submit a transcript.)

PERSONAL STATEMENT

A typed, double-spaced personal statement is required; this statement must be at least two pages, but should not be more than five pages. The statement must describe how the candidate developed an interest in the field of Mental Disability Law Studies, how this degree will assist in his or her career advancement, and any other information that the Admissions Office should have available in the decision-making process.

RÉSUMÉ/CURRICULUM VITAE

Please include your updated résumé/curriculum vitae with your application.

LETTERS OF RECOMMENDATION

All applicants must submit two academic or professional letters of recommendation in support of their application. Such letters should discuss the applicant's analytic and writing skills and other factors relevant to the applicant's ability to complete rigorous graduate level training. One letter should be an academic reference (if possible) written by a professor or academic dean. The second letter should be a professional reference; letters written by a practitioner in any aspect of mental disability practice or mental disability law are preferred. In the case of students applying for the Certificate program who have not yet had relevant "field experience" of any sort, two academic reference letters should be submitted. One additional letter of any type may be submitted; the Admissions Committee, however, will review a maximum of three letters of recommendation for each applicant. The most effective letters are those written by individuals who have known the applicant for a substantial period of time and can provide insightful comments on the character and abilities of the applicant. The letters should be sent directly by their authors to the Admissions Office at the address on the next page.

APPLICATION FEE

All applicants are required to submit a non-refundable application fee of \$65 (U.S.). Please make checks payable to New York Law School. This fee is not credited toward any charges in the event of your admission to the Certificate program.

DISCLOSURES

The application form requires disclosure of all instances in which the applicant has been charged with any offense or violation; pleaded nolo contendere to, pleaded guilty to, or been found guilty of any crime, offense, or violation (with the sole exception of a minor traffic offense); and of any such actions pending or expected against the applicant. Conviction of DUI (or any other alcohol or drug-related offense) is not a minor traffic offense. The application form also requires disclosure of all instances in which the applicant has been suspended from practice, reprimanded, censured, removed, or otherwise disciplined as a member of any profession or occupation, and all instances in which any complaints or charges, formal or informal, have been made or filed, or proceedings instituted against the applicant as a member of any profession or occupation. Failure to disclose such information on the application may result in dismissal from school or revocation of any degree awarded. Any failure to disclose this information will also be reported, if the applicant is a lawyer, to the Bar or any equivalent professional licensing organization.

STUDENTS WITH DISABILITIES

New York Law School complies with the Americans with Disabilities Act of 1990 and with Section 504 of the Rehabilitation Act of 1973 as amended. The Law School's Office of Student Life and Office of Academic Affairs formulate general policy on disability issues and make decisions on individual accommodation requests.



ADDITIONAL INFORMATION FOR INTERNATIONAL STUDENTS

Applicants who have completed their undergraduate, graduate, medical and/or legal education outside of the United States must have their transcripts forwarded to the World Education Services, Inc. (WES), Bowling Green Station, P.O. Box 5087, New York, NY 10274-5087; 212.966.6311; info@wes.org; www.wes.org.; or another certified evaluation service for analysis. The evaluated transcript must be forwarded by WES directly to the Admissions Office. Completion of the requirements for the Certificate in Advanced Mental Disability Law Studies generally will not qualify a foreign-trained lawyer to take the New York Bar Examination. Additional course work is usually required to sit for the bar exam. Information concerning the Foreign Lawyer Program at New York Law School for attorneys admitted to practice in foreign jurisdictions who wish to qualify to take the New York Bar Examination can be found at www.nyls.edu. For a determination of eligibility to sit for the New York State Bar Examination, please contact: The State Board of Bar Examiners, 1 Executive Centre Drive, Albany, NY 12203-5148; 518.452.8700.

ENGLISH REQUIREMENT

Applicants for whom English is a second language and who have not studied law at an institution where English is the primary language of instruction are required to take the Test of English as a Foreign Language (TOEFL). Results of the TOEFL must be forwarded to the Admissions Office for review. The minimum score requirement is 600 on the old scale and 250 on the computer-based scale, or a 90 on the Internet-based TOEFL.





7th Avenue Line

1 (local) to Franklin Street. Exit at Varick Street and West Broadway. Walk two blocks south on West Broadway to Worth Street.

2, 3 (express) to Chambers Street. Exit at West Broadway and walk four blocks north on West Broadway to Worth Street.

Lexington Avenue Line

4, 5 (express) and 6 (local) to Brooklyn Bridge/City Hall. Exit at Foley Square. Walk north two blocks to Worth Street and west three blocks to Church Street.

8th Avenue Line

A (express) and C (local) to Chambers Street. Exit at Church Street. Walk four blocks north on Church Street to Worth Street.

Avenue of Americas (Sixth Avenue) Line
