COMMENCEMENT '89 SPEAKER ANNOUNCED
The Hon. Roger J. Miner '56 to Address June Graduates

The Law School will hold its annual commencement exercises on Sunday, June 11, at Avery Fisher Hall in Lincoln Center. Featured speaker at this year's ceremony will be New York Law School graduate Hon. Roger J. Miner, Judge of the U.S. Court of Appeals, Second Circuit, in Albany.

Judge Miner, a 1956 graduate of the Law School, was the Law School's first managing editor of the Law Review and active in moot court competition. After practicing law in his home town of Hudson, N.Y., Judge Miner served as District Attorney for Columbia County, N.Y. In 1976 he became one of New York's youngest State Supreme Court Justices and, in 1981, was appointed U.S. District Judge for the Northern District of New York. Four years later he was named to his present position as Judge on the U.S. Court of Appeals for the Second Circuit.

Judge Miner has written and lectured widely on the federal courts system, constitutional law, professional responsibility and other topics.

#### TWO NEW MEMBERS ARE ELECTED TO BOARD OF TRUSTEES

The New York Law School Board of Trustees elected two new members at its most recent meeting. They are Harry H. Wellington and Stanley B. Doyle, Jr. '49.

Mr. Wellington is the former dean and currently Sterling Professor of Law at Yale University. After graduating from Harvard Law School he served as law clerk to the noted Supreme Court Justice Felix Frankfurter. Professor Wellington joined the Yale Law School faculty in 1956, was named to the Phelps Chair in 1967 and the Sterling Professorship in 1983. He is a prolific author as well as a lecturer and consultant in demand in the United States and abroad.

Mr. Doyle, a member of the Law School class of 1949, was elected as an Alumni Association trustee. He recently retired as Vice President, Personal Trust Division, at the Manufacturers Hanover Trust Company.

Mr. Doyle has served on the faculties of the New York State Bankers Association's Trust Division and the National Trust School of the American Bankers Association. He has lectured at the Practicing Law Institute of C.W. Post College and is the author of Settling an Estate in 40 Steps and Wills and Trusts To Carry. He was elected President of the New York Law School Alumni Association in January.

#### "THE LAW LISTENS" AGAIN

The third annual "The Law Listens" program, sponsored by the Criminal Law Society and the City Board of Education's SPARK Program, is scheduled for April 14. The morning-long program on drug abuse allows high school students to speak directly to prosecutors, high-ranking police officers, judges and others involved in formulating and executing public policy on substance abuse. The program is designed to give high school students a forum in which to air their thoughts, but more importantly, to give the invited listeners an opportunity to hear first-hand from one of the groups most intensely affected by the ongoing problem of the illicit drug trade, according to Michele Marwill of the Criminal Law Society.



#### IN MEMORIAM: PROFESSOR FRANKLYN SETARO

Professor Emeritus Franklyn C. Setaro died in New York on March 19. He was 84 years old. He was a member of the New York Law School faculty from 1954 until his retirement in 1980.

A 1926 graduate of New York University, he received his law degree at Boston University in 1931 and a diploma at the College of the City of London in 1952. A retired Merchant Marine officer, he was an associate professor at the United States Merchant Marine Academy from 1946 to 1952 and visiting professor at the College of the City of London from 1952-53.

#### Federal Litigation Clinic Victories

The New York Law School Federal Litigation Clinic recently scored two more victories on behalf of indigent disability claimants in federal district and appellate courts. In <u>Tirado v. Bowen</u>, No. 86-4915 (S.D.N.Y Feb. 3, 1989), United States District Judge Conner granted the Clinic's motion for a remand in light of new medical evidence. The new evidence was discovered by law student interns Scott Cagan'88, and Arcadio Reyes'88 while investigating and briefing Mrs. Tirado's appeal to the United States of Appeals for the Second Circuit in <u>Tirado v. Bowen</u>, 842 F.2d 595 (2d Cir. 1988) (remanded to review new evidence). Susan Fiore'90 assisted in preparing the Clinic's remand motion.

In <u>Hill v. Sullivan</u>, No. 87-4344 (S.D.N.Y. Mar. 14, 1989), the Clinic joined forces with the Legal Aid Society and Brooklyn Legal Services Corporation in persuading United States District Judge Walker to grant plaintiffs' motions for class certification and intervention, and to deny the United States Department of Health and Human Services' (HHS) motion to dismiss. <u>Hill</u>, a case of first impression in the Second Circuit and only the second case of its kind in the nation, challenges HHS's method of determining widow and widower disability. Miles Esty'89 and Maureen Galvin'88 assisted in the case.
