ARRANGEMENTS: The above named subject was given a Polygraph Examination for the purpose of determining the truthfulness of his answers to the following questions.

Subject signed statements releasing all parties concerned and empowering this examiner to disclose to those in authority his opinions, as well as information elicited during said test.

PROCEDURE: A four-pen Stoelting polygraph was utilized to register changes in blood-pressure, rate and strength of pulse beat, galvanic skin response and the respiratory pattern.

BACKGROUND: Subject was born on October 6, 1947 in Cincinnati, Ohio. He came to New York in 1961 from Cincinnati and he presently resides at 158 Rutland Road, Freeport, New York, in a private house, with his parents. He has lived there for the past ten years, off and on. Subject is married and separated. His father, Orville, is a Night Watchman for the Sterling Last Corporation.

Subject is 5'9", 135 lbs. SS# 104-38-8007. Home telephone is (516) 868-5247.

ARRESTS: Subject stated that he was arrested approximately six times. He was arrested for: marijuana and hashish in Nassau County, two times; petty larceny (shoplifting), in Nassau County; possession of dangerous weapons, one being a sawed off shot gun and the other an inoperative pistol, two times in New York City; and driving without a license.

EDUCATION: Subject stated that he is presently attending the State University at Westbury. He has less than 40 credits and he is a Sociology major. He later stated that he wasn't attending this semester but that he would continue in January.

EMPLOYMENT: Subject has been employed at the Department of Drugs and Alcohol of Nassau County, as a Drug Counselor, for the past one year.

STATEMENT: At the time, and it was about seven years ago, many things intervened and my recollection may be vague about details. For example, I don't remember the car coming around the corner but I do remember the car at the scene. My description of the clothing may be inaccurate but the most important thing was that I was there. I had been high on speed (methadrine) and I hadn't slept for 36 hours. I had been sniffing methadrine the morning before and Dale and I had been up because we couldn't sleep.

Dale is 5'10", white, long curly hair. He is a New Yorker and he was attending high school at the time. He and his parents live in the Village area but he spent most of his time in the East Village. His

girlfriend lived there but I don't remember her name. I had known Dale one or two months before this and I would recognize him again.

The black man was younger than Maynard's picture and had lighter skin.

I told the story to people afterwards. I told Erline and her husband, Maurice Baker. I believe I told Eric Charles and also my wife and additionally Patricia Carty and Norman Pearsall.

At the scene, one of the policemen tried to question me. They questioned Dale and I walked away from the police.

The Marine was wearing greens and the Sailor was wearing whites. Everyone was on the sidewalk when the shooting occurred, I'm sure of this. I actually stood over the Marine, who got shot.

The following relevant questions were asked and the indicated answers given.



BIOGRAPHICAL SKETCH OF VICTOR C. KAUFMAN

Victor C. Kaufman, founder and Chief Examiner of New York Lie Detection Laboratories, (a division of The Sentor Security Group, Inc.), has personally conducted more than 10,000 Polygraph Examinations for business, industries, law enforcement agencies and attorneys since 1958.

He was graduated from St. John's University, Brooklyn, N. Y. in 1939 and received an LLB Degree.

He was a member of the New York City Police Department from June 1941 until April 1964, When he retired with the rank of Lieutenant, (Commander of a Detective Squad).

As Commanding Officer of Brooklyn South Homicide Squad, from 1958 to 1964, he personally investigated approximately 300 homicide cases using the polygraph in many of these investigations.

After retirement, he was an instructor in the Police Science Program at Brooklyn College from 1964 through 1966, lecturing in Law, Investigation, Administration and Interrogation. Recently, Mr. Kaufman has lectured at the New York City Police Department Security Conference, held at the New York City Police Academy, to the heads of security of a variety of businesses and major city and national corporations.

Mr. Kaufman is a Charter Member of the American Polygraph Association, and presently is Chairman of the Awards Committee. He was formerly a member of the Case Review Committee which cooperated with the late Earl Stanley Gardner in the Court of Last Resort. Currently he is the Chairman of the Board of Directors of the Polygraph Examiners of New York State, Inc., after having served as it's President during the fiscal year 1972-1973. His other professional memberships include, Society of Professional Investigators; National Law Enforcement Associates, Retired Detectives of the City of New York; Police Law Society, and Associated Licensed Detectives of New York State, of which he is a Vice President.

He is a licensed Polygraph Examiner, having received his license from the State of South Carolina in 1973.

For the past 15 years, Mr. Kaufman has attended all annual conferences and symposiums sponsored by the American Polygraph Association and the American Academy of Polygraph Examiners with the exception of two. These annual symposiums consist of four day educational-work programs in selected cities throughout the United States. Government; police and private examiners meet to discuss new techniques, up-dated procedures and current innovations. The 1970 Seminar was sponsored by the University of Southern California, Los Angeles; during 1971 De Kalb College was the host in Atlanta, Georgia; in 1972 De Paul College and Northwestern Law School were the co-sponsors in Chicago, Illinois; and Florida University, Division of Criminal Justice, supervised the Seminar in 1973. Specific lectures are presented by well known Attorneys, Professors of Law, Doctors of Medicine and Psychiatry, Psychologists, Physiologists, Polygraphists and Military Personnel, and provide the opportunity for group discussion and the exchange of ideas among all members of these participating disciplines.

Victor Kaufman is the author of numerous articles published in professional journals and security periodicals, as well as having been the subject of a variety of written profiles concerning his polygraph and police career in leading newspapers and popular monthly magazines.

He has appeared often as a polygraph expert on radio and television discussion programs. On November 30, 1972, Mr. Kaufman qualified as an expert on polygraph in the Eastern District United States Court, Judge Jack Weinstein presiding. His testimony was about to be admitted in evidence before a jury, when the United States Attorney, James Drucker, moved to dismiss the indictment in the case of United States versus Dioguardi.

Sworn, deposes and says:

1. This being given to Louis M Steel a lawyer for Wm. Maynard, at my office 47 E Fulton Ave, Rm 11, N.Y. Ralph Addonizio is also present.

2. The Maynard case was first brought to my attention a couple of wks ago when I was asked to sign a petition for his bail. Up until that time I did not know that anyone had been arrested or tried for killing the marine in Greenwich Village, more than 6 years ago.

3. I was in Greenwich Village when that shooting occurred, & saw both the argument which led to the shooting. And the shooting itself.

4.) The petition that I saw had a pic of Wm Maynard on it, and the person who was involved in the shooting of the marine was not the same man. There were 2 people involved in that shooting, one blk & one white. The Blk man was about the same age that I was at the time, which was 19. He was much darker than the man in the picture. The blk man appeared to be about my size, and I am 5'10", 135 lbs.

5.) I was sitting in the park between W 3rd St & W. 4 St. when the entire incident ~~occure~~ occurred. I was with a person I knew ~~as~~ only as Dale.

6.) I didn't tell the police after the shooting that I saw it because I didn't want to get involved. I am now willing to testify about what I saw because I am convinced that Wm Maynard, if he looks as he looks in the picture, I was shown, is definitely not the Blk man involved in the incident.

7.) I am making this statement of my own free will, & have agreed to take a lie-detector test,

8.) I will also be willing to tell the full

Story of what I remember occurring to the
D.A. or anyone else.
