JESSUP MOOT COURT TEAM WINS REGIONAL CHAMPIONSHIP
Advances to International Round in Chicago

New York Law School's team placed first in its regional round of the Philip C. Jessup International Law Moot Court Competition on February 17 in Camden, N.J. As Regional Champion, the team qualified to compete in the Competition's International Semifinal Round to be held in Chicago, April 1 - 8, where it will meet ten other U.S. regional winners and more than 50 teams from around the world.

In advancing through the Regional Round, the NYLS team of Sandra Corbitt, Hassan Fancy, Donna Farmer, Dennis Prahl and Pashko Vuksanaj bested teams from Seton Hall, SUNY-Buffalo, Rutgers-Newark as well as the defending U.S. National Champions from the Columbia University School of Law. They defeated Brooklyn Law School in the Regional Finals.

The Jessup Competition, sponsored by the International Law Students Association, centers on points of international law. The NYLS team won its regional competition arguing a complex fact pattern involving diplomatic immunity and the seizure of assets of an international organization.

This is the second moot court regional championship for New York Law School this winter. In December, a NYLS team defeated N.Y.U. in the regional finals of the National Moot Court Competition. A member of that team, Kannan Menon, served as student coach for the Jessup team. Professor Lung-chu Chen served as faculty advisor.

STUDENT ORGANIZATION POLICY COMMITTEE FORUM SCHEDULED

The student/faculty Student Organization Policy Committee appointed by Dean Simon to review the membership and leadership policies of student organizations at the Law School will hold open hearings on Friday, March 3, from 1 p.m. to 6 p.m. in the Moot Court Room, A301.

Those members of the New York Law School community who have submitted written position papers to the Office of Student Affairs will be scheduled to make an oral presentation and take part in a discussion of the views presented in the papers. All other members of the Law School community are welcome to attend and observe the hearings. Also, any member of the Law School community is welcome to submit a position paper to the committee regardless of whether he or she wishes to take part in the oral presentations.

After considering all presentations, the committee will report and make policy recommendations to the faculty.

"We hope that the Committee's proceedings will provide a forum for the entire NYLS community to exchange views on the important matters under consideration," said Professor Nadine Strossen who chairs the Committee. Other committee members are Professor Lung-chu Chen, Professor Aleta Estreicher, SBA President Agostinho Ribeiro, SOC Cochair Anthony Mazza and Assistant Dean Joan Fishman, ex-officio.

WAGNER MOOT COURT COMPETITION SET FOR MARCH 9 - 12

The Law School will host representatives from thirty-two law schools for the thirteenth annual Robert F. Wagner Sr. National Labor Law Moot Court Competition, March 9-12.

Preliminary rounds will take place on March 9 and 10, with quarter finals and semifinals on Saturday, March 11. The final round will be on Sunday, March, 12, at 11 a.m., in the Froessel Reading Room.

Judges for the final round will be Hon. Boyce F. Martin, Jr., Presiding Justice of the U.S. Court of Appeals for the Sixth Circuit; Hon. James M. Stephens, Chairman of the National Labor Relations Board; Hon. Patricia Diaz Dennis, Commissioner of the Federal Communications Commission and former member of the NLRB and Hon. John A. Penello, of the firm of Thompson, Mann and Hutson and a former member of the NLRB.

The issue to be argued concerns whether a purchaser of the assets of a failed business can be found to be a "successor employer" when the purchase occurs more than a year after the closure of the initial business and only a bare minimum of workers were employed by the previous owner.

The Competition has been organized by the Wagner Committee, chaired by students Lynn Daly, Linnea J. Ranucci, Randolph Frank Iannacone and Lynne Crawford. Professor Arthur S. Leonard serves as faculty advisor to the committee.

AMNESTY INTERNATIONAL TO PRESENT FORUM ON CAPITAL PUNISHMENT

The New York Law School chapter of Amnesty International will present a panel discussion on the death penalty on Monday, March 27 at 6 p.m. in the Faculty Dining Room. Panel members will include: Hon. Chris Mega, a member of the New York State Senate and the author of the most recent death penalty legislation to be passed by that body; Magdaleno Rose-Avila, Director of Amnesty International's National Death Penalty Program; Henry Schwarzchild, Director of the American Civil Liberties Union's Capital Punishment Project, and Ernest van den Haag, Professor of Law at Fordham University.

NEW YORK LAW SCHOOL FACULTY NEWS

Professor Robert Perry is co-drafting a brief in an American Civil Liberties Union suit asserting the free speech rights of the Ku Klux Klan to use public access cable television in Kansas City, Mo.

Professor Randolph N. Jonakait, was quoted in The New York Times, commenting on the distinction between manslaughter and murder in relation to the Joel Steinberg trial.

In April, Professor Nadine Strossen will present a paper on Justice William O. Douglas' religion clause decisions at a conference commemorating the fiftieth anniversary of his appointment to the Supreme Court, at the Douglas Institute at the University of Washington, Seattle, in April. She will also deliver the Law Day Convocation address at Southwest Missouri State University in Springfield, Mo. in May.

Professor B.J. George, Jr. has recently published an article entitled Federal Anti-Terrorist Legislation, in LEGAL RESPONSES TO INTERNATIONAL TERRORISM: U.S. PROCEDURAL ASPECTS, 25-88 (M.Bassiouni ed., Martinus Nijhoff Publ. 1988).

Professor Stephen Newman's article, "The Latest on Tenants' Rights", appeared in the December issue of New York Magazine. In addition, his article entitled, "Baby Doe, Congress, and the states: Challenging the Federal Treatment Standard for Impaired Infants", has been accepted for publication by the American Journal of Law & Medicine.

Professor Arthur Leonard will speak on "AIDS and the Workplace" March 1st at Seton Hall University School of Law, Newark, New Jersey and March 23 at the University of Michigan Law School, Ann Arbor, Michigan. He will participate in a conference, "Sexual Orientation and the Law: Implications for Legal Education" April 8-9 at Harvard Law School, Cambridge, Massachusetts, and will attend the American Psychiatric Association's Annual Meeting and Symposium on "Overcoming Stigma: Homophobia and Heterosexism" May 8 in San Francisco, California.
