MOOT COURT NEWS...

The John Marshall Harlan Moot Court Competition is now underway. Twenty teams have signed up for New York Law School's annual intramural criminal law competition. This year's participants will argue issues concerning the admissibility of evidence recovered from a communal trash bin and whether police have a duty to inform a defendant of the nature of the crime for which he/she will be questioned. Mr. Sean Dwyer and Ms.Helen Miller are the authors of this year's Harlan fact pattern. Following is the schedule of dates for this year's Competition:

Priliminary Rounds - Monday 9th through Friday 13th; Quarter Finals - Tuesday 17th; Semi-Finals - Thursday 19th; and Finals - Tuesday 24th.

The Committee invites interested students (particularly, First-Year students), to consider being a part of this most important Competition. It's a good way to get invaluable "competition experience." The Robert F. Wagner, Sr., Memorial Moot Court Competition will be held Thursday, March 26th through Sunday, March 29th. This year's fact pattern addresses timely issues in current conflict among the U.S. Circuit Court of Appeals. The Wagner competitors must resolve those issues which concern the effect of a no-strike clause in a collective bargaining agreement, and whether this constitutes a waiver of the right to participate in a sympathy strike as well as the National Labor Relations Board's present standards regarding deferral to an arbitrator's decision.

With the issues being debated and the schools and jurists participating, this year's Wagner Competition promises to be an exciting and informative competition. Students are welcome to sit-in on any of the arguments. Also, anyone interested in timekeeping, can sign up in the Moot Court Office, A402. Following is the schedule of dates and times for the competition:

<u>Opening Rounds</u> - Thursday and Friday, March 26 and 27th; Saturday, March 28th, <u>Elimination Round</u> - 10:00 a.m. to 12:00 noon, <u>Quarter-Finals</u> - 1:00 - 3:00 p.m. and <u>Semi-Finals</u> - 5:00 - 7:00 p.m.; Sunday, March 29th, <u>Finals</u> - 12:00 noon - 2:00 p.m.

STUDENT CLERKSHIP PROGRAM: STATE COURTS

There will be a meeting for all students interested in student clerkships in the state courts for the Summer 1987 or Fall 1987 semesters. The meeting will be on Tuesday, March 24th at 5 p.m. in room A301. At this meeting, the application process and the student clerkship program will be explained. Students are encouraged to ask questions about the program.

Opportunities will be available for students to be placed as student clerks to judges in the New York State Supreme Court, the New York Surrogate's Court, the New York Family Court, the New York City Civil and Criminal Courts, and the New Jersey Superior Court. Judges expect a commitment of 25 to 30 hours per week during the summer and 15 hours during the fall. It is possible to receive academic credit for serving as a student clerk.

Students interested in applying for the program for either the summer of fall semesters should:

- Bring five (5) copies of an up-to-date resume to the meeting of March 24th or submit five (5) copies of their resume to Amy Grossman's office prior to the meeting on March 24th.

- Pick up a copy of the memo outlining, in detail, the Student Clerkship Program and the application procedures and requirements (copies available in the Placement Office and in Ms. Grossman's office).

Professor Peter Margulies gave a presentation at the Brandeis University National Women's Committee (Gotham Chapter) on the topic "Pornography and the Law," last month. His article, "Pandemonium Between the Mad and the Bad: Procedures for the Commitment and Release of Insanity Acquittees after Jones v. United States," 36 Rutgers L. Rev. 793 (1984), has been cited in Ellis, "The Consequences of the Insanity Defense: Proposals to Reform Post-Acquittal Commitment Laws," 35 Cath. U.L. Rev.

Professor Robert Perry was guest speaker last month at the annual INTV convention held in Los Angeles. INTV is the trade association for independent television stations. The panel on which he spoke included a member of the U.S. House of Representatives and was moderated by Dean Burch, a communications lawyer who formerly was Chairman of the Republican National Party. The topic was "monopolistic practices in the cable industry." Professor Perry discussed, in particular, the Media Law Clinic's antitrust lawsuit on behalf of cable subscribers in lower Manhattan against Manhattan Cable Television, Inc., Home Box Office, Inc. and Time, Inc. (the "Time defendants"). In addition, he appeared before a panel in the U.S. Court of Appeals for the D.C. Circuit on behalf of the American Civil Liberties Union in American Civil Liberties Union v. FCC (and consolidated cases) argue against the FCC's to decision permitting deregulation of basic cable service rates in most communities within the United States.
