Independent Redistricting Commission Announces Commission Timeline

The NYS Independent Redistricting Commission (IRC) has begun deliberations to come to a consensus on final maps.

The Commission will provide updates to the public on Wednesday, December 22nd.

The Commission will meet again on Monday, January 3rd at 11:00 AM to consider and vote on the congressional, senate, and assembly maps to be sent to the state legislature for consideration. The location will be announced soon.

Capitol Pressroom Interview with Jack Martins: Redistricting Effort Faces Time Crunch and Partisan Obstacles

In less than a month, the state's bipartisan redistricting commission is planning on adopting their final legislative boundaries for New York's state and congressional district lines. Dave Lombardo at the Capitol Pressroom spoke with the commission's vice chair, Jack Martins. He spoke about the timeline in which the Commission plans to have maps and a report ready to have a vote on maps on January 3. He stated the Commission has been setting up workgroups aiming to come to a consensus with maps. He also expressed how much information the Commission was able to receive from New Yorkers who participated in the process. Martins expressed concerns about the legislature attempting to circumvent the recent defeat of Proposition 1 and draw their own lines.

Urban Institute Report: Census Undercounts Cost New York One Congressional District

The Urban Institute has produced new information on the 2020 Census, possible undercounts, overcounts, miscounts, and consequences for fairness in apportionment and funding. The findings include:

■ a projected 2020 Census undercount of 224,638 New Yorkers, reflecting that 1.1% of the state's population was not officially counted.

- a net undercount of 5.48% fewer children under age 5 in the state than were officially counted.
- a net undercount of Black residents by 3.14%, a net undercount of 2.48 % for Hispanic residents, and a net undercount of 0.04% for White, non-Hispanic/Latinx residents.
- a net undercount of 3.88% for people living in households that had at least one noncitizen.
- a net undercount of New York-Newark-Jersey City's total population by 240,989

Based on the Urban Institute's overall finding, New York State would not have lost a congressional district had such undercounts not occurred. The report can be accessed at: https://urbn.is/3Dlpk4w

LATFOR Vacancy

Assemblyman Robert Rodriguez resigned from the State Assembly last week, creating an Assembly Co-Chair vacancy in the Legislative Advisory Task Force on Demographic Research and Reapportionment (LATFOR). Rodriguez has been named by Governor Kathy Hochul to serve as the next Secretary of State. Speaker Carl Heastie is expected to fill the vacancy.
