SUBPOENA FOR A WITNESS TO ATTEND THE GRAND JURY.

YOU ARE COMMANDED to appear before the Grand Jury of the County of New York, at the Grand Jury Room, in the ninth story of the Criminal Courts Building, at 155 Leonard Street, between Centre and Baxter Streets, in the Borough of Manhattan, of the City of New York, on the *13* day of *March*, 19*69*, at the hour of 1:30 in the afternoon of the same day, as a witness in a criminal action prosecuted by the People of the State of New York against *Wm. Maynard*

and for a Failure to Attend you will be deemed guilty of a Criminal Contempt of Court, and liable to a Fine of Two Hundred and Fifty Dollars and Imprisonment for thirty days and to be prosecuted and punished for a misdemeanor.

When you arrive at the witness room, hand this subpoena to the attendant at the door.

The Grand Jury calls witnesses in whatever order its foreman pleases. The foreman knows best for the public good. If you wait patiently on the day of attendance until your turn comes, it may save you waiting hereafter.

If the Grand Jury adjourns, and you have not been called and no explanation has been made of the failure to call you, inquire of the Grand Jury clerk if you are wanted again and when.

A witness is entitled to fifty cents for each day's attendance; and if he resides more than three miles from the Court House, to eight cents for each mile, going to the place of attendance. Mileage is payable only within the boundary line of the State of New York.

SPECIAL NOTICE TO POLICE OFFICERS

Officers are requested to furnish the District Attorney, or his Assistant having this case in charge, all information obtainable relating to the defendant and his history. Furnish records of any prior arrests or convictions.

SPECIAL NOTICE TO WITNESSES

Complainants and witnesses should report to the District Attorney or his Assistants any attempts to intimidate them or induce them not to appear as witnesses.
