NYLS 1987 OTTO L. WALTER INTERNATIONAL DISTINGUISHED FELLOW

New York Law School is proud to announce the visit of Judge Stephen M. Schwebel of the International Court of Justice, The Hague, as our second Otto L. Walter Distinguished International Fellow.

The Otto L. Walter International Fellows program became an integral element of the Law School's curriculum in Comparative and International Law in the Spring of 1986. Made possible through the generosity of Dr. Otto L. Walter '54, a distinguished alumnus, adjunct faculty member and prominent author in the field of International Law, the program brings scholars, practitioners and public officials in the international field to the Law School for substantial dialogues with students, faculty and guests.

A native of New York, Judge Schwebel earned his B.A. from Harvard College in 1950 and his LL.B. from Yale Law School in 1954. From 1954 to 1959 he practiced law with the New York firm of White & Case. He joined the faculty of Harvard Law School in 1959, where he served as an assistant professor until joining the U.S. Department of State as Assistant Legal Adviser in 1961. During the next twenty years, Judge Schwebel served in several capacities at the State Department, including Consultant, Counselor on International Law and Deputy Legal Adviser. He represented the United States before the International Court of Justice in several cases during these years, including U.S. v. Iran, which eventually led to a condemnation of Iran's seizure of the American hostages. Judge Schwebel was elected to the International Court of Justice in January, 1981, by the United Nations General Assembly.

On Tuesday, April 7th at 4:30 p.m., Judge Schwebel will hold an Open Student/Faculty Forum in the Student Lounge.

STUDENT CLERKSHIP PROGRAM: STATE COURTS

Opportunities are still available for students to be placed as student clerks to judges in the New York State Supreme Court, the New York Surrogate's Court, the New York Family Court, the New York City Civil and Criminal Courts, and the New Jersey Superior Court. Student clerks are generally expected to commit between 25 to 30 hours a week during the summer semester and between 12 to 15 in the fall semester at their placement. You may receive academic credit for serving as a student clerk.

Interested students should attend a meeting scheduled for Monday, April 6th at 5:00 p.m. in the Moot Court Room. At this meeting, the application process and the student clerkship program will be further explained. Students interested in applying for the program for either the summer of fall semesters should:

- Bring five (5) copies of an up-to-date resume to the meeting of April 6th <u>or</u> submit five (5) copies of their resume to **Amy Grossman's** office <u>prior</u> to the meeting of April 6th.
- Pick up a copy of the memo outlining, in detail, the Student Clerkship Program and the application procedures and requirements (copies available in the Placement Office and in Ms. Grossman's Office).

LIBRARY NEWS

A new exhibit has been put on display in anticipation of the upcoming Otto L. Walter International Distinguished Fellow Program. The display, located in the lobby of 57 Worth Street near the Froessel Room, highlights the career of this year's Otto L. Walter Distinguished Fellow, Judge Stephen M. Schwebel, a member of the International Court of Justice.

Also on display are new additions to our Supreme Court photograph collection -- a group photograph of the new Supreme Court and an individual color photograph of Justice Scalia, on display on the 2nd floor in the Library. Our first floor collection of Supreme Court Chief Justice photographs now includes a black & white photograph of Chief Justice Rehnquist.
