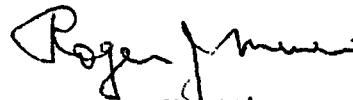

Northern District I was Acting pro se and was
under the Assumption that A Counsel would be
Appointed to my case. From the understanding I
Recieve from the 1983 forms was to give A brief
Summary of what happen. I honestly didn't know
I was suppose to present All Issue at that time. To
give you A brief Summary of what happen I was
the victim of An Assault I was At Oneida Correctional
Facility on the night of June 6, 1991 in "K" dorm
building 16 I got into A Argument with Another
inmate who's Name Thomas Mannors over A Fan I
was A small squabble in which Apologized 1992

giving at approximately 3:20 AM June 7, 1991
I Awoke screaming in which I also woke the
majority of the house, Upon my waking I
notice the inmate I previously had the argument
with was backing out of my cube by this time I
proceeded to get out of my bed towards Thomas
MANNON At this time I notice my chess was
shining as well as my bed was wet and also a
Hot pot was lying on my bed me and Thomas
MANNON proceeded in a tussle in which I was stab
in my left shoulder I would say ten minutes
had gone by in which an officer had finally arrive
to the back section, what I would like to argue
is that the officers that were on duty were sleeping
I have witnesses as well as officer Fizey that
was on duty that night may I joke out of it
to me whereas he quoted I Awoke him from
his sleep

Medical upon my entering into the ONEIDA
INFIRMARY there was no Doctor present, why was I
not sent out to a burn unit or the nearest
hospital I HAD Cook hot baby oil and through it
ON ME this hot oil went into my left ear At
this present moment of time I have a hearing problem
A loss of hear, I also would like to ~~note~~ ^{Note} I'm
going through constantly ear Aches I Am awaiting
to under go surgery I've been going through for
almost A year of ear draining. During my stay in
ONEIDA INFIRMARY my second and third week I complain
of not being able to hear I was told time
after time there was nothing wrong with my ear
I thank you for your time
