We wish to break the cycle that is causing our youths to enter these prisons at such an alarming rate.

The reason that I am writing you is because our organization would truely appreciate an opportunity to correspond with
you and other individuals that share our goals for these communities. We wish to open a forum to discuss ways to improve
conditions inside and outside of prisons and implement these plans.
We would like and appreciate if you were involved in some form of
fashion. Even if it's just advice and words of wisdom. If not
you, personally, then hopefully a representative of your office
will have the time to share ideas with us.

As I've stated, the lifers is formed by our members to impart a positive change within ourselves and others. One way to do so is by reaching out to people to create a forum to come up with programs here inside of prison and also outside of them. One idea for such a program is something to improve community & police officer relations, in which officers and members of the community can get together to discuss ways to build better communications between one another. Pinic with the Police was a program during the summer in Syracuse, N.Y. that took place annually during the 90's: It would bequeent to start that type of program once again in neighborhoods across New York State. Another program that we envision could be some type of youth apprenticeship in law firms, Judge's offices, police stations, . colleges, and other places to inspire youths to look into these areas as options for a career. It would also be something creative and constructive for teens & young adults to do instead of being out in the streets with nothing but time on their hands. Those
