HARLAN CONFERENCE HIGHLIGHTS CENTENNIAL CELEBRATION

An all-day conference on Saturday, April 20, on the judicial career of U.S. Supreme Court Justice John Marshall Harlan '24, will be the centerpiece of activities celebrating the Law School's centennial. In addition to the conference, Alumni reunion receptions with an emphasis class years ending in "1" and "6", and the annual Harlan Fellowship Dinner will take place that day.

John Marshall Harlan, Associate Justice of the United States Supreme Court from 1954 to 1971, ranks high among the most influential members of the modern Supreme Court. After his graduation from the Law School in 1924, Justice Harlan earned a formidable reputation as a trial lawyer with the New York firm now known as Dewey, Ballantine, Bushby, Palmer & Wood. This reputation and stints as Assistant U.S. Attorney for the Southern District of New York and counsel to the New York State Crime Commission helped him become appointed to the U.S. Court of Appeals for the Second Circuit in 1954. Nine months later, he was elevated to the U.S. Supreme Court by President Dwight D. Eisenhower.

Three panels of distinguished legal scholars and members of the judiciary will address the following topics: Justice Harlan as a Judicial Conservative, Justice Harlan and the Bill of Rights and Justice Harlan's Legal Process: Judiciability, Civil Procedure, and Remedies.

The panel members are: Chief Judge James L. Oakes and Judge Roger J. Miner, U.S. Court of Appeals, Second Circuit; Professor Norman Dorsen, New York University School of Law; Professor Bruce Ackerman, Yale Law School; Professor Charles Fried, Professor Martha A. Field, and Professor Charles R. Nesson, Harvard University School of Law; Professor Kent Greenawalt, Columbia University School of Law; Professor Gerald Gunther, Stanford Law School; Professor William W. Van Alstyne, Duke University School of Law; Dean Jesse H. Choper, University of California at Berkeley School of Law; Professor Nadine Strossen and Professor Donald Zeigler, New York Law School; Charles Lister, Esq., Covington & Burling; and David L. Shapiro, Esq., Deputy Solicitor General, U.S. Department of Justice.

HOUSING CLINIC REPRESENTING COALITION AGAINST MANUFACTURERS HANOVER

The New York Law School Housing Law Clinic, on behalf of a coalition of community-based organizations, filed a Community Reinvestment Act challenge against Manufacturers Hanover Trust's proposed acquisition of 11 Goldome Bank branches. The challenge prepared by Professor Richard Marsico and Housing Law Clinic students Maria Fernandez-Gomez and Rhonda Cooper, alleges that MHT has made a minuscule number of home mortgage loans in Harlem compared to similarly situated white neighborhoods. The challenges also asserts that MHT's continuing ties to South Africa harm MHT's ability to work with community groups and other African-American and Latino communities. The challenge, which was covered by numerous media including the New York Times and American Banker, is pending before the Board of Governors of the Federal Reserve System.

Professor Michael Botein spoke at the National Engineering Consortium on March 15 in Phoenix, Ariz. on "Regulatory Trends in Telecommunications for 2021 A.D."

Professor David Chang has been appointed Visiting Professor of Law at the Georgetown University Law Center for the fall 1991 term, teaching constitutional and criminal law.

Professor Seymour I. Feig, Media Counsel to the Radio and Television Commission of the Southern Baptist Convention, will conduct a seminar for the station managers and cable operators who receive programming from the American Christian Television Service at their yearly meeting in Fort Worth, Tex. on April 25th and 26th. He will speak on the most recent cases involving cable operators and music performing rights societies and will discuss packaging of family programs for use over the ACTS Network and the Family Television Network which has recently become affiliated with the ACTS Network.

Professor B.J. George's case notes on Yates v. Evatt, 1990-91 Term Preview of United States Supreme Court Cases 185-87 (Issue No. 4, February 19, 1991) were published in the ABA Preview of United States Supreme Court Cases.

Professor Lawrence Grosberg's "Defining Clinical Scholarship," was published as the introduction to the New York Law School Law Review colloquium issues on clinical education. He spoke at the New York State Division of Human Rights conference on March 7 on the subject of fair lending requirements under the Community Reinvestment Act.

Professor Karen Gross spoke at Community Legal Services in Philadelphia on February 11 on women debtors. She was on the faculty of the Federal Judicial Workshop for Bankruptcy Judges held in Hilton Head, S.C. on February 25, speaking on "Set-off and Recoupment: A Difference With or Without Distinction?" She will speak to bankruptcy judges on the same topic in Mystic, Conn. on May 13. She will serve as a group leader at the Seventh Annual Retreat of the Southern Florida Bar Association on May 2-5. She will speak at the National Bankruptcy Judges Conference being held in San Francisco on October 30 through November 2 on recent developments in consumer bankruptcy.

Professor Allen Hammond was quoted in the February 28 New York Times on a recent F.C.C. ruling approving applications by three major cable companies to build experimental telephone networks.

Professor Randolph Jonakait was interviewed on WCBS-TV Channel Two News on February 18 on the case of an abused woman who killed her father and on March 8 on the battered wife defense. He was panelist at the Cardozo Law School conference, "Decision and Inference in Litigation," on March 24.

Professor Arthur Leonard was interviewed on radio station WFAS-AM on March 21 about the new

City Bar Association Committee on Lesbians and Gay Men in the Legal Profession, of which he is cochair. He was quoted in the April 1991 issue of <u>American Health</u> on the subject of HIV-infected health care workers. He was quoted in the March 27 <u>New York Times</u> on Montefiore Medical Center of the Bronx becoming the largest private employer in the nation to provide the same health benefits to homosexual workers and their partners as for heterosexual employees and their spouses.

Professor Jethro K. Lieberman has signed a contract with Random House for a book entitled <u>The Almanac of the American Constitution</u>, a comprehensive single volume reference on the Constitution to be published in December 1992.

Professor Richard Marsico spoke at the New York State Division of Human Rights conference on March 7 on the subject of fair lending requirements under the Community Reinvestment Act.

Professor Michael Perlin's article "Fatal Assumption: A Critical Evaluation of the Role of Counsel in the Trial of Mental Disability Cases," will be published in a special symposium issue of <u>Law and Human Behavior</u>. The paper is an expansion of remarks he made at the National Center for State Courts' Symposium on Interactions Between the Legal and Mental Health Systems, held last November in Arlington, Virginia. His book review essay of Ann Braden Johnson's <u>Out of Bedlam: The Truth About Deinstitutionalization</u>, entitled "The Myths of Social Discourse: Making Sense of the Relationship Between Homelessness and Deinstitutionalization," will appear in the upcoming issue of the <u>N.Y.L. Sch. J. Hum. Rts.</u> He will present a paper this summer at the annual meeting of the American Psychology-Law Society on "Tarasoff and the Dilemma of the Dangerous Patient: New Directions for the 1990's."

Professor Stuart Schlesinger's article "Discovery in Design-Defect Cases" appeared in the Product Liability Column of the March 20 New York Law Journal.

Professor David Schoenbrod will speak at the Indiana University School of Law on April 10 on the topic of his book in draft, "When Congress Delegates, Does the Public Lose."

Dean James F. Simon will deliver Manhattan College's Robert Christen Lecture, entitled "The Rehnquist Court and the Future of the Bill of Rights," on April 18.

Professor Nadine Strossen appeared on Law Line, which will be broadcast on Manhattan & Paragon Cable, CTV-Staten Island, and UA Columbia Cable throughout March. She spoke at the Providence Journal/Brown University Public Affairs Conference on March 13 and was quoted in the March 18 Chicago Tribune on hate speech on campus.
