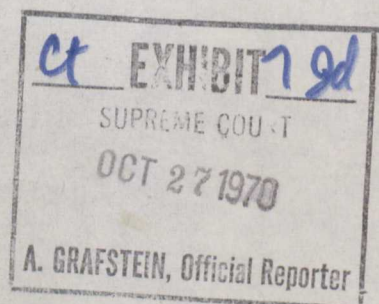

1. The undersigned received confidential information relative to this case.

2. Information discloses that this homicide was committed by one Andy Bones, AKA Eddie Bones, Male negro 5'9", 135 lbs, brown skin, heavy lips, lots of head hair, uses drugs and lives on the East Side of lower Manhattan. He frequents the area from 292 to 304 East 3rd Street. Also a Bar & Grill known as the "Hole" located on 11th Street and near Ave B. This man is alleged to have done the actual shooting. He is armed with 12 ga Sawn Off Shotgun and a .32 cal. automatic pistol. The second perpetrator is Male white, 20's who is described as about 5'10" tall and has light sandy hair. His first name is Lawrence and he is known as "Lennie" and until a short time ago lived in the Broadway Central Hotel with an unknown girl. When last seen Andy Bones was wearing tight black pants and a black shirt.

3. Information discloses that after the shooting the two perpetrators fled in different directions but made plans to meet later at the Broadway Central Hotel.

4. Information discloses that both perpetrators are friends of a girl by the name of Carol who works at "H" Pizza Shop on West 3rd Street and 6th Ave. This girl is female white, 5'10" tall, blue eyes, blond hair and about 20 years old. This girl resides at the Wolcott Hotel, located at 10 West 31th Street, N.Y.C. She lives at this hotel with two other girls, named "Cathy" and "Tonie". Tonie is described as female, part chinese, black hair and about 19 years old.
5. Information discloses that Andy Bones fled scene on foot, crossed Sixth Ave. going East, made a left turn and ran North up Mac Dougal Street and fled East across Washington Square Park and came out of the Park at the Wooster Street & Washington Square South Exit. He then fled South to Wooster and West 3rd Street at which time he took sawed off shotgun out of paper shopping bag and but sawed off shotgun under his jacket. He then went through Court Yard at # 1 Washington Square ~~xxxx~~ Village going South and came out on Bleecker Street. He then went East on Bleecker Street till he came to Broadway and made a left hand turn around corner to Broadway Central Hotel.
6. Both perpetrators met at the Broadway Central Hotel and went to the room of a male negro, about 50 years old who is confined to a wheel chair.
7. Both perpetrators then left the Broadway Central Hotel and got into a taxi cab at Bond Street and Broadway.


