

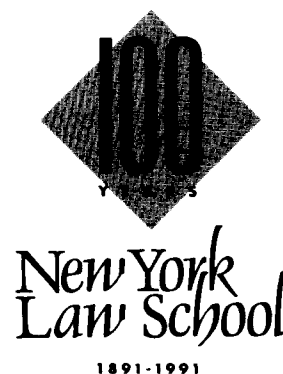

Begun in 1988, the Stiefel Symposium brings together a distinguished panel to discuss timely and important topics of interest to attorneys practicing foreign and international law. This year's panel includes leading specialists of Eastern Europe from academic and legal communities.

#### **EXHIBIT TO HONOR BLACK HISTORY MONTH ON DISPLAY IN MENDIK LIBRARY**

The Mendik Library is proud to sponsor "Blacks and the United States Constitution," an exhibition which will be on display in the Froessel Reading Room, located on the first floor of the Library, through February 28. The exhibit, which is an overview of the pivotal role of race in American Constitutional history, is on loan from the Shomburg Center for Research in Black Culture of the New York Public Library.

The exhibit is made up of fifteen panels, with text and illustrations, and portrays the black presence in America, the dynamics of race relations in the United States, as well as the role of black freedom struggles in American constitutional history. Highlights of the exhibit include proceedings of the nineteenth century black conventions; David Walker's fiery Appeal using natural rights philosophy

to justify slave violence in pursuit of freedom; Secretary of State William H. Seward's signed certificate attesting to the ratification of the Fourteenth Amendment; and the Supreme Court's formal judgment in Brown v. Board of Education.

**FIRST-YEAR LEXIS TRAINING SESSIONS HELD IN MENDIK LIBRARY**

The Mendik Library will be offering training sessions in both Lexis and Westlaw, computer assisted legal research databases, to first-year students beginning the week of January 27th and ending Friday, February 14.

Each day, several instruction sessions will be offered, each session lasting one and a half hours. These sessions will provide an introduction to the databases. At the conclusion of the session, personal passwords and software for home computer access will be available.

As the training rooms contain ten terminals, attendance will be limited to ten persons. The complete session schedule, along with sign up sheets, are available at the Library circulation desk.

**CENTENNIAL EXHIBIT RELOCATES TO MENDIK LIBRARY**

The New York Law School Centennial Exhibit, which made its debut at the New York State Supreme Court Building on September 9, 1991 is now on display on the third floor of the Mendik Library.

Following its run at The Supreme Court Building, the exhibit was relocated to the New York County Lawyers' Association, before a one-night stand at the Grand Hyatt Hotel for the Centennial Dinner Dance. The exhibit was then moved to the New York State Department of General Services at 80 Centre Street.

An outcome of many months of research, the exhibit traces the 100-year history of the Law School through pictures, newspaper articles, memorabilia and artifacts, many donated by alumni.

**Professor Martin B. Pavane** has been associated with the firm indicated of Cohen, Pontani, Lieberman & Pavane since January 1st.

**Professor Rudolph Peritz** has been invited to participate in a conference on "The Emerging Convergence of Progressive Legal Theory and Practice" at the University of California, Hastings College of Law in late February. The Hastings Law Journal will publish a theme issue in the spring.

**Professor Michael Perlin's** paper on "Sanism" which he presented at the AALS Section on Law and Mental Disability earlier in January at the annual convention in San Antonio, will appear this summer in a special symposium issue on Psychological Jurisprudence in the S.M.U. Law School's Law Review. His article, "Psychiatry and the Homeless Mentally Ill" A Reply to Dr. Lamb, co-authored with Dr. Douglas Mossman, will appear in an upcoming issue of the American Journal of Psychiatry. In December, he served as a member of a pro bono panel of law professors and Supreme Court litigators assisting in the pre-argument preparation of Riggins v. Nevada, a death penalty/insanity defense/medication refusal case argued before the U.S. Supreme Court in January. He is also serving as a member of the manuscript peer review panel for a special issue of Behavioral Sciences & Law on Criminal Competencies.

**Professor E. Donald Shapiro** was quoted in Time magazine's November 11th cover story "Nowhere to Hide" on privacy rights. This article was read over the 'In Touch Networks,' a radio program whose reporters read current news to the visually and physically print-impaired public.

**Professor Martin E. Silfen's** second edition of "Law and Business of the Entertainment Industries," which he co-authored, was published in December. First published in 1987, the text is being used in over 50 law schools throughout the United States and Canada. He addressed the Foundation for Accounting Education on December 9th as part of an Advanced Litigation Seminar on domestic relations and litigation support. On December 20th, his article, co-authored with his law partner Janna Glasser, on "Licensing of Managers Cuts Both Ways" appeared in the National Law Journal.

**Professor Nadine Strossen** appeared on NBC Nightly News talking about free speech on campus on December 10th. On the December 11th, she gave a lecture on "The Supreme Court and Privacy," at a meeting sponsored by the ACLU and the American Jewish Congress in Dallas, Texas. On December 14th, she was a panelist on a panel sponsored by the American Bar Association on free speech, sponsored by PBS-TV. On December 18th, she was a panelist for the Federal Bar Council program on "The Bill of Rights - Where Is It Going?" in Philadelphia, Pa. On December 19th, she debated Brooklyn College Sociology Professor Robert Brannon on "Rights and Conflicts Within the Women's Movement" focusing on pornography on the American Jewish Committee Women's Network in New York City. On the same day, she appeared on PBS's Charlie Rose Show, "The Treatment of Women by the Legal System" with co-panelists Linda Fairstein, sex crime prosecutor and NOW attorney Ruth Jones.
