# MAYOR DINKINS TO OFFICIALLY OPEN MENDIK LIBRARY RIBBON CUTTING CEREMONY ON APRIL 5

On Thursday, April 5, New York Law School will officially open the Mendik Library with a ribbon cutting ceremony featuring Mayor David N. Dinkins. Mayor Dinkins will be joined by the former mayors Robert F. Wagner, Jr. and Edward I. Koch, as well as many local politicians and members of the legal community as special guests.

Dean Simon, Board Chairman Bernard Mendik and Mayor Dinkins will speak in the Froessel Reading Room at 11:00 a.m., followed by the ribbon cutting at the main entrance to the Library at 11:45 a.m. All members of the Law School community are welcome to assemble for the ribbon cutting and receptions to follow. Due to the limited capacity of the Froessel Room, a limited number of seats will be set aside for students. Seats may be reserved at the Office of Development and Public Affairs, 6th Floor, 57 Worth Street. All others are invited to view the proceedings via closed circuit television in the Student Lounge, where refreshments will be served.

#### LEFRAK MOOT COURT ROOM UNDER CONSTRUCTION

Renovation of the space left vacant by the relocation of the library began on March 16. Construction has begun on the first and second floors of 53 Worth Street, and the eighth floor of 57 Worth. The work is expected to require eight weeks to complete.

The centerpiece of the 53 Worth Street project is the Samuel J. and Ethel LeFrak Moot Court Room, a gift of Samuel J. LeFrak, chairman of the LeFrak Organization and a Trustee of the Law School. The room will be constructed on the first floor, providing a realistic setting for students to sharpen their oral argument skills and for the Law School to hold moot court competitions. Other features of the renovation will include a video center as well as offices for students and faculty.

Space on the eighth floor of 57 Worth Street is being converted to offices and work rooms for student journals and publications.

#### CONFERENCE ON STATE SPONSORED MASS MURDER SET FOR APRIL 3

The New York Law School Journal of International and Comparative Law will sponsor "Crime and Punishment: Accountability for State Sponsored Mass Murder" on Tuesday, April 3 in the Faculty Dining Room. The symposium is made possible by the Ernst C. Steifel Fund and is presented in cooperation with the Boston College Law School Holocaust/Human Rights Research Project.

The program will bring together prosecutors and scholars to discuss the implications of prosecuting the crime of mass murder perpetrated by state actors. European prosecutors of World War II-era mass murders join with Latin American colleagues currently prosecuting state crimes.

The first panel, "Prosecutions of State Sponsored Mass Murder: Five Case Studies," on the reasons for and the ramifications of punishment will be from 2:15 to 4:15 p.m. The panel members include Benjamin Ferencz, former prosecutor, the Nuremberg Trials; Walter Griebel, senior public prosecutor, Frankfurt, the Federal Republic of Germany; Hon. Elizabeth Holtzman, comptroller, the City of New York; and Luis Moreno Ocampo, chief prosecutor, Federal Republic of Argentina. Professor Lung-chu Chen will moderate.

From 4:30 to 6:30 p.m., the second panel will discuss "When There is No Punishment: Barriers to Criminal Accountability - Amnesties and Pardons." Panel members will include Mr. Ocampo; Roberto Garreton Merino, legal advisor of the Vicaria, Chile; Felipe Michelini, human rights activist, Center for the Study of Legal and Social Issues, Uruguay; Jaime Malamud-Goti, former state solicitor, the Republic of Argentina; and Professor Alejandro Garro, Columbia University School of Law. Professor Ruti Teitel will moderate. A reception will follow the second panel at 6:30.

#### HUMAN RIGHTS SYMPOSIUM TO EXAMINE SUPREME COURT DECISIONS

The Journal of Human Rights will sponsor a symposium on Monday, April 23, 1990 on recent United States Supreme Court decisions and their impact on affirmative action, employment discrimination and civil rights.

Symposium panel members include Samuel Rabinove, The American Jewish Committee; Dianne E. Dixon, the Center for Law and Social Justice; Professor Merrick T. Rossein, CUNY Law School at Queens College; Julian Birnbaum, Valdeck, Waldman, Elias & Enselhard; Frank Deale, Staff Attorney for Constitutional Rights; Judith Reed, assistant counsel, NAACP Legal Defense and Education Fund; and Professor Denise S. Carty-Bennia, Northeastern School of Law.

The program will be held in the Froessel Reading Room from 10:00 a.m. from 4:30 p.m. and a reception will follow.

#### NEW YORK LAW SCHOOL FACULTY NEWS

Professor Carlos Cuevas was quoted in an article on the legal issues of the cash bonuses paid by Drexel Burnham Lambert in the March 1 <u>New York</u> Law Journal.

Professor George Dent's article, "Toward Unifying Ownership and Control in the Public Corporation," was published in the 1989 <u>Wisconsin Law</u> <u>Review</u> (pp. 881-924). A previous work was cited by the New York Court of Appeals in Ware v. Valley Stream High School District

Professor Aleta Estreicher's article, "Securities Regulation and the First Amendment" will be published in the <u>24 Georgia Law Review 223</u>. She will be participating as a discussion leader in "The Voices of Women," a conference on women in legal education at NYU School of Law on April 20-21.

Professor Seymour I. Feig was interviewed by WNYE-TV's Telecommunications and Information Revolution series. The program, will appear on the Paragon and Manhattan cable system on channel C on April 5 at 4:30 p.m. and channel D on April 2 at 8:00 p.m.

Professor Karen Gross spoke at a Federal Judicial Center training session for bankruptcy judges on March 8 on the topic, "Women Debtors: Who are They and What Questions Should We Begin to Ask About Them." She will repeat the speech at another training session in Nashville in May. She has been asked by the American Law Institute- American Bar Association Committee on Continuing Education to participate in a video tape to be distributed to lawyers on personal bankruptcy. She will participate in the 15th annual Stetson College of Law Bankruptcy Seminar to be held December 7-8, 1990 Tampa, Fla. Her article on Bankruptcy and the Thirteenth Amendment is expected to appear in the <u>Notre Dame Law Review</u> in April and she expects a book review/essay to appear in the <u>Michigan Law Review</u> in June.

Professor Randolph Jonakait was interviewed by WCBS-TV on February 27 discussing the "battered wife's defense" in a murder case. His article, "The Supreme Court, Plain Meaning, and the Changed Rules of

Evidence" was published in the <u>68 Texas Law Review 745</u>. An earlier article, "When Blood is Their Argument: Probabilities in Criminal Cases, Genetic Markers, and Once Again, Bayes' Theorem," was reprinted in <u>3 DNA: Understanding, Challenging and Controlling the New Evidence of the 90's</u>. He will be speaking on scientific evidence at the Seminar on biotechnology, at Cornell University on April 24.

Professor Alan Kolod has become a partner at Moses & Singer, a Manhattan firm where he will be practicing bankruptcy law.

Professor Arthur Leonard's article "On a Need for a Realistic View of the Epidemic" was excerpted in the February 27 <u>Advocate</u>. An article he has written has been accepted for publication by <u>The Nation</u> and will appear within the next month. His editorial citing the need for improved AIDS education in the State Police and the courts appeared in the March 8 <u>New York Law Journal</u>. He has been appointed to the Human Rights Workgroup which will review and comment on the New York State Inter-Agency AIDS Five Year Plan. He will attend the first meeting of the Workgroup on March 23.

Professor Carlin Meyer's letter on the appeal of a man who was found to have AIDS after his sentencing appeared in the March 7 <u>New York Law</u> Journal.

Professor Stephen Newman's "Treatment Refusals for the Critically and Terminally Ill," from the 1985 <u>New York Law School Human Rights</u> <u>Journal</u>, was excerpted in the February 1990 <u>Pediatrics</u>.

Professor Michael Perlin spoke to the staff attorneys of New York Lawyers for the Public Interest on "Shifting Strategies in Mental Health Litigation: Reading the Supreme Court's Tea Leaves" on March 20. On June 6, he will lead the plenary session of the National Association of Protection and Advocacy Systems' annual national conference in Bethesda, Md. on "Ethics in Advocacy: Hidden Issues in Vocational rehabilitation Law," and will conduct a workshop on "Alternative Nonlitigation Strategies in the Representation of Handicapped Clients." His presentation at the University of Houston Law Center's conference, "Competency, Deinstitutionalization and Homelessness: A Story of Marginalization," was video taped for presentation to three different Houston Law School courses.

Professor Virginia Ramadan was interviewed by WABC-TV "Eyewitness News" on December 26, WNBC-TV "Live at Five"and WNYW-TV "Fox 5 News" on January 4, on the international law implications of the capture of and assertion of extraterritorial jurisdiction over Gen. Manuel Noriega following the U.S. invasion of Panama.
