#### FORGER STEPS DOWN AS TRUSTEES CHAIRMAN; MENDIK IS ELECTED

Alexander D. Forger, Chairman of the Law School's Board of Trustees since 1985, has stepped down as Chairman, effective January 1, 1989. He has been succeeded by Trustee Bernard H. Mendik, who was unanimously elected by the Board at its November meeting.

Mr. Forger, Chairman of the Executive Committee of Milbank, Tweed, Hadley and McCloy, cited "pressing professional obligations" in his resignation message to the Board. He will continue to serve as a member of the Board of Trustees.

In a message to the Law School community, Dean James F. Simon said that, "In his three years as Chairman, Mr. Forger has introduced a series of initiatives that have strengthened the School in all aspects of operations and prepared us for a second century of excellence. We regret that we will no longer have his guidance as Chairman."

Mr. Mendik, a member of the Law School class of 1958 and a Trustee since 1985, is president of the Mendik Company, one of New York City's largest real estate development and management firms. He has been a leader in the Law School's plan to acquire and renovate the building at 240 Church Street for use as its library. The library, the focus of the School's Second Century capital campaign, will be named in his honor. "We look forward to Mr. Mendik's outstanding leadership as the Law School approaches its centennial," Dean Simon said.

NATIONAL MOOT COURT TEAM WINS REGIONAL COMPETITION Advances to Finals, Jan. 23 - 26

New York Law School's national moot court team placed first in its regional round of the 39th National Moot Court Competition last month and qualified for the national finals, January 23 to 26.

The NYLS team of Sherri L. Eisenpress, John J.P. Howley and Kannan Menon defeated New York University School of Law to claim the Whitney North Seymour Cup, emblematic of the top team in the New York - New Jersey - Connecticut region. Other teams in the competition represented Fordham, Brooklyn Law School, St. John's, Seton Hall, Rutgers-Newark, Cornell, Cardozo, and Pace.

#### COMMUNICATIONS LAW SEMINAR: TAX BENEFITS FOR SALE TO MINORITIES

On Friday, January 27, the Law School and the National Telecommunications and Information Administration will co-sponsor a seminar on "Tax Certificates in Telecommunications Ventures."

The seminar, offered by the NTIA's Minority Telecommunications Development Program, is designed to educate buyers and sellers of FCC-licenced broadcast properties and their legal advisers, about creative uses of Federal Communications Commission "tax certificates." The tax certificates, designed to encourage minority ownership in the telecommunications industry, allow sellers to defer taxes on the sale of broadcast stations when the property is sold to a minority-owned company. The program will include presentations by experts from the FCC, the Internal Revenue Service and the Washington law firm of Verger, Liiphert, McPherson and Hand.

The seminar will be held from 9 a.m. to noon in room A604 and is open to members of the Law School community at no charge. For reservations or more information, contact the Communications Media Center at extension 160.
