

Dinner Honors Establishment of Solomon Professorship

The Law School's Froessel Library was home, on May 20, to a black-tie reception and dinner in honor of Dr. Joseph Solomon '27 regarding the establishment of the Joseph Solomon Professorship.

Dr. Solomon's acceptance speech, and excerpts from Dr. Calvin H. Plimpton's introductory toast, are reprinted below. Dr. Solomon is a Partner of the Manhattan firm of Pincus Munzer Bizar D'Alessandro & Solomon, Dr.

Plimpton, a member of the NYLS Board of Trustees, is Professor of Medicine at Dov state Medical College.



Dr. Solomon's Acceptance

Distinguished members of the Board, the faculty, and the administration, honored guests and friends:

Your flattering remarks are touching and gratefully received.

I am sorry that Don Shapiro is not with us this evening. Dr. Thornton in a letter to me last December said "The team of Shapiro and Solomon is quite unbeatable." When wonderful people are brought together to share in exciting events the results are bound to be spectacular.

I am greatly pleased by the presentation to me of this citation.

The competent and dedicated staff of the Law School is making invaluable contributions to the success of the School.

Many, many years ago, when I graduated from New York Law School, if anyone had told me that I would someday have a professorship established in my name, I would not have believed it.

And yet, it has happened. It is, indeed, an honor which I shall always cherish.

In a very real sense, I can never repay the School for the advantages that it alone gave me at a time when I had no funds.

Henry Wadsworth Longfellow once wrote: "Give what you have. To someone, it may be better than you dare to think."



That wise advice has, for me, become an urgent exhortation.

It is important for all of us to cultivate the psychology of giving.

The satisfaction it returns is exhilarating and enduring.

I am firmly convinced that giving and serving others is the best assurance of one's own well-being.

Today, the need for giving is especially acute.

Awesome financial problems face our most basic institutions because of federal, state and city cutbacks.

I feel honored to be in a position to be of assistance in helping the School achieve not simply a good law school, but a truly great urban law center of the first rank.

And I am also gratified that this endowed, chaired professorship will not only attract holders of the highest calibre, but will be an enduring contribution towards the education of students, who, in time, will utilize t knowledge for the good of the ultimate be ficiaries-the many people whose needs in our complex society must be met by competent and well-trained lawyers.

To the members of the Board of Trustees who have seen fit to permit my name to be so closely associated with this great law school, may I say as sincerely and gratefully as I know how, thank you; thank you very much.

Toast by Dr. Plimpton

... To get that kind of faculty who can incul-"the decency of reason", and who will be embered for themselves far more than for the content of their lectures, you need support for professorships.

Here in a somewhat round about way is the singular and tremendous significance of the Joseph Solomon Professorship. This makes possible the finest kind of education. Long, long after we are all gone there will be someone with pride that he is THE JOSEPH SOLOMON PROFESSOR. And there will be others who will study the life of Dr. Solomon to find out what manner of man he was and then to go and do likewise. Dr. Solomon we thank you for today and tomorrow!

Now while men are important we should not forget the new building—less important than the professor—but still the scholar needs a roof. (And as we administrators know, one million other things!) But buildings are also important because they have an influence. When they wanted to rebuild the House of Commons like the semi-circular Chambre de Deputés with a physical statue to every



nuance of opinion, Winston Churchill, who had crossed the aisle many times, objected: "No, we will build it the same. We shape the building and then the building shapes us!" So hooray for the new building to house the Solomon Professor.

Finally, since there are aromas of fundraising in the air—a desire to follow the magnificent leadership of Dr. Solomon—to go and do likewise—and because I gather Dr. Solomon's specialty is Estate Planning—I would like to read you Oliver Wendell Holmes on the subject of *Parson Turell's Legacy*. Here speaks the Parson.


God bless you gentlemen, learn to give

Law Meets the Press in Verbal Slugfest

The Seventh Annual "Law and the Press" Conference was held at NYLS on May 15, and the time was ripe for spirited debate: a murder trial was receiving daily coverage (Craig Crimmins was to be found guilty of the murder of a violinist in the Metropolitan Opera House) and the State's Court of Appeals had, days before, handed down a controversial decision concerning child pornography.

Were the police pressured by the Fourth Estate to indict Crimmins? Is the judiciary insensitive to community mores? Is justice truly served by withholding the names of juvenile offenders? Are the First and Sixth Amendments totally, irrevocably irreconcilable? Is the judiciary lenient, and does this leniency cause or contribute to the high crime rate?

The slugfest ended in a draw, but many of the participants were heard to mutter "Wait till next year."

Excerpt of E.R. Shipp Statement

New York Times court reporter E.R. Shipp had to cancel her appearance as a panelist so that she could attend the Crimmins trial. However, she kindly supplied the Conference with a brief written statement.

A few judges...do not realize that in order for a trial or hearing to be "public" someone other than the judges and the lawyers involved must be able to hear. The acoustics are generally horrible, yes, but a little more attention to voice levels in order to assure that proceedings are more than bench conferences would be appreciated.

Excerpts of Remarks by Hon, Sol Wachtler

... Whenever a decision is written by the courts which suggests in a particular instance that a defendant's Sixth Amendment right to a fair trial is more important than the public's right to know, I am amazed not so much by the instantaneous criticism, sometimes warranted, but by the often grossly inaccurate assault by the press on the court or on the particular judge whose misfortune it was to dare author that opinion. These attacks may serve as a journalistic catharsis but they do not inform the public, and only add to the erosion of the public's confidence in the courts. That is not to say courts or judges should enjoy a general immunity from criticism; . . . what I am talking about is unfair criticism of judicial determinations.

... First Amendment absolutists are just as bad as Sixth Amendment absolutists. Both feed at the extreme ends of reality and reason.





The registration brochure noted that as the FCC and Congress have moved to "deregulate" broadcasting and cable on a wholesale basis, claims of unfair competition and the like have shifted dramatically to the antitrust arena—often resulting in awards of triple damages and attorney's fees (horror of horrors!).



Elizabeth Hughes Gossett, a 1977 recipient of an honorary Doctor of Laws degree from NYLS, died on April 25 in Detroit at the age of 74.

Mrs. Gossett, wife of lawyer and automobile executive William T. Gossett, was the daughter of Charles Evans Hughes, the former New York State Governor and Chief Justice of the U.S. Supreme Court who made an unsuccessful Presidential bid against Woodrow Wilson.

After receiving her honorary degree, Mrs. Gossett said that she had once wanted to become a lawyer but married William Gossett instead. She is survived by her husband and three children.

Professor Joseph T. Arenson was one of the participants at a conference on the special estate and financial planning needs of women that was held on May 27 at the headquarters of the United Jewish Appeal—Federation of Jewish Philanthropies. 

Professor Edward D. Re, who is Chief Justice of the U.S. Court of International Trade and an NYLS professor, was the Commencement Speaker at the College of Staten Island, which awarded him a Doctor of Humane Letters.

Hon. Ernst H. Rosenberger '58, N.Y.S. Supreme Court Justice and Adjunct Professor at NYLS, lectured on "Trial-Summation and Requests to Charge" at a May 19 Criminal Trial Advocacy course. The eleven-lecture course was sponsored by the Appellate Division, First Judicial Department, Francis T. Murphy, Jr. '52 Presiding Justice, and the N.Y. County Lawyers' Association. One of the committee members was Jul Eliot Graham '78

Professor Rosenberger was also one of the discussion leaders of the "Criminal Law and

Procedure" course at the Conference of N.Y.S. Trial Judges which took place at Crotonville on June 22-24. More than 100 judges attended the continuing education program that was arranged by the Education and Training Office of the State Office of Court Administration.

Professor Philip J. Ruffo was one of the discussion leaders at a concentrated one-day workshop devoted to Collective Bargaining—Negotiating Your Next Labor Contract. The program, which was sponsored by the New Jersey State Chamber of Commerce, was held on June 10 in Cranford.

Dean E. Donald Shapiro, who chairs the Committee on Penal and Correctional Reform of the New York County Lawyers' Assotion, was quoted in the June 12 New Law Journal as saying that the conditions of the Criminal Court Building "deprive the defendant of human dignity and the presumption of innocence to which the accused is entitled." Dean Shapiro's comment was occasioned by the publication of a report by the Special Action Subcommittee.

The Dean was also interviewed on WNBC-TV's "Live at Five" on the subject of mental competency on June 26. Two days later, his article, "Should jury-picking be done by the judge?" appeared in the View section of the Sunday N.Y. Daily News. He concluded that "jury selection now consumes one-third of New York City court time. A more efficient, cost-effective process would benefit the citizens of New York and thwart abuse of the criminal justice system."

Professor James F. Simon autographed copies of his highly acclaimed book, *Independent Journey: The Life of William O. Douglas*, at the June 4 Book and Author Luncheon to benefit the Nyack Library.
