## NE ARE NEW YORK'S LAW SCHOOL

#### The New York City Districting Commission 2022-23 Public Hearing May 26, 2022 3-6pm at 1 Pace Plaza, New York, New York 10007

Opening points on process:

- 2020 Census 8.8 million residents in NYC
- 51 city council districts
- City Charter requires "one person, one vote"
- Ideal population per district: 173,000
- Charter allows for 5% deviation
  - Districts should be between 168,000 and 177,000
  - All districts are currently over or under this range
  - Charter allows for exceptions to the 5% deviation if there are particular concerns from the public regarding communities of interest or other criteria
  - Chair Walcott mentioned potentially a 10% deviation but indicated the legal department was still discussing this
- Next steps:
  - Iterative process
  - Monday, June 6 LaGuardia Community College approval of first draft plan
  - Then more public hearings to get feedback on the first draft
  - Then commission will work on a second draft
- Chair Walcott encouraged members of the public to hold their own meetings in their communities as well to get feedback and hear concerns
- Commission is conscious of the need to accommodate the public when it comes to deciding when and where these meetings are held
- Further meetings will be held throughout the boroughs
