EXECUTIVE SPEAKERS SERIES FEATURES LAWRENCE HUNTINGTON '64

Trustee and alumnus Larry S. Huntington '64 will return to his legal alma mater on Wednesday, April 8 to participate in the Spring Executive Series and give a slide presentation on his recent climb of Mt. Everest.

An experienced mountain climber, Mr. Huntington was a member of the American Everest North Face Expedition and scaled the world's highest peak last spring. He came within 300 meters before being turned back by inclement weather.

JUSTICE KEITH TO DELIVER THIRD ANNUAL JOSEPH SOLOMON LECTURE ON APRIL 30

Damon J. Keith, Judge of the United States Court of Appeals, Sixth Circuit, will deliver the third annual Joseph Solomon Lecture at the Law School. He will discuss "Dissent Is An Act of Faith" on Thursday, April 30 at 4:00 p.m. in the Reading Room.

Justice Keith has served on the United States Court of Appeals since 1977. He was the United States District Judge for the Eastern District of Michigan from 1967-1977, and the Chief Judge of the United States District Court for the Eastern District of Michigan from 1975-1977.

The lecture series is named for Law School honorary trustee and alumnus Joseph Solomon, of the class of 1927. Mr. Solomon rose from childhood poverty on Manhattan's Lower East Side to become a highly regarded expert in estate law and one of New York City's most important philanthropists.

Professor James Brook has signed a contract with Little, Brown & Company for a book on 'Secured Transactions' which will be part of that publisher's 'Examples and Explanations' series of Student Guides. This will be his second book in that series. He is currently working on covering the field of 'Sales and Leases of Goods' which is to be published next year. His comment, 'The Blue Bus Stop: On Professors' Stories and the Stories Plaintiffs Tell,' was recently published at 13 Cardozo Law Review 621, as part of a symposium on 'Decision and Inference in Litigation.'

Professor Carlos Cuevas was a panelist for the Puerto Rican Bar Association's program on "Bankruptcy Practice: Selected Issues for the Non-Specialist" on January 9.

Dean John Farago was quoted in an article entitled "DEC announces LAN-based deals with Novell, Microsoft" in the February 17 issue of <u>Network World</u>.

Professor B.J. George had the following case notes published in the 1991-92 Term Preview of United States Supreme Court Cases over the past several months: Doggett v. United States (Issue No. 1, September 30); Griffin v. United States (Issue No. 1, September 30); Foucha v. Louisiana (Issue No. 3, November 22); United States v. Williams (Issue No. 6, February 21); Keeney v. Tamayo-Reyes (Issue No. 6, February 21). He has also published 'Federal and State Legislation Against Organized Crime in the United States,' 38 UNAFEI Resource Materials 78-93 (December 1990)[published November 1991]; and 'Obscenity and Pornography' in B. Morosco, Prosecution and Defense of Sex Crimes, Ch. 8 (pp.8-1--8-114)(Matthew Bender 1991). He has been appointed as an international director of the Asia Crime Prevention Foundation and as the resident representative of the Foundation, an accredited nongovernmental organization (NGO), to the United Nations. He attended the meetings of the Foundation board in Tokyo on March 3 and 7, and participated in the meeting of the UNAFEI advisory committee on March 6.

Professor Karen Gross was a group leader at the Third Annual Bankruptcy Forum conducted by the Eastern District of Pennsylvania Bankruptcy Conference, held at Scanticon in Princeton, New Jersey in February. She was appointed and currently serves on the Management Committee of the American Bankruptcy Institute's State Justice Institute Grant and chairs the subcommittee on evaluation. She also served as one of the three judges of the American Bankruptcy Institute's writing competition. On April 10, she is speaking in Orlando, Florida at the Spring Meeting of the Chapter 11 Subcommittee of the Business Bankruptcy Committee of the American Bar Association and will speak on the Supreme Court's Business Bankruptcy Jurisprudence. She has also been asked by the faculties of several law schools to make presentations on either her forthcoming book or her research on early women debtors.
