# STRONG AND DIVERSE CLASS ENROLLED FOR FALL 1990

This fall New York Law School welcomed a diverse and highly qualified entering class. The strength of the incoming students' qualifications reflect the Law School's increasingly strong appeal among law school applicants, according to Director of Admissions Kevin Downey. A 25 percent increase in applications over the previous year's, resulted in the largest applicant pool in recent Law School history.

The second consecutive year of sustained growth in applicant strength and numbers allowed the admissions staff to assemble a class that is correspondingly strong both in academic promise and diversity. The new students possess a broad range of professional, business, and educational backgrounds. Academic credentials also continue to rise, as the mean LSAT score of the incoming class again increased significantly.

The entering class comes to the Law School from 17 states and 2 foreign countries. They represent 153 undergraduate institutions with 44 students holding a total of 50 advanced degrees, including 4 Ph.D's, 12 M.B.A.'s, and one M.D. Women make up 36 percent of the incoming class, and 21 percent of the class indicate they are members of minority groups. The day division has an enrollment of 285 students, and 132 students are enrolled in the evening division.

## FARAGO NAMED ACADEMIC AFFAIRS DEAN AT NEW YORK LAW SCHOOL

John M. Farago has been named Associate Dean for Academic Affairs at New York Law School, Dean James F. Simon announced during the summer. He succeeds Professor Donald H. Zeigler, who returns to the full-time faculty.

Dean Farago graduated from Harvard College in 1972 and received his J.D. in 1978 from New York University School of Law. Dean Farago is the author of four books and many articles on legal education, computer technology, professional ethics, jurisprudence and constitutional law.
