The Fall '86 Moot Court season is well underway. The Moot Court Board and Association are pleased to announce the following events and developments:

The Charles W. Froessel Annual Moot Court Competition. This year's competition focuses upon an AIDS victim's rights in the workplace. The Froessel traditionally provides NYLS the opportunity to showcase its brightest advocates before some of the Metro area's most eminent jurists. To date, Judges Kram and Edelstein from the Southern District have accepted seats on the finals bench, over which Judge Van Graafeiland from the Second Circuit Court of Appeals will preside. The 37th Annual National Moot Court Competition: NYLS appears to be a contender in this year's most prestigious Moot Court Competition, "The Nationals." Dianna Andriotis, Heide Mason, and Michael Morris were selected from among our finest advocates. The dates for oral arguments will be announced in the near future.

The 1986 BENTON Competition: Christine Burgess, John Koester, and Kevin Suttlehan will compete in this very prestigious civil law competition. Supreme Court Justice William Brennan will preside over final arguments which take place at the John Marshall Law School in Chicago this month.

FACULTY NEWS

Some of the Faculty's recent publications and professional activities...

Professor Karen Gross is the reporter of a study sponsored by the American Bankruptcy Institute on the effect and effectiveness of the 1984 amendments to the Bankruptcy Code. The actual data collection is being performed by the Survey Research Center at the University of Maryland and involves telephone interviews with approximately 1,000 individuals specializing in bankruptcy law. This is one of the first hard-data studies on the changes to the bankruptcy law and is expected to be of considerable interest to lawyers, judges, legislators and the entire debtor/creditor community.

Professor Arthur S. Leonard's earlier article, "Employment Discrimination Against Persons With AIDS," 10 Dayton Law Review 681 (1985), was cited as authority in a case of first impression, Cronan v. New England Telephone Co., CA No. 80332 (Suffolk Superior Ct., Massachusetts, August 15, 1986), holding that a person with AIDS could maintain an action for wrongful discharge and invasion of privacy under Massachusetts Law.

Professor Jethro K. Lieberman's article "Lessons from the Alternative Dispute Resolution Movement," was just published by The University of Chicago Law Review. His Op-ed article, "Some questions for the A.B.A.," appeared in The New York Times, August 6th.

Professor Michael L. Perlin's recent and upcoming publications include Book Review of Bursten, Beyond Psychiatric Expertise (1984), 14 J. Acad. Psych. & L. p. 25, (1986). In addition, Professors Perlin and Peter Margulies report that an outstanding job was done by two of our recent graduates, Marie Dooley and Jim Karamanis, and two third-year students, Michael Burns and Steven Shepard, whose able involvement in the Federal Litigation Clinic contributed to two FLC victories in Cabrera v. Heckler and Lugo v. Bowen.

Professor Joyce Saltalamachia participated as a moot court judge in the semi-final rounds of the 1986 National Appellate Advocacy Competition, as part of the recent ABA meeting held in New York.

Professor E. Donald Shapiro lectured during the summer at St. Cross College of Oxford University and at Hebrew University in Jerusalem on medical-legal topics. In addition, he has had four articles published in the last couple of months: "Single-Sex Families: The Impact of New Birth Innovations Upon Traditional Family Notions," Journal of Family Law, University of Louisville School of Law; "Overview," New York Law School, Human Rights Annual; "New Innovations In Conception and Their Effects Upon Our Law and Morality," New York Law School, Law Review; "Birth, Law, Medicine and Morality," The Eleventh Sacks Lecture, Oxford Center for Postgraduate Hebrew Studies.
