This spring, New York Law School students took part in the school's week-long Mini-M.B.A. program, the flagship initiative of NYLS's James Tricarico Jr. Institute for the Business of Law and In-House Counsel. Matus '00, General Counsel at Excel Sports Management; and Thomas J. Kavaler, Senior Counsel at Cahill. Each speaker gave us insight into their jobs and offered concrete, actionable advice to become future leaders and how to build our networks.
