# MAYOR DINKINS TO SPEAK AT JUNE COMMENCEMENT

The Honorable David N. Dinkins, Mayor of the City of New York, will receive an honorary doctor of laws degree and will be the featured speaker at the Law School's commencement ceremony in June, Dean Simon has announced.

"Ours is a uniquely urban institution and we count among our founding principles a commitment to serve the city that is our home. It is, therefore, a singular and appropriate honor to have the Mayor take part in our centennial commencement," he said.

Dean Simon also noted that the Law School has always enjoyed a close relationship with City institutions and that "the links between the Law School and City Hall have been especially strong." Three New York Law School graduates have served as mayor and many graduates have gone on to careers in public service with city agencies. In addition, many municipal employees are enrolled in the Law School's evening program.

Mayor Dinkins will join a distinguished list of elected officials who have received honorary degrees from the Law School, including former President Gerald R. Ford, Senators Daniel Patrick Moynihan and Alfonse D'Amato, New York Governor Mario M. Cuomo, Connecticut Governor Lowell P. Weicker, former New Jersey Governors Thomas H. Kean and Brendan T. Byrne and former New York City Mayors Robert F. Wagner and Edward I. Koch.

The 1991 commencement ceremony is scheduled for Sunday, June 9 at 2 p.m. in Avery Fisher Hall at Lincoln Center.

#### PROFESSOR STROSSEN ELECTED A.C.L.U. PRESIDENT

Professor Nadine Strossen was elected president of the American Civil Liberties Union on January 26. She is the first female president in the 71 year history of the organization. Professor Strossen, the A.C.L.U. general counsel since 1986, succeeds N.Y.U. law professor Norman Dorsen, who served as president since 1976. As president, she will lead the group's policy making board in recognizing issues concerning civil liberties and appropriating the organization's budget.

published in the <u>ABA Preview of United States Supreme Court Cases</u>. He was quoted on a California court ruling on the mental competency of a convict on death row in the December 10, <u>National Law Journal</u>.

Professor Arthur Leonard has been appointed co-chair of the new Special Committee on Lesbians and Gay Men in the Legal Profession of the Association of the Bar of the City of New York. He was interviewed on WFAS-AM's "The Law and You" program on December 19. On December 28 he spoke at the American Historical Association's annual meeting in New York on a panel on "The History of Sodomy Law Reform in the United States." His letter to the editor "The Real World" appeared in the January 1 Village Voice. On January 4 he spoke at the Association of American Law Schools annual meeting in Washington D.C. on panels on "Teaching AIDS Law" and "Non-Traditional Families and the Law." He was quoted on the subject of teaching AIDS law in an article in the January 11 issue of the Chicago Daily Law Bulletin. His letter to the editor "Public Health Doesn't Gain From AIDS Edict" appeared in the January 23 New York Law Journal. On January 23 he spoke at the New York State Bar Association annual meeting on a program on The Legal Issues of HIV and AIDS, discussing employment law issues. On January 25 he spoke at Duke University's "Frontiers of Legal Thought," participating in a panel on gay and lesbian rights and the law. On January 30 he spoke at the University of Pennsylvania on the Legal Rights of Lesbian and Gay Employees. On February 3 he will moderate a panel discussion on lesbian and gay family law issues at the Congregation Beth Sinchat Torah, New York. He is co-author with Professors Robert Jarvis (Nova Law School), Michael Closen (John Marshall Law School) and Donald Hermann (DePaul Law School) of AIDS Law in a Nutshell (West Publishing Co., 1991). His extensive legal bibliography on AIDS is included as Chapter 14 of the new treatise, Legal Aspects of AIDS, published by Callaghan & Company during December.

Professor Gerald Meyer prepared the English language version of International Copyright and Neighboring Rights Law, published by VCH Publishers.

Professor Zuhayr Moghrabi spoke on international environmental legal problems at a symposium sponsored by the New York Law School Environmental Law Society on November 1.

Professor Stephen Newman spoke on "Legal Problems in the Use of Stress Response Syndrome Testimony" at the Conference on Psychiatry and Law sponsored by the Tri-State Chapter of the American Academy of Psychiatry & the Law on January 26.

Professor Michael Perlin's paper, "Power Imbalances in Therapeutic and Forensic Relationships," has been accepted for a special symposium issue of <u>Behavioral Sciences and the Law</u>. For the 15th consecutive year he will chair the Practicing Law Institute Program entitled "Counseling Clients in the Entertainment Industry." The program will be held in Manhattan in March.
