### Profiles: Ernst C. Stiefel

Ernst C. Stiefel is counsel to Coudert Brothers. His interest in the field of international law "developed from political necessity and parental guidance rather than from planning." His father, a teacher in Mannheim, Germany, and his mother sent him to England and France to learn foreign languages before he was twenty.

Dr. Stiefel acquired practical business experience, having worked as an apprentice in a small business. He then studied law at the University of Heidelberg and received a Doctors of Law in 1929 Since his legal orientation was towards traffic and insurance law, he wrote his Doctorate Thesis in this area. His thesis, which deals with motor insurance law, was then published in book form. This well-known treatise, 50 vears after its first publication. is in its tenth edition.

Dr. Stiefel was ready to devote himself to insurance law when Hitler came into power. Since he was Jewish and since he was not in the First World War (he was six years old at the time), he was immediately disbarred. Fortunately, German insurance law was also the insurance law in Alsace Lorraine, France. This area had only been recovered by France in 1918. The French government repromutgated the German law in this field. Being familiar with German insurance, he was offered a legal position in Alsace Lorraine where he passed the equivalent of the French Bar.

Realizing he could not become a French citizen, Dr. Stiefel went to England to become a barrister. In England, barristers plead in court while solicitors prepare briefs. In order to become a barrister, Dr. Stiefel was required (aside from passing the bar examination) to eat formal dinners with the members of the Bar for 72 evenings! He passed the Bar and became a member of the Honourable Society of the Middle Temple of London, one of the four Inns of Court. He found insurance companies to be very conservative and as a German immigrant, it was difficult to attract clients.

Dr. Stiefel arrived in the United States on September 14, 1939, with no possessions save the clothes on his back. He took

odd jobs when he first arrived, including chauffeuring and working in a cafeteria. He recalled chauffeuring one woman to Macy's. She asked him to drive around the block a few times so that she wouldn't have to pay for his lunch or for the parking — it was a difficult beginning.

By chance, Dr. Stiefel was introduced to an attorney, Mr. Engelhart (a cousin of Georgia O'Keefe's husband), who hired him as an apprentice. Dr. Stiefel studied New York law which he found more tedious than European law since it was much more pragmatic. When he passed the Bar, he was drafted into the United States Army. Through the cooperation of Mr. Allan Dulles, John Foster Dulles' brother, he served from 1943-45 in the insurance division of the military government. Office of Economic Warfare.

He laid the groundwork for understanding the Nazi legal network as it was practiced in Germany at the time.

Immediately after the War, the American-Jewish Committee asked Dr. Stiefel to fly to Germany and concentrate on working on the restitution of expropriated properties of the Jews. He was permitted in Germany in 1945 when private

citizens weren't allowed to enter the country. He acquired an intimate knowledge of what happened and proposed the legal groundwork for the restitution and reparation of Jewish owned property in Germany.

Dr. Stiefel is a prolific writer. He catalogues all his reading material in his files and commented that "nothing is thrown away unless it's rubbish—from my standpoint." He has written numerous articles in the English and German languages on international law (see In Brief, December, 1978).

His experience teaching at the Law School has been a great stimulus to him. He believes that when he was asked by Dean E. Donald Shapiro to teach at New York Law School "it was one of the star hours of his career". An Adjunct Professor, he finds teaching to be adrenalin for the mind. The response of the students has been equally invigorating.

Dr. Stiefel advises students interested in international law to learn foreign languages and to become acquainted with local cultures. As for the supposed glamour of travelling, he states that there is none. One must be devoted to one's work and one must realize that the field of

international law requires constant reading of updated law materials as well as constant contact with clients.

Dr. Stiefel has received degrees from: The University of Heidelberg (Doctor of Laws 1929); University of Paris (Licencie en Droit 1934); University of Strasbourg (Diplome d'Etudes Superieures 1935). Dr. Stiefel worked for the firm of Cook, Lehman & Nathan (now the firm of Lehman, Rohrlich & Solomon). From 1950-71, he was closely associated with the firm of Cleary, Gottlieb, Hamilton & Steen.

New York Law School was housed in the Dwight Building, located at 244 William Street, from 1947-1962. Several professors recruited by Dean Reppy are today among the School's senior full-time faculty: John Dugan, Joseph Koffler, and Milton Silverman.
