
Wagner Competition

An article written by **Professor E. Donald Shapiro** (with Stewart Reifler, '92) entitled "Forensic DNA Analysis and the United States Government" was published in the January 1996 issue of the British scholarly medical journal *Medicine, Science and the Law.*

Adjunct Professor Daniel Alterman was quoted in the February 26 issue of *New York* magazine, in a story on his client Betty Weems, who has filed a sex-discrimination complaint against Barnard College.

On February 21, **Professor Ross Sandler** moderated a panel discussion at the Association of the Bar of the City of New York entitled "New York City's Taxi Industry: Getting Street Smart," about regulation of NYC's taxi and livery industry and innovations aimed at improving the quality of drivers and cabs.

On February 20, Professor Nadine Strossen was interviewed on CNN-FN's "Digital Jam" program, about the ACLU's lawsuit challenging the Communications Decency Act (barring "indecent" and other expression in cyberspace). On February 22, she debated censorship of pornography with Stanley Fish, Professor of English and Law at Duke University, on the North Carolina affiliate of National Public Radio. On February 24, she spoke about her book on that subject at the Stanford University Bookstore in Palo Alto. On that same date, she addressed the Annual Law Students' Conference of the Federalist Society, at Stanford Law School, on "Feds Fighting Crime: When and How?" (her fellow panelists were Ninth Circuit Judge Alex Kozinski and former head of the Civil Division, U.S. Justice Department, Richard Willard). On February 25, she lectured at West Virginia University, in Morgantown, as part of the University's "Festival of Ideas." On February 26, she made a "Showcase Presentation" to the National Convention of the National Association of Campus Activities in Nashville.

GREAT SUCCESS FOR THE CIVIL LAW CLINIC

The Civil Law Clinic is pleased to announce several recent successful efforts on behalf of its clients. In the last year, the Clinic has obtained political asylum for five refugees, including a political dissident from China, a lifelong political prisoner from Albania, a Kurdish journalist from Turkey, and refugees from ethnic persecution in Bosnia and Burundi. The Clinic also reached settlements on behalf of clients in housing discrimination and community reinvestment cases. Several Clinic clients obtained not-for-profit status and exemption from federal taxes, including a community group that promotes public schools in New York City and a group that educates the public about drug abuse treatment and policy.

Professors Carol Buckler, Larry Grosberg, and Richard Marsico supervise students in the Clinic. Among the students who worked on these cases are Felicity Lung, Jennifer Drayton, James White, Kristen Snyder, Nilie Pajoohi, Stephanie Elmore, Liam McLaughlin, Rachel Marshall, Julian Miller, Joylette Hairston, Brenda Hall, Janine McQuilkin, Maureen Duffy, David Brookstone, Diane Constantine, Allen Cremer, Gareth Bullock, Greg Pietrzak, Dominic Kong, Simone Nicholson and Audra Barrow.

Starting next year, the Clinic will change its name to the Civil and Human Rights Clinic, concentrating its efforts on political asylum and discrimination cases.


