Å range of issues including life and disability insurance, living wills, and estate and gift tax planning will be discussed.


Although there will be a fee for alumni and guests, the program is free for students. Seating is limited so reservations are required. For more information or to make a reservation, call ext. 2167.

Faculty Activities

Professor Richard Marsico spoke about the implications the expansion of electronic banking will have for community reinvestment at a conference sponsored by the East Fulton Street Group at Pace University on September 26. On October 22, he spoke at the annual conference of the Neighborhood Preservation Coalition in Albany. His topic was the impact the new Community Reinvestment Act regulations will have on community economic development.

Last month, **Professor Michael Perlin** spoke at the annual Psychiatric Services conferences of the American Psychiatric Association on the constitutionality of mobile crisis outreach team statutes, and then at the annual National Forensic Mental Health Attorneys' conference on the right of forensic patients to 'sexual interaction.

On October 24 he presented a Grand Rounds at Kirby Forensic Psychiatric Center on the Colin Ferguson case and and the question of competence to waive counsel.

At the end of the month, he made several presentations on the procedural and substantive rights of institutionalized mental patients to the Oklahoma Department of Mental Health's chief-administrators and medical officers.

In their just published book Law in a Therapeutic Key, Professors David Wexler and Bruce Winick include lengthy excerpts from Professor Perlin's book The Jurisprudence of the Insanity Defense, and from the article he coauthored with Prof. Keri K. Gould and Deborah A. Dorfman '92 entitled "Therapeutic Jurisprudence and the Civil Rights of Institutionalized Mentally Disabled Persons: Hopeless Oxymoron or Path to Redemption?" (published on page 80 of volume 1 of Psychology, Public Policy and Law) In addition, his article entitled "'No Direction Home': The Law and Criminal Defendants with Mental Disabilities." has just been published in volume 20. page 605 of Mental and Physical Disability Law Reporter as part of that journal's special 20 year retrospective symposium on developments in disability law.

On October 21, **Professor Nadine Strossen** gave a lecture on "Cybercensorship" at East Carolina University in Greenville, North Carolina. On October 23 she lectured at a conference in Gothenburg, Sweden on "Incitement to Hatred — Should There Be a Limit?" She also participated in a public debate at the Gothenburg Book Fair on "Striking a Balance: The Right to Speak, the Duty to Protect." Other panelists included Albie Sachs, Justice of the South African Constitutional Court: Wole Soyinka, the Nobel Prize-winning author and exiled Nigerian human rights advocate; and Ursula Owen, Editor of Index on Censorship. On October 24 Professor Strossen was filmed for a German television documentary on free expression and interviewed on Swedish public radio about human rights issues in the U.S. and Sweden. Her latest monthly column, "The Politicizing of the Judiciary," was published in the October 17 issue of the E- Zine "Intellectual Capital." Her interview and picture were featured in the October, 1996 edition of Western Business magazine.

Professor Donald P. Rothschild presented an "Update on Labor Law Issues in 1996" to those in attendance at the 11th Annual Rhode Island Labor-Management Relations Conference held Friday, October 25 at the Biltmore Hotel in Providence.

Professor Arthur Leonard participated in a panel discussion of new developments in employment law affecting the rights of lesbians, gay men, bisexuals and transgendered persons, a the Fifth Lavender Law Conference, held in New Orleans, October 24 through 26.
