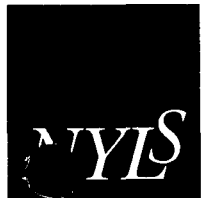

SPECIAL LECTURE SERIES WITH FORMER WALT DISNEY EXECUTIVE

NAPIL/AMERICORPS*VISTA SUMMER LEGAL CORPS(NVSLC)

AmeriCorps*VISTA announced in September that it will fund a 1997 summer corps of 50 first and second-year law students who will work alongside VISTA volunteers at urban and rural sites across the country. This program succeeds the National Summer Rural Legal Corps program. NVSLC fellows will work on a wide range of community development issues, including helping activists for low income people set up nonprofit organizations, assisting established groups with fundraising and development, developing literacy programs, and working with local domestic violence shelters on victims' outreach and education services. The NVSLC fellows will earn a stipend equal to that of a full-time VISTA volunteer for eight to eleven weeks, and also will receive a partial education award at the end of the summer. Application materials for the NVSLC will be available in December.

Faculty Activities

On September 27, Professor Michael Perlin was interviewed on National Public Radio by Alex Chadwick on the question of John Hinckley's application for conditional release from St. Elizabeth's Hospital (where he remains as an insanity acquittee after his attempted assassination of President Reagan). On October 4, he was quoted on CBS-television on related insanity defense issues. His article, "Patients' Rights" has just been published in *Psychiatry*, a multi-volume medical encyclopedia edited by Dr. Robert Michels and others, and published by Lippincott-Raven.

On October 2, Professor Nadine Strossen gave a lecture at Duke University in Durham, North Carolina on "Cyberliberties." On October 5, she debated Judge Robert Bork about the issues raised in his new book, *Slouching Towards Gomorrah*, on CNN's "Crossfire." Professor Strossen's article, "The Tensions Between Regulating Workplace Harassment and the First Amendment: No Trump," which was based on The Kenneth M. Piper Lecture she delivered at the Chicago-Kent Law School last year, was just published in *Chicago-Kent Law Review*, vol. 71 pages 701-727 (1995).

Professor Richard K. Sherwin was invited by the Columbia University Seminar on Cinema to speak on October 3, at the Museum of Modern Art. His topic was the interpenetration of law and popular culture, with particular reference to film. His paper responded to University of California at Berkeley film scholar Carol Clover, who argued that the Anglo-American jury trial has exerted a strong influence on American film making.

On September 26, Professor Michael Botein was interviewed by Court Television concerning "theft of services" from satellite cable networks.

Professor Jeffrey Hass recently published an article entitled "Directorial Fiduciary Duties in a Tracking Stock Equity Structure: The Need for a Duty of Fairness" in the *University of Michigan Law Review*, vol. 94, page 2089 (June 1996). The article addresses the unique fiduciary concerns of directors of those corporations, including US West, General Motors and USX, that have adopted a specialized equity structure that employs "tracking" or "targeted" stocks.

RESUME COLLECTION

Students applying for a Federal or State Appellate Judicial Externship: resume collection will take place on **Tuesday, October 22, from 9:30 a.m. to 2 p.m. and 4 to 6 p.m. in room B500.** Your application should include 20 resumes, 20 copies of a writing sample, the completed Judicial Externship Placement Choice Form listing the 20 judges you want to receive your resume and, if you wish, 20 copies of a recommendation letter.

Students applying for a State Trial Judicial

Externship: resume collection will take place on **Wednesday, October 23, from 9:30 a.m. to 2 p.m. and 4 to 6 p.m., and Thursday, October 24, from 12 to 2 p.m. and 3 to 5 p.m. in room B500.** Your application should include 21 resumes, 21 copies of a writing sample, the completed Judicial Externship Placement Choice Form listing the 20 judges you want to receive your resume and, if you wish, 21 copies of a recommendation letter.

Staple each copy of your writing sample. Paper clip a copy of your resume and any letter of recommendation to each of your writing samples.

It is strongly recommended that you have your resume reviewed by the Office of Career Services before you submit your application. The Office of Career Services offers walk-in hours from 1 to 2 p.m., Monday through Thursday, and 5 to 5:45 p.m. on Wednesdays. Career Services is located on the fifth floor of B Building.

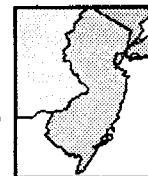
