the following misbehavior: REport of 11-3-71 by C.O. D.I. Smith - Inmate Maynard refused to take a shower when requested to do so by C.O. Wilson

Report of 11-6-71 by B. Smith C.O. - Refusing an order. Inmate Maynard refused to stand for the Noon Count. I had to tell him to get up five times before he finally did get up.

Report of 11-7-71 by C.O. D. Head - While taking the yard list on 6 Co. I was stopped by inmate Maynard who inquired of the whereabouts of some paper the had been removed from the gallery floor in front of 11 cell. I informed him that the Officer retrieving the paper, not knowing the owner had turned the paper over to Sgt. Cochrane. Inmate Maynard's next remark was directed down the gallery. He shouted "the pig gave it to the Sergeant." His next statment further described the Officer involved as a "fat little barrell assed faggot." Inmate Maynard's remarks were not condusive to good relationship between Officers & Inmates as I took offense to his remarks about a fellow Officer.
