Albany County Legislature Sends Map Back To Commission

On October 11th, the Albany County Legislature sent a draft county legislative map back to the county's redistricting commission on a 24-15 vote. The legislature's leadership maintained that the map might dilute minority voting strength in Albany City. In 2015, a federal court found the county to have violated the federal Voting Rights Act in the last redistricting a decade ago and ordered that at least 5 minority districts be created. While 5 minority-preferred candidates have been elected since 2015, a 2022 expert racial voting analysis prepared for the commission indicated that racially polarized voting in the county was still prevalent and that a total of 5 districts could be created that would likely continue to elect minority-preferred candidates but that an additional 2 districts could be created offering the potential for minority-preferred candidates to be elected. Despite the expert analysis, the county legislature rejected the proposed plan and asked the commission to go back and consider a new plan with fewer minority districts, opening the door to possible racial packing.

The Commission will meet to discuss "next steps" on October 17th at 7:30 PM.

Monroe County Executive Releases Redistricting Analysis

Monroe County Executive Adam Bello released a report produced by voting rights expert Dr. Lisa Handley analyzing voting patterns by race in recent Monroe County elections. Dr. Handley's research concluded that there are currently 5 legislative districts (22,25,27,28,29) in which black voters are electing their candidates of choice. A sixth district (LD 21) sometimes elects the preferred candidate of the black community.

Last week, County Executive Bello weighed on the ongoing Monroe County Legislature redistricting process, calling for a restart to a process marred by name-calling and divisive rhetoric and announcing that his administration would produce a redistricting a map using the data analysis conducted by Dr. Handley that is compliant with all applicable legal requirements under federal, state, and local law, including the U.S. Constitution and the Voting Rights Act that seeks to create six effective black districts if possible.

Census Bureau Releases Operational Census Metrics

In a surprise but welcome move, the US Census Bureau has released operational census metrics at the county and tract level. This information will aid community organization efforts to determine the effectiveness of their census outreach. Information is broken down by self-response (and additionally by internet self-response by physical address) and, for non-responses, household interview, proxy, and administrative records. Non-responses do not add up to 100%, likely because of the Census Bureau's anonymization practices. County level data also contains information about what percent of the population was imputed.
