# Dinner to Honor Scholars and Donors on April 19th

## **Faculty Activities**

The Board of Trustees has approved the promotion of Eugene Cerruti to Professor of Law and Annette Gordon-Reed to Associate Professor of Law.

Professor Randolph Jonakait gave a talk, helped by the research assistance of Sonya Fritts, on hearsay exceptions at a symposium at Touro Law School comparing federal and New York evidence law.

On April 6th, the New York Times published a letter to the editor by Professor Arthur Leonard. The subject matter was the recent decision by the State University of New York to ban military recruitment on SUNY campuses in response to a court decision holding that such recruitment activity violated an Executive Order by Governor Cuomo forbidding sexual orientation discrimination by state programs.

The 1994 Supplement to Professor Jethro Lieberman's The Evolving Constitution was recently published by Dialogue Press, Incorporated. The Supplement contains essays alphabetically by topic on the Supreme Court's 1992-93 term (50 cases dealing with constitutional or quasiconstitutional issues are included), the Supplement also contains a complete set of indices to cases and subjects in both the main volume and the Supplement itself.

Professor Nadine Strossen was included in the National Law Journal's triennial special section, "Profiles in Power — the 100 Most Influential Lawyers in America" (she was also included in the previous such listing, in 1991). On April 6, she debated former U.S. Attorney General Ed Meese on "Law and Order in America" at the University of California - Davis. She was quoted in the April 11 National Law Journal about public attitudes toward crime, civil liberties, and violence on television.

Professor Ruti Teitel will give a talk entitled "Justice After Transition: The East German Case in Historical Perspective" at NYU's Center for European Studies Monthly Workshop on Tuesday, April 19th.

Professor Rudolph J.R. Peritz is looking for a student research assistant for the 1994-5 academic year. He would prefer that the sra be available for some work after final exams through June. Professor Peritz's research and writing is in the areas of antitrust, economic regulation, legal history, and computer-related legal issues. 
