Moot Court Takes It All at Seton Hall

Congratulations to NYLS Moot Court, which won the National Championship at the Judge John J. Gibbons National Criminal Procedure Moot Court Competition held at Seton Hall Law School on April 8. The competition came down to two NYLS teams battling each other in the SemiFinal Round. But it was Laura McGinn, John Belmonte, and coach Carlie Draper who took the Final Round. The team also won the National Best Petitioner's Brief Award, and Mr. Belmonte won the National Best Oralist Award. Ms. McGinn, the secretary of the SBA, was the co-author of the 1995 Wagner National Labor Law Moot Court Competition Fact Pattern and Bench Brief, Mr. Belmonte was John Wilkes Booth in this semester's mock trial of Booth. Ms. Draper, along with Laurie Mayer, won the Best Team Award in the 1993 Froessel Intramural Moot Court Competition. Congratulations also to the National SemiFinalists at Seton Hall and winners of the Second Best Respondent's Brief Award: David Fish: Robert Kaminski: Jason Weisser: Shawn Weakland: and coach Michelle Goldman.

As Seton Hall Dean Ronald Riccio noted, NYLS's students came to New Jersey to dominate at Moot Court, and they did, defeating 21 other teams from around the country. This victory brings to 11 the number of national best awards (championships, best briefs, best oralist awards) that Moot Court has won so far this year. The season continues with NYLS's American Bar Association Moot Court Team competing in the Championship Round in Chicago in August.

NYLS Graduation Awards

The following three awards are available to 1995 graduating students. All who qualify are encouraged to apply for the awards, each of which includes a financial component.

The Otto L. Walter Distinguished Writing Award, established by Dr. Otto L. Walter, is given to the one Day and one Evening Division student with the best published paper. Only those papers written on a legal subject while the student was enrolled at NYLS are eligible for submission. Papers slated for publication must be accompanied by a letter of commitment from the publisher specifying the date of publication. The Award's judges will decide on any submissions whose eligibility is in question.

The Ernst C. Stiefel Award, established by Professor Ernst C. Stiefel, will be presented to the graduating student who has written the most accomplished paper in the field of comparative, common, and civil law.

(For both competitions, four copies of the student's paper(s) must be submitted to the Office of Student Services no later than 6:00 pm on Tuesday, May 16. The scholarly merits of submitted papers are evaluated by a faculty committee.)

The Helen and Andrew Dokas Memorial Award for Excellent Achievement is given annually to a graduating student who has overcome some hardship in his or her life that makes achievement even more noteworthy. The student's circumstances, academic performance, and overall achievement will be determining factors of the Award's recipient. All personal circumstances will be kept confidential. Applications and nominations containing a brief statement of the qualifications of the candidate should be submitted to Student Services, by 6:00 pm, Tuesday, May 16. The Award selection will be made by a faculty committee.

Student Legal Ethics Award Competition

The New York State Bar Association has announced the 1995 Student Legal Ethics Award Competition for participating New York State law schools. The Competition is open to all students enrolled at NYLS during the 1994-95 academic year. The award is intended to encourage activities in connection with the lawyer's role as client representative, officer of the legal system, and public citizen with a special responsibility to maintain the quality of justice. Students are invited to submit evidence of a contribution or activity in which they have been engaged to further legal and professional responsibility or legal ethics. This might include an article written by the student, a statement detailing an activity in which the student has had significant involvement, or a letter(s) attesting to the student's contribution to professional responsibility and/or legal ethics. (An examination answer will not be accepted as a submission.) The New York State Bar Association will award a cash payment of \$750 and the possibility of publication of the submitted article (if applicable). The deadline for submission to the Office of Student Services is 6:00 pm, Wednesday, May 31.

Nathan Burkan Memorial Competition

Each year, the American Society of Composers, Authors and Publishers (ASCAP) sponsors the Nathan Burkan Memorial Competition for law student papers on any phase of copyright law. The competition is open to second, third, and fourth-year students. Each participating school will select a first-prize and second-prize winner, awarding \$500 and \$200 respectively. NYLS's selection will be made by a committee of faculty members. The winning papers will then be submitted to the national competition which awards prizes of \$3,000, \$2,000, \$1,500, \$1,000, and \$500. Interested students should pick up a copy of the competition rules from

Student Services. The deadline for submission to Student Services is 6:00 pm, Wednesday, May 31.



Professor Michael Botein gave a lecture on April 11 to a group of French graduate students at the Ecole Nouvelle d'Inginieurs en Communications (New School for Communications Engineers) in Lille, France, via a two-way videoconference. The school handled the transmission from its end, and France Telecom provided its videoconferencing facilities in New York. The topic was the status of telecommunications regulation in the U.S. today.

Professor Arthur Leonard was re-elected to the Executive Board of the Harvard Law School Association's Gay/Lesbian/Bisexual Alumni Committee at the annual meeting in Cambridge, Massachusetts, on April 8.

Professor Richard Marsico was a panelist at the Fifth Annual Regional Fair Housing Conference sponsored by Long Island Housing Services on April 7. The panel was on "Examining Financial Institutions for Discrimination: Lending and Insurance."

Professor David Schoenbrod wrote the article "On Environmental Law, Congress Keeps Passing the Buck," which was printed in the March 29 Wall Street Journal. Also, Guy Darst's article in the April 3 Boston Herald entitled "Now This is Real Law-Making" discussed Professor Schoenbrod's ideas on how Congress abuses its power to write laws. The article referred to his book Power Without Responsibility and said "his ideas have been seeping into the network of Washington think-tanks and congressional staffs."

Adjunct Professor Peter J. Strauss wrote "Proposals and Interpretations that Threaten Medicaid Access," an article on the legislative changes that have affected the Medicaid program which was printed in the March 31, 1995 New York Law Journal.

On April 4. Professor Nadine Strossen delivered the 15th Sumner H. Canary Memorial Lecture at Case Western Reserve Law School in Cleveland, Ohio (previous Canary Lecturers included Supreme Court Justices Warren Burger, Sandra Day O'Connor, and Antonin Scalia). On April 6, she delivered the Keynote Address at the Annual Convention of the Texas Library Association. College and University Division, in Dallas. Professor Strossen debated William F. Buckley, Jr. on April 7 at "The 1995 Great Debate" held at the Annual Convention of Phi Theta Kappa in Chicago on "Rights, Privileges, and Responsibilities: How Do We Strike the Balance?" (carried by C-SPAN). On April 11, she delivered the 17th Annual Kenneth M. Piper Lecture at Chicago-Kent Law School on "The

Tensions Between Regulating Workplace
Harassment and the First Amendment" (with
commentary by Gilbert Casellas, Chair of the U.S.
Equal Employment Opportunity Commission). She
also lectured at Kenyon College in Gambier, Ohio,
on April 11. She gave two lectures in Chicago on
April 13: at Northwestern University Law School and
at the University of Chicago Law School.

Report from the Academic Responsibility Committee

This is the second in a series of reports to inform students, teachers and staff of the Law School of proceedings that have taken place under the School's Code of Academic Responsibility. The reports are meant to clarify the meaning of the Code and demonstrate the School's commitment to the values embodied in it. Copies of Cases One and Two (Counselor, April 10, 1995) are available in the Dean's Office. Questions and comments about the substance of or procedures under the Code of Academic Responsibility may be addressed to Prof. Edward Samuels or Associate Dean Ellen Ryerson.

Case Three

The Academic Responsibility Committee unanimously found that a student had violated the Code by submitting identical papers for credit in two separate Independent Study courses without notice to or approval of either professor. The Committee recommended, and the Dean concurred, that the student should receive an F in one of the two courses and a WD in the other course and should be prohibited from making any use of the paper in any other course at NYLS. A more complete report, dated April 17, 1995, redacted to protect the identity of the parties, is on file in the Dean's Office and may be viewed by anyone in the NYLS community.

Case Four

After a full hearing, the Committee unanimously found that a student had received assistance on the portion of a written assignment that was supposed to represent the student's own independent work, and had submitted, as the student's own, work that was written by another student. The majority of the Committee found that the student had appropriated a copy of the other student's work without the other student's permission or knowledge. The Committee, by unanimous vote, recommended that the student receive an F for the course and that a permanent notation of the action be included in the student's

record. The Dean accepted the recommendation of the Committee. A more complete report is available in the Dean's Office, dated April 18, 1995.

Potential Breaches of Anonymity on Exams Several cases of potential breaches of anonymity were reported to the Committee in the last two semesters, pursuant to a request by the Committee that faculty members report all potential breaches of anonymity by students either on exams or in communication with professors after exams but before the exams have been graded. The Committee concluded in each of the cases that the identity of the student had not in fact been disclosed and voted to take no formal action in any of the cases. Some of the involved students were personally warned. The Committee reminds all students not to communicate with professors about exams while grades are pending. Students who have concerns to raise about exams before grades have been released should contact the Academic Affairs Office, not the professor grading the exam.

Minority Job Fair Sponsored by DuPont


