

Locker Assignments

Students may sign up for a locker during the first week of classes at the Office of Student Services located on the 5th floor of A Building. There is no charge for lockers <u>but you must have a specific</u> locker assigned to you and provide your own locks. Locks placed on unassigned lockers will be clipped and the contents of the locker removed. Students who request a locker will be assigned only one initially. If there are unassigned lockers after the fourth week of classes, students may request a second locker. No student will be assigned more than two lockers.

Faculty Activities

Adjunct Professor Sidney H. Asch, Supreme Court Judge of the Appellate Division, First Department, was a guest of honor at the Annual Dinner of the 12th Judicial District and a guest of honor at the Annual Dinner of the Bronx Bar Association at its annual outing.

Professor Richard Bernstein was quoted as an "expert on constitutional history" concerning recent major amendments to the Constitution in both the June 6, 1995 *Plain Dealer* and the June 11 *Sun-Sentinel*. He was also quoted about television tabloid magazine shows in the article "Taking a Stand on O.J.," *Newsday*, July 2, 1995.

During the month of May, **Professor Michael Botein** was a Visiting Professor at the Faculty of

Law, Haifa University, Israel, where he taught the course "Regulation of the Electronic Media: A Comparative Analysis." On May 17, he gave a paper on "Copyright Liability of Multichannel Video" at the conference "Cable and Satellite Developments" sponsored by the Faculty of Law, Hebrew University. He gave a paper on June 9 on "Finding Commonality Between Local Governments and Telcos" at a conference in Washington, D.C. on "Video Dial Tone in the New Competitive & Deregulated Telecom World," sponsored by the Strategic Research Institute, NYC. The Cardozo Arts & Entertainment Law Journal published his article, "Judicial Review of FCC Action," in Volume 13, Number 2. Also, the New York Law Journal published his article, "Move Over Bill Gates: The Real Antitrust Menace Is the Law Professors," in the July 6, 1995 issue.

During the spring 1995 semester, Professor Stephen Ellmann chaired the meetings of the Clinical Theory Workshops at NYLS, and also chaired a meeting of the New York Area South Africa Reading Group. The third issue of the. Clinical Law Review, of which Professor Ellmann is a co-editor-in-chief, came out in May 1995. His article on "Law and Legitimacy in South Africa" is about to be published in the journal Law & Social Inquiry, as part of a symposium on lawyering in repressive states: Professor Ellmann is the Special Issue Editor for this symposium and his essay. "Struggle and Legitimation," will be published in the same issue. He was a panelist on "Negotiation and the South African Constitution" at the Southern African Workshop session held at Southern Connecticut State University on April 1, 1995. His article, "The New South African Constitution and Ethnic Division," published last year, was circulated for this workshop as a background paper. In August 1995, he was one of two speakers at a forum of the New York County Lawyers Association on the case in which the South African Constitutional Court held the death penalty unconstitutional. His Op-Ed piece on the same case was printed in the June 29 edition of Newsday, under the title "On the Death Penalty, Copy South Africa," Earlier in the year, he had been "of counsel" on a memorandum of law prepared by the NAACP Legal Defense & Educational Fund and Human Rights Watch and submitted to the South African Constitutional Court in this case. Last but not least, Professor Ellmann and his wife, Nancy Rosenbloom, became the proud parents of a daughter, Nora Rachel Ellmann, on June 26.

Adjunct Professor Lloyd Epstein wrote "Crack Cocaine Sentencing Guidelines Challenged," an article in the April 27, 1995 New York Law Journal.

Adjunct Professor Kristin Booth Glen was

appointed dean of City University of New York Law School and will assume her new position on September 1, 1995. She currently is an associate justice at the New York State Supreme Court.

The article "Reaching for the Phone" in the July, 1995 *City & State* quoted **Professor Allen Hammond** about local telephone competition and the debate over universal service.

The Chicago Tribune made reference to **Professor** William LaPiana in the June 28 article, "They Can't Take It with Them, But They Won't Let Go," in which he was quoted about benefactors' use of incentive trusts to control the behavior of heirs.

Professor Jethro K. Lieberman received a Ph.D. in political theory from Columbia University at its commencement on May 17, 1995. He began his graduate work in 1983 and earned his M.Phil. in October, 1994. His dissertation was entitled "Redress and Freedom: Harm and the Limits of the State." An article in the *American Bar Association Journal* cited him as an expert source for the compilation of their Law Lists, providing practical advice for lawyers. His topic was how to improve legal writing.

Professor Arthur Leonard became a contributing writing for Lesbian & Gay New York, a new semimonthly community newspaper. His first article was "The Parent Trap: State Courts Hand Down Troubling Decisions for Gay Parents," printed in the May 21, 1995 issue. He was quoted about the Supreme Court's decision in Hurley v. Irish-



American Gay, Lesbian and Bisexual Group of Boston in the New York Times on June 20. He was quoted about free speech and the Supreme Court's ruling to allow the Boston annual St. Patrick's Day parade to exclude gay marchers in a news article in the Jerusalem Post, June 21, and an Arizona Republic editorial, June 23. Professor Leonard was elected to the Board of Directors of Madrigal House, Inc., a transitional living program providing temporary housing and related support services to homeless lesbian and gay youth, including assistance with the transition to permanent housing.

Professor Richard Marsico's essay, "Working for Social Change and Preserving Client Autonomy: Is There a Role for Facilitative Lawyering?," was published in the recent issue of the *Clinical Law Review*. On May 1, he was a guest speaker for a housing and community development course at CUNY Law School. On May 8, he spoke at a conference sponsored by Westchester Residential Opportunities.

A Carnegie-Mellon study of sex on the Internet prompted Professor Carlin Meyer's comments, "Reclaiming Sex from the Pomographers: Cybersexual Possibilities," published, along with a comment by Catherine MacKinnon, in the Georgetown University Law Journal. She was quoted extensively on her reaction to that study in articles appearing in Time magazine, July 3 (along with a reference to Professor Nadine Strossen's Defending Pornography), in Newsday, June 27, the St. Louis Post-Dispatch, June 28, and the Dallas Morning News, July 3. Her article, "Sex, Sin, and Women's Liberation: Against Porn-Suppression," was adopted for use this last term in Feminist Jurisprudence seminars at NYU, Fordham, Hofstra, and Columbia, and excerpts will be included in the upcoming supplement to Mary Jo Frug's casebook, Women and the Law.

Adjunct Professor Martin Minkowitz's "Practice Commentaries," *McKinney's Cons Laws of N.Y. Book 64, Workers' Compensation Law*, was cited by the Court of Appeals' *In the Matter of Bonnie B. Zechmann, etc. v. Canisteo Volunteer Fire Department, et al.*

Professor Michael Perlin received the Manfred Guttmacher Award at the American Psychiatric Association's annual meeting in Miami Beach in May for his book, *The Jurisprudence of the Insanity Defense*, chosen as the best book published last year in the area of law and forensic psychiatry. He argued against the death penalty as part of the Lexis Counsel Connect, an online exchange in discussion of the limits of hate speech. The exchange was printed in the May 1, 1995 *Legal Times*. In addition, his article, "Therapeutic Jurisprudence and the Civil Rights of Institutionalized Mentally Disabled Persons: Hopeless Oxymoron or Path to Redemption?," has been published in the inaugural issue of *Psychology*, *Public Policy, and Law*, and his article, "With Great Lawyers You Have Discussed...': References to Bob Dylan in Published Legal Cases," has been published in the Spring 1995 *On The Tracks*.

Professor Ross Sandler spoke on a panel at the Association of the Bar of the City of New York's program, "Environmental Protection: The view from Storm King Mountain," on June 13, 1995. An *Investor's Business Daily* article about the decisionmaking power of judges quoted Professor Sandler's and Professor David Schoenbrod's study of government by court order.

The *New York Law Journal* published "Successor Liability," an article by **Adjunct Professor Stuart Schlesinger** and David B. Turret, in the June 21, 1995 edition.

Professor David Schoenbrod was invited to be an Adjunct Scholar of the Cato Institute. He was quoted in an article in the May *Atlantic Monthly* entitled "Too Representative Government." Also, his book, *Power Without Responsibility*, was recently reviewed by Judge Douglas Ginsburg in *Regulation* magazine.

Recent articles by Adjunct Professor Richard Siegler have been published by the New York Law Journal, including "Directors and Officers Liability Insurance: Duty to Defend," May 3, 1995 and "Diplomatic Immunity: Minimizing the Risks," July 5.

The new book by **Professor James F. Simon**, *The Center Holds: The Power Struggle Inside the Rehnquist Court*, scheduled to be released in August, 1995, was reviewed by *Kirkus Reviews*, May 15. His paper on Justice Douglas, presented at a Warren Court conference at the University of Tulsa in Fall, 1994, will be published with other papers presented at the conference by Oxford University Press. Also, he was quoted about affirmative action in USA Today on July 20, 1995. **Professor Michael Sinclair** wrote a *New York Times* editorial entitled "Why Banks Have to Remain Impartial Lenders," printed on July 8, 1995.

"An Update on the Right-to-Die Issues" was provided by **Adjunct Professor Peter J. Strauss** in the July 3, 1995 *New York Law Journal*.

This summer, Professor Nadine Strossen gave numerous lectures on various constitutional law and civil liberties topics, including presentations at Oxford University and at an international conference on "Freedom of the Press and Mass Media in Taiwan" in Taipei, organized by Professor Lung-Chu Chen, in his capacity as the President of the North American Taiwanese Professors' Association. She appeared on TV programs to discuss current constitutional controversies, including NBC's Today Show, CBS's Sunday Morning, CNN's Crossfire (debating Ralph Reed, Executive Director of the Christian Coalition), Comedy Central's Politically Incorrect with Bill Maher, and WNYC-TV's Open Mind. Her radio interviews included an appearance on Oliver North's radio program. Professor Strossen was pictured and guoted in Esquire Magazine's June story "Women Who Love Men." Her recent book on pornography was on the New York Times Book Review's recommended summer reading list, and her recent co-authored book on hate speech was on the National Law Journals recommended summer reading list. The St. Louis Post-Dispatch profiled Professor Strossen in connection with her June 11 visit to the Center for Contemporary Arts for the Eastern Missouri affiliate's annual meeting. She spoke along with Cissy Lacks, a high school teacher who was fired for allowing students to use "some raw language" in a creative writing exercise. The May/June 1995 Harvard Magazine profiled Professor Strossen, 1972 graduate of the school, as did the Orlando Sentinel in July when she spoke at an ACLU fundraising dinner in Orlando. She wrote the editorial, "When Schools Favor Religion," that was published in the July 19 New York Times.

Professor Ruti Teitel participated on a panel at the Anti-Defamation League's program, "Reading 'Riting, 'Rithmetic...And Religion?: Debating the Role of Religion in Public Schools," on May 4 at the ADL Headquarters in New York.


