STATEMENT IN SUPPORT

1. The Equal Employment Opportunity Commission is the agency charged by Congress with the interpretation, administration and enforcement of Title VII, Civil Rights Act of

1964, 42 U.S.C. 2000e et seq., and other federal employment discrimination laws. See President's Reorganization Plan No. 1 of 1978, 43 Fed. Reg. 19807 (May 9, 1978); Executive Order No. 12067, 43 Fed. Reg. 28967 (June 30, 1978).


2. This appeal involves a significant question concerning the relationship between Title VII and the 1953 Treaty of Friendship, Commerce and Navigation between the United States and Japan, [1953] 4 U.S.T. 2063, T.I.A.S. No. 2863. Because the issue has great importance for the enforcement of federal fair employment statutes against foreign-owned businesses operating in the United States, the Commission's views should be considered.


