## NEW YORK REDISTRICTING ROUNDTABLE UPDATE

## LOCAL REDISTRICTING

#### **Nassau County Litigation Anticipated**

Based on statements made at a Nassau County Legislative hearing on February 16<sup>th</sup>, it looks like the county's county legislative map is headed to a court challenge. The hearing lasted several hours and opened with presentations by counsel for the Republican Majority and experts retained by the Democratic Minority on the county's advisory commission.

Misha Tseytlin, an attorney retained by the legislature's GOP majority, expressed the view that a proposed map developed by the majority members met all legal criteria as analyzed by the Troutman Pepper Hamilton Sanders law firm and their expert, Sean Trende.

In response, SUNY Binghamton University Professor Dr. Daniel Magleby, maintained that the proposed map was an extreme partisan gerrymander and violated a state law prohibition against a plan favoring one political party. Another Democratic expert, Megan Gall, submitted a memorandum where she argued that the plan threatened minority voting rights and did not comply with state legal standards.

Another draft map was released by the GOP majority on Friday, February 17<sup>th</sup>. A final public hearing and a vote on the final plan are scheduled for Monday, February 27<sup>th</sup>, one day before the 2023 primary petition period begins.

#### Hempstead Adopts a New Town Map

Hempstead Township in Nassau County also adopted a new town board map last week. Residents who attended a hearing before the map was approved complained that the new map failed to reflect new population demographics and did not create a second district to afford minority voters the opportunity to elect a preferred candidate of choice. A challenge to the map may be likely.

### LITIGATION

#### Clarkstown Redistricting Challenge: Borelli v. Hoehmann

On February 15<sup>th</sup> in Rockland County, Clarkstown Councilmembers Frank Borelli and Patrick Carroll along with Co-Chair of the Clarkstown Democratic Party Schenley Vital filed a challenge to the 2023 Town of Clarkstown Ward Boundary Map. They allege that the map violates state law prohibiting districts from being "drawn to discourage competition or for the purpose of favoring or disfavoring incumbents or other particular candidates or political parties" (Municipal Home Rule Law §10). They allege that Supervisor Hoehmann drew Borelli and Carroll in the same district "solely in retaliation against their vote in opposition" to repealing a section of town code that sets term limits. They also contend that (1) redistricting was not necessary as the former districts had only a 3.4% population deviation (under 5% requirement); (2) the map splits the African American community of Central Nyack into two districts; and (3) the map splits residents who attend East Ramapo Central School District into two districts.
