Annual Dinner Honors Bernard Mendik

More than 350 alumni, spouses and guests attended this year's Alumni Dinner Dance, a gala black-tie affair held at the Grand Hyatt on November 12. A strong turnout—largely the result of efforts by Dinner Committee Chairman Jerome M. Becker '60—made this year's dinner among the most successful in recent memory.

Judge Ernst H. Rosenberger '58, a trustee of the Law School and President of the Alumni Association, presented the 1987 Distinguished Alumnus Award to Bernard H. Mendik '58, a classmate of Judge Rosenberger's at New York Law School and also a member of the Board of Trustees. Mr. Mendik is president of the Mendik Company, one of New York City's most prominent real estate development firms.

In the course of his remarks, Judge Rosenberger announced that the School has acquired the adjacent building at 240 Church Street, which will be completely renovated to become the new, centralized location of the New York Law School library.

"It is no secret that Bernard Mendik has been the driving force behind this major project," Judge Rosenberger said, adding that throughout his involvement, Mr. Mendik "has been a very powerful force for development and progress at New York Law School."

Mr. Mendik began evening classes in 1955 and was Notes Editor of the Law Review. By 1958, the year of his graduation and admission to the Bar, he owned a half dozen buildings in New York. Today, the Mendik Company owns a real estate portfolio of approximately 18 million square feet, including: Two and Eleven Penn Plaza, the Sperry Hutchinson Building, the U.N. Plaza Office Building and other landmark addresses.

In addition to playing a vital role in New York's real estate renaissance, Mr. Mendik has demonstrated intense commitment to numerous civic, educational and charitable institutions. Together with his New York Law School Trusteeship, he is a Governor of the Real Estate Board of New York and is a member of the Boards of Trustees of Hobart and William Smith Colleges; the Montefiore Medical Center;

the Citizens Budget Commission of New York City; the Character and Fitness Committee for Admission to the New York Bar Association; the Fifth Avenue Association; the Jewish Guild for the Blind, where he is also a past President; the Realty Advisory Board; the Bronx High School of Science Foundation; and The City College Fund.


NYLS Celebrates Constitution's Bicentennial

The Law School began the 1987-88 academic year with a series of distinguished programs honoring the bicentennial of the U.S. Constitution. For three consecutive weeks in September, noted Constitutional scholars and historians gathered at the Law School for animated presentations on vital constitutional principles.

The inaugural program on September 14, entitled "The Constitution: That Delicate Balance," was presented by Fred W. Friendly, Edward R. Murrow Professor Emeritus of Broadcast Journalism at Columbia University. Professor Friendly's lecture outlined the themes presented in his PBS television series of the same name. He discussed the concept of "balance" both in philosophical and administrative terms—which has permitted the Constitution to adapt to changing times, remaining humankind's most ambitious experiment in self-government. Professor Friendly received an honorary degree at the Law School's commencement in June 1987.

The second program, on September 21, focused on evolving Constitutional concepts of privacy, a timely topic given the then ongoing hearings on Judge Robert Bork's nomination to the Supreme Court and the controversy over his thinking in Griswold v. Connecticut. This panel discussion was moderated by the Hon. Roger J. Miner '56, U.S. Court of Appeals, Second Circuit, and New York Law School adjunct professor. The panelists included Professor Norman Dorsen, President of the American Civil Liberties Union; John O. McGinnis, Deputy Assistant Attorney General, U.S. Department of Justice; Associate Professor Harlon L. Dalton of Yale Law School; and Professor David Chang of New York Law School.

The final program, on September 28, presented an intense and substantive analysis of evolving constitutional concepts of church and state. Panelists included former Congressman Father Robert Drinan, S.J., Georgetown University Law Center; Ms. Ruti Teitel, Assistant Director of the Anti-Defamation League; NYLS Professor George W. Dent, Jr.; and Professor John Edward Sexton, NYU School of Law. The panel was moderated by Dean Simon.

Career Fair Joins Alumni, Students

More than 50 alumni returned to the Law School in mid-November to share their knowledge and experience with students at the first New York Law School "Career Fair."

Sponsored jointly by the Career Planning and Placement Office and the Student Placement Committee, the event was intended to provide hard facts and first-hand information to students in the planning stages of their careers. "In this and other programs, our object is to set students firmly on a career path and give them the information they need to make the right preparatory choices," said Suzanne Baer, Director of the Placement Office.

A total of 75 employers spoke to several hundred students during the four-hour program. Students were able to circulate among 30 tables arrayed by area of specialization, talking one-to-one with attorneys.

Response to the Fair was extremely positive. "There was a great deal of sincere

interest by our alumni," said Baer, who attributed the success of the program to a strong cooperation between alumni and the student placement committee. "In terms of both the good feelings generated and the substantive information exchanged, this has been one of the most successful placements programs we have had in years," she said.

Wagner Committee Announces Final Round Bench for 1988

The Robert F. Wagner, Sr., National Labor Law Moot Court Competition Committee at New York Law School has announced the members of the Final Round Bench for the national competition, which will be held at the School on March 24-27, 1988. The Wagner Competition, one of the largest national moot court competitions, is named in honor of Senator Robert F. Wagner, a distinguished alumnus of New York Law School and legislative father of the National Labor Relations Act of 1935.

Presiding at the Final Round arguments

on March 27 will be the Honorable Dolores Sloviter, Judge of the United States Court of Appeals for the Third Circuit. Sitting with Judge Sloviter will be: The Honorable Marshall Babson, Member of the National Labor Relations Board; Betty Southard Murphy, former Chair and Member of the National Labor Relations Board and presently a member of the firm of Baker & Hostetler; Patricia Diaz Dennis, former Member of the National Labor Relations Board and presently a Commissioner of the Federal Communications Commission; and Robert Hunter, former

member of the National Labor Relations Board and presently a member of the firm of Proskauer Rose Goetz & Mendelssohn.

Approximately forty law schools are expected to enroll teams in the 1988 Competition, which will concern the controversy surrounding the appropriate circumstances under which the National Labor Relations Board can require an employer to recognize and bargain with a union which has failed to win a Board-supervised election.

Urban Law Society Symposium on the Homeless

On October 22 the Urban Law Society sponsored a symposium addressing the legal rights of the homeless and welfare hotel residents. Members of the panel included Mr. Harrison Goldin, Comptroller of New York City; Ms. Nancy Waxstein, special advisor on the homeless to Manhattan Borough President David Dinkins; Mr. Norman Siegal, Executive Director of the New York Civil Liberties

Union, Mr. Douglas Lasdon, Director of the Legal Action Center for the Homeless, and Mr. Mark Muscaro, Vice-President of the Staten Island Chamber of Commerce.

The members of the panel discussed the ways in which their respective organizations have attempted to meet the problem of urban homelessness. Mr. Goldin and Mr. Muscaro both spoke about alternative

programs to temporary sheltering. Mr. Siegal focused his discussion on the opposition of the New York Civil Liberties Union to Mayor Koch's ongoing "Project Help," which mandates picking up homeless persons and placing them in city psychiatric units. He urged the active participation of law students in this program, stressing the highly controversial nature of the Mayor's program.

Faculty News

On August 19 Professor Arthur Best presented a paper entitled "Written on the Screen: Talismans in Televised Ads" at a faculty seminar at Cornell Law School. Prof. Best argued that television advertisements that qualify their messages by displaying written words at the end constitute a new form of deceptive advertising if the writing is displayed so quickly that it is virtually incomprehensible. Prof. Best said that when the writing did not communicate its meaning effectively, government regulators should treat as deceptive an advertisement that would be viewed as false under existing legal standards, if it lacked the information presented in that writing. He conducted an empirical study of viewers' comprehension of the information contained in such advertisements. He concluded that the commercials he studied created false impressions for a significant percentage of viewers.

Professor Lung-chu Chen was chosen as Chairperson-elect of the Section of International Law at the 1987 annual Meeting of the Association of American Law Schools. He delivered a paper on "Aging: A New Human Rights Concern—A Policy-Oriented Perspective" at the Annual Meeting of the American Society of International Law held in Boston in April. In addition, he was a speaker at the panel on Communication Process and Policy at the Policy Sciences Summer Institute held in New Haven, Connecticut, in August 1987.

Adjunct Professor Joel C. Glanstein, a senior partner in the firm of O'Donnell & Schwartz, New York City, was elected Chair of the New York State Bar Association's 1,500-member Labor & Employment Law Section.

In early fall, Professor Edward Samuels conducted a seminar on computer copyright at the Rainbowfest convention in Princeton, New Jersey. Rainbowfest is sponsored by the Rainbow computer magazine, in which he has published two articles on computer copyright—the first on how to protect computer programs, in the April 1987 issue, and the second on what users can and cannot do with someone else's copyrighted computer program, in the July 1987 issue.




