### Nationally-Touring Art Show Opens at NYLS

In honor of Black History Month, "Black Photographers: 1840-1980" opens Feb. 1 at the NYLS Student Center art gallery. "Black Photographers," a timeline of images which stretches from America's antebellum period to

Tracing the evolution of photography, the pictures vividly portray African-American history

the dawn of the Reagan era, will remain on view through February.

The exhibition is touring nationally under the auspices of the Schomburg Center's Travelling Exhibition Program.

The roster of artists on display includes Gordon Parks, James Van Der Zee and Austin Hansen, as well as lesser known photographers. Reflecting a wide range of styles, the photographs trace the evolution of the art of photography and vividly portray African-American history. The subjects are diverse, with images of religion, politics, farming, the arts, architecture, education and social life.

"Black Photographers: 1840-1980" was created in 1989 by the Schomburg Center for Research in Black Culture and the New York Public Library to commemorate the 150th anniversary of the invention of photography. It is sponsored locally by the NYLS Office of

Student Services, and supported by Eastman Kodak Company.

### Faculty Activities

Professor Arthur Leonard participated as a panelist for the Section on Labor and Employment Law's program on "Innovations in Teaching" at the Association of American Law School's annual meeting in San Antonio on January 6. He was quoted in an article about the Supreme Court argument on the validity of Colorado's Amendment 2, published in the February 1996 issue of *Out* magazine, titled "Our Day in Court," by Elise Harris.



An article by **Professor Stephen A. Newman** entitled "At Work in the Marketplace of Ideas: Academic Freedom, the First Amendment, and *Jeffries v. Harleston*" was published in volume 22 of the *Journal of College and University Law*.



On Jan. 17. Professor Nadine Strossen addressed the faculty and gave a public lecture at Ball State University in Muncie, Indiana, about current civil liberties issues. On Jan. 22, she was interviewed long-distance for the morning program on Swedish National Broadcasting's Channel One radio network, about the U.S. death penalty, focusing on Utah's impending execution by firing squad. On Jan. 22 she gave a lecture at Barnard College, sponsored by its Center for Research on Women, on "Hate Speech Codes on Campus." Her article "How Much God in the Schools? A Discussion of Religion's Role in the Classroom," was published in the William & Mary Bill of Rights Journal (volume 4, pp 607-638, Winter 1995).

### **Moot Court Competition**




NYLS is pleased to host this year's Atlantic Regional Jessup International Moot Court Competition. The competition begins Friday, Feb. 9, when 12 teams meet for orientation. On Saturday, Feb. 10 the competition continues, with the final round scheduled for Sunday, Feb. 11 at 3:30pm in the Ernst Stiefel Reading Room. The public is invited to watch this prestigious competition, although the NYLS team -- Cristin Flynn, Marna Albanese, David Werbel, Alexander Singha and Tina Margellis, and coaches Larry Cowen and Eileen McCrohan -will not be competing due to rules imposed on the host school. (Watch for more information on the NYLS team's trip to Washington the weekend of February 16, 17 & 18 to compete in the Jessup International competition in the mid-Atlantic region.)

More congratulations are in store for Lydia Payne, David Fish and coach Alex Jeffrey, who comprised the team that won the Northeast Regional round of the National Moot Court competition this past December, defeating 14 area schools and earning the right to compete at the national level against other regional champions. On Tuesday, Feb. 23, the team advanced to the final round of the National Moot Court competition, known as the Sweet Sixteen. On Feb. 24, the team was eliminated, and members are considered Octo Finalists.
