# Today's All-day Mock Trial Decides the Guilt of John Wilkes Booth

President Abraham Lincoln was assassinated on Good Friday, April 14, 1865. Good Friday of this year, which also falls on April 14, will mark the 130-year anniversary of that event.

In honor of the historic event, the SBA, Moot Court Association, and NYLS community will stage the trial of Lincoln's alleged assassin, John Wilkes Booth, on January 30 from 10:00 am—4:00 pm in the Ernst Stiefel Room. Come sit in on this landmark trial.

Professor Rudolph J.R. Peritz was a speaker on the subject of "Teaching Antitrust: Antitrust's Special Role in the Law School Curriculum" at the Antitrust and Economic Regulation Section session of the AALS Conference in New Orleans on January 6. He was also voted Chair-elect of the AALS Contracts Section for 1995-96.

#### New York Law School Graduate and Student Summer Funding Opportunities

Presently, there are four sources of funding available to NYLS students seeking public interest internships for the Summer of 1995, in addition to those from outside sources. The NYLS funding opportunities include: Public Interest Coalition (PIC) Fellowship Program, New York Law School Public Interest Fellows, Federal Workstudy Program, and Joseph Solomon Public Service Internships. While the Solomon program is described below, information concerning the other three sources of funding will be available shortly.

Joseph Solomon Fellowship

Graduating Students: If you have secured a position with a non-profit public service organization upon graduation, you are eligible to apply for the Joseph Solomon Fellowship. The deadline for application is MAY 15, 1995, at 5:00 pm. The grant offers \$5,000/year for up to three years.

First- and Second-year Students: If you have secured a non-paying, full-time summer position with a non-profit public service organization, you are eligible to apply for the Joseph Solomon Internship Stipend. The deadline is MARCH 31, 1995, at 5:00 pm. The grant provides \$325/week for ten weeks. Pick up an application for either of these grants from Career Services. Early is better, so apply now.

Outside Sources of Funding

American Bar Association John J. Curtin, Jr.

Justice Fund: The Curtin Justice Fund Legal

Internship Program, which is managed jointly by the ABA Commission on Homelessness and Poverty and the Standing Committee on Legal Aid and Indigent Defendants, will pay a \$2000 stipend to students who spend the summer months working for a bar association or legal services program designed to prevent homelessness or assist homelessness clients or their advocates. The application deadline is MARCH 1, 1995.

New Jersey Public Interest Summer Legal Intern Program: For the sixth year, Legal Services of New Jersey (LSNJ) will sponsor a summer intern program which places first- and second-year law students in public interest legal organizations in New Jersey. The 1995 interns will be paid at a weekly rate of \$335/week, first-year students, and \$415/week, second-year students. Applications can be picked up in the Office of Career Services. The application deadline is MARCH 1, 1995.
