N.Y. CENSUS & REDISTRICTING ROUNDTABLE UPDATE

LITIGATION

To date, 15 significant cases have been filed in federal and state courts over congressional, state legislative, county, city, and town redistricting maps in New York State. Five lawsuits have been either decided or dismissed. Several cases are in various stages on appeal or pending court approval. One major case, Hoffman v. IRC, is awaiting a decision by the Appellate Division courts. This case seeks to send congressional redistricting back to the state commission and state legislature. This chart lists each case and its status. *Please contact us if you know of a case that is not listed.*
