#### SBA EXECUTIVE BOARD ELECTIONS

TO: ALL STUDENTS FROM: ILENE SACCO, SBA PRESIDENT RE: STUDENT BAR ASSOCIATION EXECUTIVE BOARD ELECTIONS

Elections for SBA Executive Board Positions will be held on Tuesday, April 12th and Wednesday, April 13th. There are seven positions on the Executive Board and they are as follows: President; Day Vice-President; Evening Vice-President; Treasurer; Secretary; Attorney General; and American Bar Association Representative. Some of the duties involved in being an Executive Board member include: representing the school to other schools; representing the student body to the Faculty and the Administration; making decisions regarding expenditures for student activities; regulating the activities of the student organizations; conducting SBA Senate meetings; and other duties as they may arise.

#### THE QUALIFICATIONS FOR OFFICE ARE AS FOLLOWS:

1. All candidates must be registered students at New York Law School.

2. All candidates must have at least a weighted "C" average computed cumulatively;

3. All candidates must have completed at least one semester and must have at *least one full year of study* remaining at the Law School prior to the date of election.

4. A candidate for President, Vice-President or Attorney General must have held a position on the Executive Board or Senate for at least one semester at any time prior to the date of the election;

5. A candidate for one of the Vice-President positions must be a member of the division that he/she would represent and must maintain this status throughout his/her term. Failure to do so shall automatically remove the person from office.
6. A candidate for the Office of Law Student Division Representative must be a paid member in good standing of the American Bar Association Law Student Division and must maintain this status throughout his/her term. Failure to do so shall automatically remove the person from office.

If anyone is interested in running for one of these positions, you must notify Sally Harding of Ilene Sacco immediately. A nominating petition must then be signed by fifty students in the school to get your name on the ballot. Copies of job descriptions are now posted on the SBA office door.

#### **CAMPAIGN RULES ARE AS FOLLOWS:**

1. Elections for Student Bar Association Executive Board positions will be held on Tuesday, April 12 and Wednesday, April 13th from 10:00 am to 3:00 pm and from 4:00 pm to 8:00 pm. These hours are subject to change in the event there are difficulties in arranging student election coverage. The final schedule will be posted on Wednesday, April 6th, on the door of the SBA office. The votes will be counted on Thursday, April 14th and the results will be posted on the elections bulletin board on Friday, April 15th. Vote tabulations will be conducted by the outgoing SBA President - Ilene Sacco, two other students not running for elected office and one administrator.

2. The voting booth must be staffed at all posted hours by at

least two members of the student body who are not running for elected office.

3. Students running for elected office may not campaign anywhere on the first floor of the B building where the election will take place.

4. Campaigning will start on Monday, April 4th.

5. Campaigning will consist of:

a. posting one poster per nominee on the official Elections Bulletin Board in the lobby of the B building. These posters should not be larger than 17" x 22". Please submit your poster to Shani Darby in the Office of Student Services.

b. speeches given at "Meet the Candidates" forum scheduled for Thursday, April 7th in the lower level of the Student Lounge from 1:00 - 2:00 pm for all candidates (except those running for Evening Vice-President), and from 5:00 - 6:00 pm for all candidates (except those running for Day Vice-President).

6. Nominees may not post fliers anywhere except as specified above.

7. All students running for positions are invited to submit a one page typed statement that will be compiled with other statements, to be distributed to the student body via their mailfolders. These statements must be submitted to the Office of Student Services no later than Wednesday, April 6th at 6:00 pm.

8. Nominees may not approach any member of the Administration

for campaign assistance, except as noted in #5a and #7 above. 9. Nominees may not address any class in a classroom, nor interrupt any class session, with election/campaign information or updates.

10. Any candidate found to be in violation of any of the election rules, or found not to meet the specific qualifications for office can and will be disqualified by a majority of the elections committee (Ilene Sacco, Clare Chapman, Tamara Smith, and Sally Harding). GOOD LUCK!
